

The budget season concluded with the adoption of 15 different

government agency budgets (14 CDDs and 1 Dependent District) which included 48 individual funds. Although these three folks were heading the charge, they were aided in their efforts by our district management team of department directors and financial coordinators who helped prepare the over \$270,000,000 in budgeted funds.

## The Villages Community Development Districts Executive Golf

As your Executive Golf Department works to complete this summer's planned course renovations, we continue to witness firsthand that Mother Nature can be difficult. We have experienced a significant amount of rainfall over the last three months during our planned projects and our short growing season. The yearly averages for Florida have almost been met in only 9 months. The contractors are developing innovative ways to complete the work around the inclement weather.



The following projects continue to progress on your Executive Golf Courses:

- The De La Vista full course renovation is in the final phase of completion. The greens have been grassed, tees enlarged and leveled, fairways shaped and repaired, and new bunker sand will be installed this week. Staff anticipates a delay in opening the course due to weather.
- Final shaping and grassing is taking place on the newly constructed Amberwood green # 5. At this time, the contractors are promoting growth of the new green complex with a vigorous fertilizer program. Staff anticipates a delay in opening the green to ensure proper growth of the sprigs to provide a sustainable playing surface.
- Hawks Bay #4, Mira Mesa #9 and Chula Vista's new practice green all are growing in well and being evaluated daily by your Executive Golf Department.

# District continues multiple golf course renovation efforts

oodbye summer, hello fall! I couldn't think of a better introduction for the first Our Place article following Labor Day.

As we all know, summer is quickly coming to an end. For our family, Labor Day weekend meant that we only have a short time to get our wonderful beach activities completed before we begin preparing for fall festivities. I personally look forward to the cooler, fall weather. It truly is one of my family's favorite times of the year. In a few short weeks, I can't help but think of the beginning of fall activities like camping, fishing, and football games.

Since we are not quite out of summer, I would like to highlight some of the current projects taking place on your District Executive Golf Courses.

For the month of September, we continue to stay on track despite the inclement weather that has produced large amounts of rain. The upgrades to De La Vista, one of our more seasoned courses, are 95% complete and include renovations to the tees, greens, fairways and bunkers.

Other renovation projects set for completion this summer include the resurfacing of the green complexes at Mira Mesa #9 and Hawks Bay #4. The newly-added Chula Vista and Mira Mesa practice green facility is growing in nicely with some minor details scheduled for completion this month.

One of our most challenging projects was the Amberwood #5 green renovations; the green area turned out beautiful and is starting the grow-in phase.

The summer is flying by quickly. We will continue to implement our plan for long



term sustainability and successful growth for the remaining summer weeks and into fall.

During the upcoming fall months we have planned to begin the overseeding program. Our greens, tees and fairways are scheduled to be completed in October and November.

Please remember the ground is much softer during this time with the added water to establish the seed. These areas on your courses are more prone to divots and ball marks as compared to the summer growing season. Bermuda grass will lay flat during the fall, turn brownish and become hard as dormancy begins to occur.

These conditions will bring an old nemesis out of the closetthe challenge we have with divots and ball marks.

As many of you know, repairing divots and ball marks has been the topic of many conversations. Since we cannot close the courses in the fall and winter, they can be very unsightly.

However, in the end, these areas will become much more plush and vigorous as a result of the overseeding.

Repairing divots, fixing ball marks, placing rakes in the bunkers and using the cart paths all create no impact to the players, but help tremendously to keep your courses in excellent condition.

When checking into play, golfers can ask for current conditions, look for signs that help direct and lead by example with your fellow golfers in etiquette. An extra set of eyes are very helpful when trying to manage all of our executive courses. We all are stakeholders so please share your observations.

If you are new to the golf experience and planning to make it one of your new lifestyle activities in your hometown, please take the opportunity to become educated about the expectations of playing this lifelong game. We provide constant updated programs that include good golf school, golf instruction, printed information and other opportunities to prepare for this game.

Residents also have access to on-going updates with the monthly turf talks that are posted on the Golf Administration web page at golfthevillages.com and on the District site at districtgov.org.

When it comes to golf and the two million rounds being played yearly on these courses, it requires everyone to do their part to keep them enjoyable for years to come.



## **Multi-Modal Path Discussion Group**

The Multi-Modal Path Discussion Group met on July 6, 2015 to review the findings of Individual Project Order 17 (IPO) with Kimley-Horn & Associates Engineer). The IPO was previously approved to review options for center island markings and side markings on the multi-modal paths. The discussion group consists of representation from Districts 1-10 and the Amenity Authority Committee (AAC).

A second meeting was held on July 20, 2015 due to additional information relative to paint materials and reflectivity, the estimated cost of the project, and resident communication received.

The Multi-Modal Path Discussion Group listened to public comment and discussed the next step relative to the project. The members unanimously supported moving forward with the center island markings on the paths; however, based on the importance of the subject, the majority of the group agreed to further discuss side striping at their August 2015 Board Meetings. Districts 1-10, the Amenity Authority Committee met in August to discuss the issue and provide information to their Board representatives who serve on the Multi-Modal Path Discussion Group.

On August 31, 2015 the Project Wide Advisory Committee (PWAC) met and addressed side striping. The majority of the committee (4-2) voted in opposition of moving forward with side-striping.

Following the August meetings, the Multi-Modal Path Discussion Group will meet on September 21, 2015 at 9:00 a.m. in the Savannah Center.

## SAVE \$\$\$ ON YOUR IRRIGATION CHARGES

Turn your irrigation timer off after rainfall events and let your lawn "tell" you when you need to turn the timer back on. If a particular zone begins to show signs of stress, only set the irrigation system to irrigate the stressed zone, don't run the entire system. Rain sensors should be checked monthly to ensure that they are not clogged with debris. Your irrigation system settings should also be checked monthly to be sure that it is operating on the proper day and time, and to verify that no "extra" start times



are accidentally turned on. To assist with the correct use of your irrigation timer as well as copies of the Owner's Manuals, visit www.districtgov.org. There are several videos

The amount of irrigation needed varies depending on the time of year, rainfall and soil conditions.

specific to your type of timer that offer easy to follow informative instructions.

It is important to remember not to irrigate just because it is your scheduled day. Irrigation systems should only be operated when the lawn begins to show signs of stress, some ex-amples are listed below:

- Lingering footprints or mower tracks
- Grass blades or leaf blades begin to close lengthwise
- The top few inches of soil feel dry
