Turnpike Travel Advisory

Florida's Turnpike in Sumter County – Nightly Closures and Detours on March 30-31 and April 4-6

 $^{\sim}$ Motorists Detoured along US 301 and CR 470 for bridge work at County Road 468 $^{\sim}$

OCOEE, FL—Motorists traveling on Florida's Turnpike in Sumter County should be alert for full roadway closures between Leesburg and Wildwood beginning March 30.

Sumter County is reconstructing and widening the County Road 468 bridge over the Turnpike. To construct the deck for the new bridge, traffic on Florida's Turnpike must be detoured to other routes throughout the County.

Southbound Turnpike traffic will be detoured at US 301 (Exit 304), 10 p.m.-6 a.m., Wednesday, March 30 and Thursday, March 31. Motorists should follow the posted detour and reenter the Turnpike southbound in Leesburg at CR 470 (Exit 296).


Northbound Turnpike traffic will be detoured at CR 470 (Exit 296), 10 p.m.-6 a.m., Monday, April 4 and Tuesday, April; 5. Motorists should follow the posted detour and reenter the Turnpike northbound in Wildwood at US 301 (Exit 304).






Spring/Summer Recreation Schedule

We are entering the Spring/Summer season (April 1st – September 30th, 2016) Check the website for new sports pool, court and lesson schedules.


The Villages Community Development Districts Executive Golf

What to bring

- Automotive fluids
- Automotive batteries
- Cleaners
- Fertilizers
- Fluorescent lamps and Mercury containing devices
- Fungicides
- Wood preservatives
- Herbicides
- Household batteries rechargeable
- Household electronics (TVs, VCRs, computers, etc.)
- . Latex & oil based paints
- · Paint removers
- Paint thinners
- Pesticides
- Pool chemicals
- Smoke detectors
- Solvents
- Propane tanks (25lbs)





What not to bring

- Biological/Infectious waste
- Explosives
- Radioactive waste
- Empty paint cans

HOW TO PACKAGE AND TRANSPORT CHEMICALS

- (1) Do NOT mix chemicals together.
- (2) Keep products in original labeled containers if possible.
- Place containers into cardboard boxes to prevent breakage.
- (4) Place leaky container in clear plastic bag and transport in box with newspaper.
- (5) Put boxes in trunk or in back of vehicle away from passengers.
