TURF TIP:

Mechanical Aeration

This is a mechanical method of removing cores of compacted soil from heavily trafficked compressed areas of your playing surfaces. This is completed at various times of the year to aid in root system development and promote good grass health. A quality top dressing material such as sand is then filled into holes for a new growth medium for roots to spread and develop. This also allows for a smoother putting surface to play from until healed.

RUMOR CONTROL!



Village Center, Sumter Landing and Brownwood Community Development Districts each have Rules in effect pertaining to parking on District owned property:

- No person may leave, stand or park any motor vehicle, golf cart or merchandise on any District owned public property, including any street, parking lot, alley, or easement, or upon any public place, including vacant land, shopping center parking lots or any other similar area for the purpose of displaying such motor vehicle, golf cart or merchandise for rent or sale without the approval of the District Manager.
- No person may leave, stand or park any motor vehicle or golf cart on any District property other than in designated parking areas without the approval of the District Manager.

If staff observes these activities taking place, a warning sign is placed on the vehicle or golf cart to notify the individual of their actions. If staff identifies habitual behavior of these activities, the District does reserve the right to trespass individuals from District Property if it is warranted.

ALERTMARION

Marion County is replacing the CodeRed program with AlertMarion. This free program is for Marion County residents and will send alerts for hazardous conditions.

After subscribing to AlertMarion, Marion County residents will be alerted to emergencies and other important community news by signing up for the Emergency Alert & Notification Program.

This system enables Marion County to provide residents with critical information quickly in a variety of situations, such as severe weather, unexpected road closures, missing persons and evacuations of buildings or neighborhoods. This information can be sent to the location specified – home, mobile, business, email addresses, text messages and more.

Office of Management and Budget

The District Boards will be approving their FY16-17 Proposed Budgets and maintenance assessments rates at their June Board meetings. Florida State Statutes require that a Proposed Budget and Proposed Maintenance Assessments be approved no later than June 15^{th} of each year. The meetings for Districts 5 – 8 have been moved to this Friday in order to meet that requirement.

After spending hours reviewing and discussing budgets during the May Budget Workshops, <u>NONE</u> <u>of the Districts will increase</u> their maintenance assessment rates in their FY16-17 Proposed Budget!

The FY16-17 Proposed Budgets and maintenance assessment rates will be approved at the June Board meetings as listed below:

It is important to note that the proposed maintenance assessment rates that are approved in June cannot increase when the final rates are adopted in September. The rates can stay at the same level as or decrease from the proposed rates.
