The following areas will be closed or have scheduled maintenance:

⇒ Coconut Cove Village Recreation Center

Coconut Cove Village Recreation Center will be closed for Quarterly Maintenance on Sunday, April 9th. All outside facilities will remain open.

⇒ Sterling Heights Tennis Courts

The Sterling Heights Tennis Courts are currently closed for maintenance.

⇒ Canal Street Billiards Room

Saddlebrook Village Recreation Center Renovation

The new windows and exterior trim are near completion. The roughin installation of the mechanical, electrical and plumbing systems above the ceiling are near completion. The drywall on the interior walls is complete and some interior finishes are being installed. The plumbing work for the new unisex restroom is complete and the HVAC system is being installed. The project is on schedule for an opening in June 2017. For your safety and the safety of all workers, please refrain from entering all construction areas.



El Santiago Storage Bins

The concrete slabs and framing for the exterior finish are complete. The exterior finish will be applied in the next few days. These storage bins will be located at the El Santiago Golf Course.



Saddlebrook IPM Building

The stem wall foundation work is complete. The grading for the concrete floor and installation of the underground utilities to the building will now begin.



What's Happening in Your District

The Villages® Community Development Districts District 5



The District Property Management Department is coordinating with Rainey Construction to mill and overlay the Villa roads in VCDD No. 5 and 6 that were not previously completed. The work began on January 16, 2017 and will continue through July 2017.

The District will deliver notices to each home that will be impacted by the work approximately 7-10 days in advance, in addition to placing informational signs at the entry and exit of each villa which will include the anticipated start and end date of the project.

The timeline may be adjusted due to unforeseen circumstances, including weather. If the timeline is adjusted, the informational signs at the villa entry and exits will be updated.

A Reminder...

The Southwest Florida Water Management District's (District) Governing Board voted to declare a Phase I Water Shortage effective March 10 for portions of Lake, Marion and Sumter counties. Due to an Interagency Agreement with the St. Johns River Water Management District, this order in Marion County would be limited to the city of Dunellon and the area encompassed by The Villages.

The District monitors regional drought indicators. Currently, groundwater levels in Lake County are extremely abnormal and levels in Marion and Sumter counties are classified as severely abnormal. In addition, short- and long-term flows of the With-lacoochee River and 12-month and 24-month rainfall levels in all three counties are severely abnormal.

Phase I water shortage order does not change allowable watering schedules from current year-round conservation measures. The primary purpose for a Phase I water shortage is to alert the public in a specified area that additional watering restrictions could be forthcoming. The order also requires local utilities to review and implement procedures for enforcing year-round water conservation measures and water shortage restrictions, including reporting enforcement activity to the District.

Due to the lack of rainfall and the Phase 1 Water Shortage issued by the Southwest Florida Water Management District for portions of Lake, Sumter and Marion

counties, District Property Management has discontinued plant replacements, with the exception of palm trees and annuals. Both palm trees and annuals are irrigated with low volume irrigation.





LAKE COUNTY IRRIGATION SCHEDULE

Residents in the Lake County portion of The Villages[®] community must comply with the restrictions of the St. John's River Water Management District. Please note that this irrigation schedule does not apply to Lake County District 11. Please refer to the irrigation schedule for Districts 1 - 11.

The following is a summary of the restrictions:

- Lawn watering depends on whether you have an odd or even numbered address, and the time of year. Please refer to the table below.
- Watering may only occur before 10 a.m. or after 4 p.m. on the scheduled days.
- Water for no more than one hour per zone.
- Certain exemptions are available, such as allowances for new plant material.
- There are no restrictions on fountains, car washing and pressure washing. However, it is important to be as efficient as possible, such as using a shut-off nozzle on the hose, so water isn't wasted.

DISTRICT 1-11 IRRIGATION SCHEDULE

Residents in the Marion, Sumter and Lake County District 11 portion of The Villages® community must comply with the SWFWMD's year-round conservation measures.

The year round conservation measures allow for twice-per-week watering, which gives residents additional flexibility for determining when to water. Residents are encouraged to water only if their lawn and landscape needs it and turn off their irrigation system if it has rained or if rain is predicted in the next 24 hours. Some of the signs that a lawn needs water include: blades folded in half lengthwise, footprints remaining on the lawn for several minutes after walking on it, and the top few inches of soil being dry.
