

With the restriction on irrigation limited to one day per week, many residents are inquiring if they should double the amount of time their irrigation is running to compensate for the decrease in water to their yards.

Your irrigation run times should not be extended due to the current water restrictions that are in place. Even without water restrictions, limiting your irrigation to only those times in which your yard is showing stress encourages a deeper root system and a healthier lawn.

Amberwood and Oakleigh Executive Golf Course Closures

The District Executive Golf Management Team is temporally closing the Amberwood and Oakleigh Executive Golf facilities, effective immediately. These courses are being closed to begin the water management implementations required for lowering certain water retention basins that have met capacity. This also enables us to move water to areas with lower levels. This movement of water from one area to another helps the District ensure the integrity of our holding capabilities throughout the various retention basins. Sumter Sanitation Holiday Schedule

Normally when a holiday falls on a regular pick up day of Monday or Tuesday, Sumter Sanitation (Contracted by CH2M) will add a "make up" day for collections on the Saturday preceding the holiday. The July 4th holiday was scheduled differently this time, with Tuesday's household trash and recycling scheduled for Wednesday. All yard waste collections were changed from Wednesday July 5th to the preceding Saturday to accommodate for the trash and recycling "make up" collection.

CH2M and the District are aware that this caused much confusion for the residents and extra care will be taken going forward when scheduling these "make up" collections. All holiday pick up schedules can be found on the District's website, www.districtgov.org under Sanitation and Recycling Information and Schedule. Holiday information will also be posted on the website's main page, posted in Welcome Wednesday information, notices posted at each postal station, published in the Village Daily Sun, and through the District's E-Notifications.

Just a Reminder

Due to the lack of rain fall, Southwest Florida Water Management District (SWFWMD), the state water management agency for our area, declared a Phase III Water Shortage effective June 5, 2017. The declaration includes all of The Villages in Marion County, Sumter County, and District 11 (Villages of Fruitland Park) in Lake County along with numerous other counties in SWFWMD.

Under the new water shortage order, lawn watering is reduced to once-per-week and allowable watering hours are reduced to before 8 am or after 6 pm. Irrigation schedule information can be found in the Fact Sheet on the following page. Microirrigation and hand watering of non-lawn areas are still allowed any day, if needed. The restrictions will remain in effect through at least August 1, 2017. Additional details regarding the watering of new lawns and plants, reclaimed water and other water uses can be found at WaterMatters.org/restrictions.

SWFWMD considerers both natural water resource conditions and the viability of public supply when deciding to declare a water shortage order. For the past 20 years, SWFWMD has worked diligently with its partners to develop alternative water supplies. Even though the region is experiencing drought conditions, there is adequate public water supply available.

The approved rate structures for the Village Center Service Area (VCSA), Little Sumter Service Area (LSSA), the North Sumter County Utility Dependent District (NSCUDD), Sumter Water Conservation Authority (SWCA), and Fenney Water Conservation Authority (FWCA) include an Environmental Protection Rate Surcharge in the event a water shortage is declared by SWFWMD. In accordance with the rate structure, a 10% surcharge will be added to water usage beginning June 5, 2017 as a result of SWFWMD's declaration of a Phase III Water Shortage. The incorporation of these rates promotes water conservation in the event of a water shortage, and they were also critical during the development and approval of the rate schedules and water use permits with SWFWMD.





FACT SHEET SWFWMD MODIFIED PHASE 3 WATER SHORTAGE ORDER

The Southwest Florida Water Management District's Governing Board issued a Modified Phase III Water Shortage Order scheduled to begin on June 5, 2017. The order restricts residential and commercial irrigation of lawns and landscaping to one-day-per-week along with other restrictions described herein.

Residential and general commercial customers in The Villages do not receive reclaimed water. Non-potable irrigation water is not exempt from the restrictions, therefore the restrictions are applicable to The Villages in:

- Sumter County, Districts 1, 2, 3, 5, 6, 7, 8, 9, 10, and 12
- Marion County, District 4
- Lake County, District 11

The following is a summary of the restrictions.

- Residential and commercial lawn and landscape irrigation may only occur before 8 a.m. or after 6 p.m. on the designated once-per-week watering schedule.
- Handwatering or microirrigation of plants (other than lawns) can be done any day at any time, if needed.
- Certain exemptions are available, such as allowances for new plant material. Refer to <u>www.watermatters.oro/restrictions</u>.
- Car washing is limited to once per week on the designated watering days as shown below.
- Commercial car washes may operate on any day.
- Fountains and other aesthetic-only water features may only operate 8 hours per day.
- Pressure washing is allowed once per year and for necessary purposes, such as prior to painting or sealing, to address a health or safety hazard, or to comply with health laws. Aesthetic concerns do not constitute a "necessary" purpose.

Ending in 4 or 5	Wednesday
Ending in 6 or 7	Thursday
Ending in 8 or 9	Friday

All commercial and residential customers must modify their irrigation timer to only irrigate once per week in accordance with the above table.

Deed restrictions and community standards enforcement must suspend any requirement to replace lawns, pressure wash, or engage in other activity which increases water use during this water shortage declaration.

Mosquito Bite Protection in Florida

Not all mosquitoes are the same. Different mosquitoes spread different diseases and bite at different times of the day. Some mosquito species bite during the day, such as those mosquitoes that can spread chikungunya, dengue and Zika viruses. Other species of mosquitoes bite most often at dawn and dusk, including those that can transmit West Nile virus.

Mosquitoes can live indoors and will bite at any time, day or night.



Use Environmental Protection Agency (EPA)-registered insect repellents

Wear repellent when you are outdoors. Use products with active ingredients that are safe and effective.

- Always follow the product label instructions.
- Do not spray repellent on skin under clothing.
- If you use sunscreen, put sunscreen on first and insect repellent second.
- It is safe for pregnant or nursing women to use EPA-approved repellants if applied according to package label instructions.





- Do not use permethrin products directly on skin.

Sumter County announces new emergency mass notification system, AlertSumter

Wildwood . FL -

Sumter County is changing the emergency mass notification system and residents need to sign up for it. AlertSumter is replacing CodeRED®

AlertSumter will offer a more robust emergency notification capability to the residents of Sumter County. AlertSumter is part of the Florida Division of Emergency Management's initiative to provide mass notification services to all Florida residents and businesses using Everbridge, Inc. as the statewide provider.

Sumter County will use AlertSumter to alert residents about a variety of events, ranging from severe weather, fires, floods and other emergencies. Messages will be sent to residents by their preferred contact paths—cell phone, text, home phone, email, fax, pager and more—to ensure real-time access to potentially lifesaving information.

Emergency Management is facilitating the transition to AlertSumter, which is now live. Residents can self-register by visiting www.SumterPrepares.com, selecting the AlertSumter button, and following the instructions. Residents can also call 352-689-4400 and register over the phone Monday through Friday, 7:30 AM to 5:00 PM.

Residents will be signed up for both systems while the transition takes place. After September 30, 2017, residents will no longer receive notifications from CodeRED®. Emergency Management will conduct a significant public outreach program for the next two months to assist residents in moving to the AlertSumter system.
