Did You Know??



Recreational Vehicle Driveway Parking

Although the District's adopted rule (Rule) prohibits recreational vehicles and trucks in excess of ¾ ton in size parking in the driveway, the External Deed Restriction Standards, which is a document adopted by the Boards to identify ambiguous terms in the Rule, allow for the following exception:

Campers, Winnebago's and other recreational vehicles are permitted on the driveway not to exceed three (3) days provided they are not inhabited. This allowance is made in an effort to accommodate the packing and unpacking of the recreational vehicle.

If the recreational vehicle remains on the driveway in excess of three (3) days, it becomes a deed compliance issue and staff would follow its process to bring the property into compliance. If you see a property that you believe may not be in compliance, please contact the Community Standards Department at 352-751-3912 or visit 984 Old Mill Run, The Villages and we will be happy to assist you with your concern.

Preventative maintenance is occurring on the potable water system field valves throughout many areas of The Villages. Those customers serviced by Village Center Service Area (VCSA), Little Sumter Service Area (LSSA) and North Sumter Utilities (NSU) that will be impacted will be notified 24 hours in advance of a temporary interruption in service and will receive the following notification:

THE PUBLIC DRINKING WATER MAINS IN YOUR AREA WILL BE SHUT DOWN TEMPORARILY FOR NEEDED MAINTENANCE.

AS A PRECAUTION, UPON RETURN OF WATER SERVICE, WE ADVISE THAT ALL WATER USED FOR **DRINKING, MAKING ICE, AND COOKING BE BOILED, FOR ALL OTHER HOUSE HOLD USES THE WATER IS ACCEPTABLE**. A ROLLING BOIL OF ONE MINUTE IS SUFFICIENT. AS AN ALTERNATIVE, BOTTLED WATER MAY BE USED.

THIS "PRECAUTIONARY BOIL WATER NOTICE" WILL REMAIN IN EFFECT UNTIL THE MAINTENANCE TASK HAS BEEN COMPLETED AND A BACTERIOLOGICAL SURVEY SHOWS THAT THE WATER IS SAFE TO DRINK. IF YOU HAVE ANY QUESTIONS, YOU MAY CONTACT DEANNA SIMMONS, FROM THE WATER DEPARTMENT AT (352) 259-2802 (NSU WWTP).

A notice with the addresses of the affected area along with this information will be left at the door of all impacted addresses. We appreciate your patience and cooperation in order to maintain the continued integrity and safety of the District Infrastructure.

Executive Golf

Summer rains have continued to remain steady through the month of July. Our present forecast, however, shows these rains will continue into the first part of the month of August.

We continue to utilize golf courses to dump water and various courses will be closed periodically for water management needs. We understand this is a minor inconvenience but implementing these closures ensure the integrity of our infrastructure.

As a gentle reminder, we are still in the middle of Hurricane season. It is extremely important to be prepared with hurricane emergency plans and understand there may be frequent weather pattern changes up until the end of November.

In August, our budgeted golf maintenance projects for the summer months continue to stay on track. Hawks Bay is 90% complete with the renovations of green and tee surfaces. Silver Lake Cart paths should be completed by months end.

The summer is flying by quickly and we continue to implement our plans for long term sustainability and successful growth throughout the summer. Thank you for your patience and understanding as you play the courses and are able to observe our progress.

TURF TIP:

Mechanical Aeration

This is a mechanical method of removing cores of compacted soil from heavily trafficked compressed areas of your playing surfaces. This is completed at various times of the year to aid in root system development and promote good grass health. A quality top dressing material such as sand is then filled into holes for a new growth medium for roots to spread and develop. This also allows for a smoother putting surface to play from until healed.

Due to the growing popularity of Resident Academy, we are excited to announce that the program is being updated and improved based on feedback received by previous participants! As part of the overall Communication Plan, the way we present and provide information through Resident Academy will improve over the upcoming months.

The first goal for Resident Academy is to eliminate the waiting list of 650+ residents. This is being accomplished by incorporating three large (100-300 participants) Resident Academy sessions. The District Customer Service Center is currently in the process of contacting each resident on the waiting list to offer attendance at one of these three sessions. If they prefer not to attend at this time, they will have the opportunity to register online for a future session at a later date.

Due to the large number of attendees, there will be some modifications to the existing program. Participants will have the opportunity to meet with the presenters at break-out tables after the presentations are complete. This will allow those who have extensive questions the opportunity to speak with each department directly and allow staff the opportunity to interact with residents to the fullest extent. The valuable handouts provided will still be included in the larger theatre style sessions.

As we continue to review and evaluate Resident Academy, the second goal will be to improve the information provided and manner in which we provide it. Rather than maintaining an extensive and growing waiting list in which residents must wait for us to contact them for a session, residents will be able to register online for the session that best fits their schedule! Registration will be available for this updated Resident Academy in mid-2019. Information on Resident Academy will also be provided to residents via our E-Notification system. By signing up for these email notifications, residents can select the information they would like to receive. Some of the topics include road closures, recreation center closures, precautionary boil water notices and more.
