Preventative maintenance is occurring on the potable water system field valves throughout many areas of The Villages. Those customers serviced by Village Center Service Area (VCSA), Little Sumter Service Area (LSSA) and North Sumter Utilities (NSU) that will be impacted will be notified 24 hours in advance of a temporary interruption in service and will receive the following notification:

THE PUBLIC DRINKING WATER MAINS IN YOUR AREA WILL BE SHUT DOWN TEMPORARILY FOR NEEDED MAINTENANCE.

*AS A PRECAUTION, UPON RETURN OF WATER SERVICE, WE ADVISE THAT ALL WATER USED FOR **DRINKING, MAKING ICE, AND COOKING BE BOILED, FOR ALL OTHER HOUSE HOLD USES THE WATER IS ACCEPTABLE.** A ROLLING BOIL OF ONE MINUTE IS SUFFICIENT. AS AN ALTERNATIVE, BOTTLED WATER MAY BE USED.*

THIS "PRECAUTIONARY BOIL WATER NOTICE" WILL REMAIN IN EFFECT UNTIL THE MAINTENANCE TASK HAS BEEN COMPLETED AND A BACTERIOLOGICAL SURVEY SHOWS THAT THE WATER IS SAFE TO DRINK. IF YOU HAVE ANY QUESTIONS, YOU MAY CONTACT DEANNA SIMMONS, FROM THE WATER DEPARTMENT AT (352) 259-2802 (NSU WWTP).

Did you know that portable flags such as this one can be displayed on your home without approval from the Architectural Review Committee (ARC)?



Flagpoles are also permitted once approved by the ARC. Approval is required to ensure that it does not encroach an easement area and does not exceed 22 feet in height.

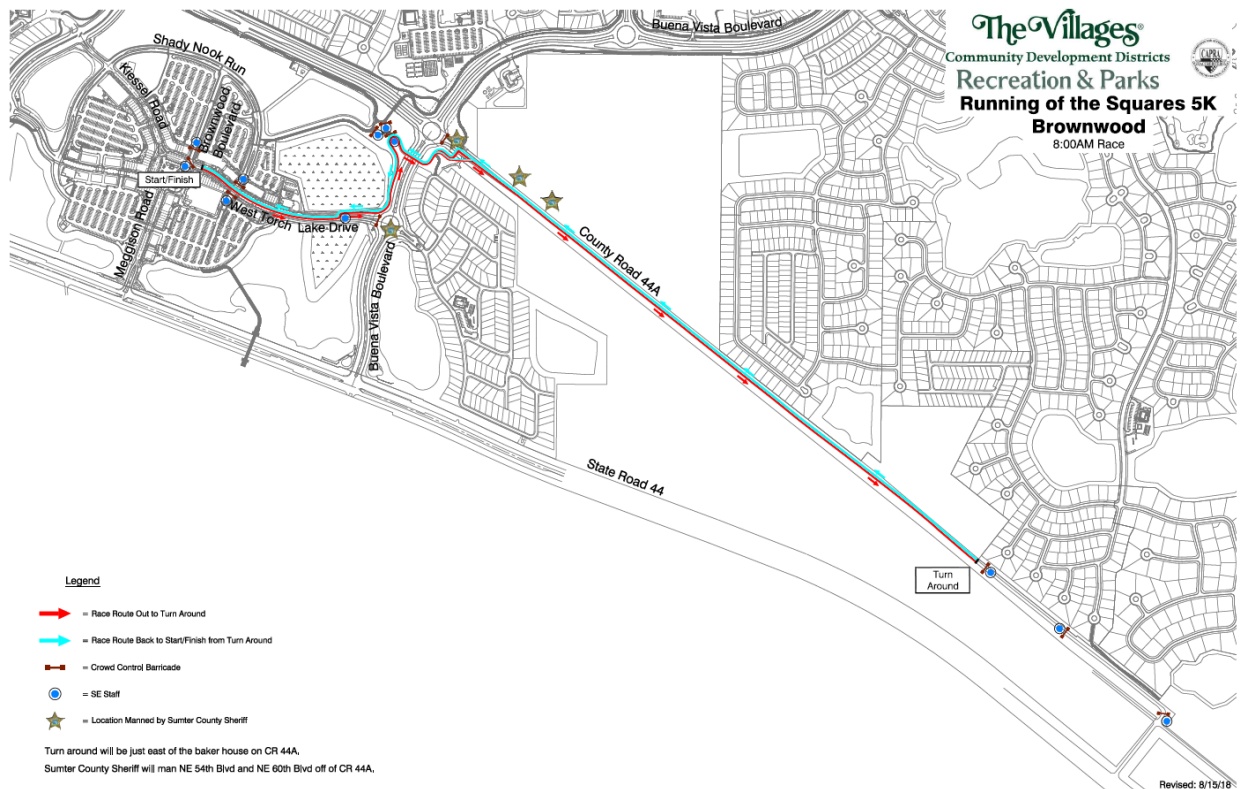


RUNNING OF THE SQUARES

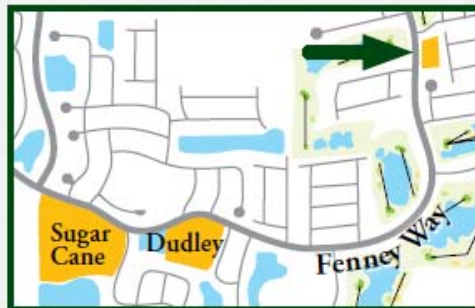

PUBLIC SAFETY DEPARTMENT

On Saturday, October 13, 2018, at the request of State of Florida Emergency Management, The Villages Public Safety Department (VPSD) deployed six firefighters along with firefighters from Sumter County Fire and EMS, Hillsborough County Fire Rescue and Flagler Beach as part of an Engine Strike Team. Their assignment is to provide back-up and post-storm resources as needed to affected areas post devastation caused by Hurricane Michael. Since arriving in the area, the firefighters have been running non-stop to various types of calls to include search and rescue, carbon monoxide alarms, structure fires, medical incidents and assisting with clearing road debris. The contingent from VPSD includes Lieutenant Adelisa Luciano, Lieutenant Christopher Gruber, Firefighter Devin Lawrence, Firefighter Jacob May, Firefighter Keith Norris, and Firefighter Eric Williamson. Personnel will be deployed for a period of seven days at which time they will return home and if necessary another team of firefighters will be sent to further assist as needed. We would like to take this opportunity to thank them for their commitment to The Villages community and the State of Florida as recovery efforts continue.

What to bring

- Automotive fluids
- Automotive batteries
- Cleaners
- Fertilizers
- Fluorescent lamps and Mercury containing devices
- Fungicides
- Wood preservatives
- Herbicides
- Rechargeable household batteries
- Household electronics (TVs, VCRs, computers, etc.)
- Latex & oil based paints
- Paint removers
- Paint thinners
- Pesticides
- Pool chemicals
- Solvents
- Smoke detectors
- Propane tanks (25lbs)



What not to bring

- Biological/Infectious waste
- Explosives
- Radioactive waste
- Empty paint cans

HOW TO PACKAGE AND TRANSPORT CHEMICALS

- (1) Do NOT mix chemicals together.
- (2) Keep products in original labeled containers if possible.
- (3) Place containers into cardboard boxes to prevent breakage.
- (4) Place leaky container in clear plastic bag and transport in box with newspaper.
- (5) Put boxes in trunk or in back of vehicle away from passengers.
