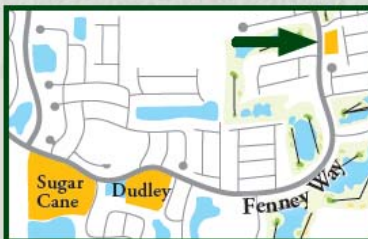
### Guest ID Card Services are available 7 days a week:

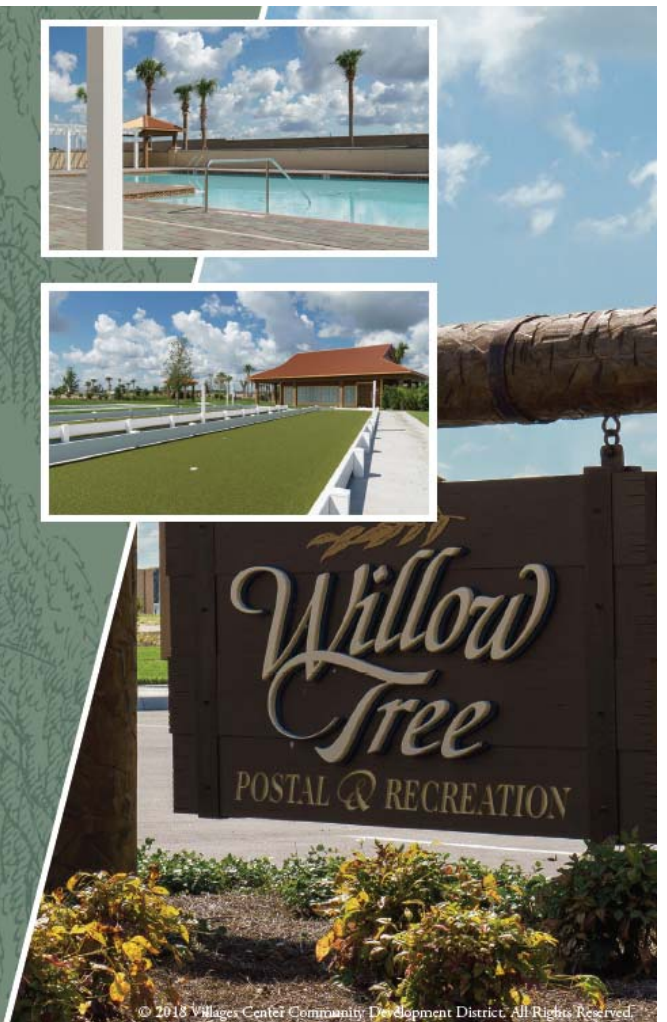

Did you know that there is a new and improved Architectural Review Application (Application) available on the website at [www.districtgov.org](http://www.districtgov.org)? In an effort to improve the overall experience for residents, contractors, the Architectural Review Committee (ARC) and staff, comments and suggestions from the ARC were reviewed and analyzed. One of the initial improvements is taking place to the Architectural Review Application. The new application is effective Wednesday, October 24, 2018 and can be found online and in the Community Standards Department located at 984 Old Mill Run in Lake Sumter Landing. The application improvements aim to assist residents, contractors and the Committee in ensuring all necessary documents are included to allow the Committee to make informed decisions when reviewing modification requests. Some of the changes you can expect include

- Additional space to identify what modifications are being requested.
- A checklist for items required for all modifications.
- A checklist for items also required for landscaping modifications.
- A checklist for items also required for building extensions/additions.

In addition to the new and improved application, a Step-by-Step Guide has been created to assist with the information required on the application. In addition to utilizing the Step-by-Step Guide, the Community Standards Department is happy to assist in filling out the application. To ensure the ARC is provided all necessary documentation, incomplete applications will not be accepted. Preventative maintenance is occurring on the potable water system field valves throughout many areas of The Villages. Those customers serviced by Village Center Service Area (VCSA), Little Sumter Service Area (LSSA) and North Sumter Utilities (NSU) that will be impacted will be notified 24 hours in advance of a temporary interruption in service and will receive the following notification:

*THIS "PRECAUTIONARY BOIL WATER NOTICE" WILL REMAIN IN EFFECT UNTIL THE MAINTENANCE TASK HAS BEEN COMPLETED AND A BACTERIOLOGICAL SURVEY SHOWS THAT THE WATER IS SAFE TO DRINK. IF YOU HAVE ANY QUESTIONS, YOU MAY CONTACT DEANNA SIMMONS, FROM THE WATER DEPARTMENT AT (352) 259-2802 (NSU WWTP).*

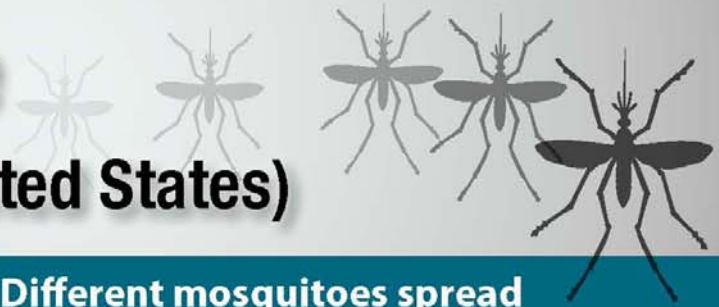

# Mosquito Bite Prevention (United States)



Not all mosquitoes are the same. Different mosquitoes spread different viruses and bite at different times of the day.

## Protect yourself and your family from mosquito bites

### Use insect repellent

Use an Environmental Protection Agency (EPA)-registered insect repellent with one of the following active ingredients. When used as directed, EPA-registered insect repellents are proven safe and effective, even for pregnant and breastfeeding women.

### Active ingredient

Higher percentages of active ingredient provide longer protection

DEET

Picaridin (known as KBR 3023 and icaridin outside the US)

IR3535

Oil of lemon eucalyptus (OLE) or para-menthane-diol (PMD)

2-undecanone

## Protect yourself and your family from mosquito bites *(continued)*



- ◆ Always follow the product label instructions.
- ◆ Reapply insect repellent every few hours, depending on which product and strength you choose.
  - » Do not spray repellent on the skin under clothing.
  - » If you are also using sunscreen, apply sunscreen first and insect repellent second.

### Natural insect repellents (repellents not registered with EPA)

- ◆ The effectiveness of non-EPA registered insect repellents, including some natural repellents, is not known.
- ◆ To protect yourself against diseases like chikungunya, dengue, and Zika, CDC and EPA recommend using an EPA-registered insect repellent.
- ◆ When used as directed, EPA-registered insect repellents are proven safe and effective. For more information: [www2.epa.gov/insect-repellents](http://www2.epa.gov/insect-repellents)

## If you have a baby or child



- ◆ Always follow instructions when applying insect repellent to children.
- ◆ Do not use insect repellent on babies younger than 2 months of age.
- ◆ Dress your child in clothing that covers arms and legs, or
- ◆ Cover crib, stroller, and baby carrier with mosquito netting.
- ◆ Do not apply insect repellent onto a child's hands, eyes, mouth, and cut or irritated skin.
  - » Adults: Spray insect repellent onto your hands and then apply to a child's face.
- ◆ Do not use products containing oil of lemon eucalyptus (OLE) or para-menthane-diol (PMD) on children under 3 years of age.

## Treat clothing and gear



- ◆ Treat items such as boots, pants, socks, and tents with permethrin or purchase permethrin-treated clothing and gear.
  - » Permethrin-treated clothing will protect you after multiple washings. See product information to find out how long the protection will last.
  - » If treating items yourself, follow the product instructions.
  - » Do not use permethrin products directly on skin.

## Mosquito-proof your home



- ◆ Use screens on windows and doors. Repair holes in screens to keep mosquitoes outside.
- ◆ Use air conditioning when available.
- ◆ Keep mosquitoes from laying eggs in and near standing water.
  - » Once a week, empty and scrub, turn over, cover, or throw out items that hold water, such as tires, buckets, planters, toys, pools, birdbaths, flowerpots, or trash containers. Check inside and outside your home.

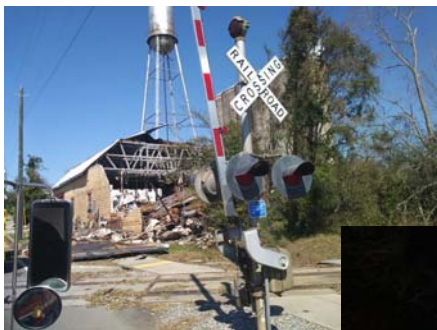

The Villages Public Safety Department (VPSD) is doing its part to help during the Hurricane Michael disaster that devastated our neighbors in the Florida panhandle. On October 14, 2018, in the early morning hours, 7 firefighters from The Villages Public Safety Department deployed as part of an engine strike team. Those deployed include VPSD Lieutenant Adelisa Luciano, Lieutenant Chris Gruber, FF/PM Keith Norris, FF/PM David Gomez, FF/PM Eric Williamson, FF/PM Devin Laurence, and FF/EMT Jacob May along with other firefighters from Sumter County, Flagler County, and Hillsborough County.

The engine strike team spent the first 4 days working in Marianna, Florida where they conducted grid searches and helped clear roads during the day and answering emergency calls for fire and EMS during the evenings. On October 18<sup>th</sup> the team was sent to Bay County/Panama City area to assist with answering emergency calls for fires and EMS. The crews are currently housed out of Bay County Fire Station 9 and have seen the full effects of the destruction caused by Hurricane Michael. The photos show some of the destruction our crews are encountering while working out there. The crews are due to return home on October 25, 2018.

### HOW TO PACKAGE AND TRANSPORT CHEMICALS

- (1) Do NOT mix chemicals together.
- (2) Keep products in original labeled containers if possible.
- (3) Place containers into cardboard boxes to prevent breakage.
- (4) Place leaky container in clear plastic bag and transport in box with newspaper.
- (5) Put boxes in trunk or in back of vehicle away from passengers.
