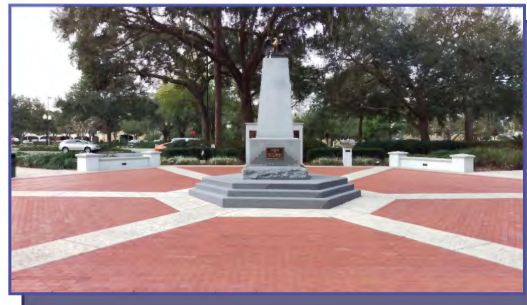

## April is Distracted Driving Awareness Month

Preventative maintenance is occurring on the potable water system field valves throughout many areas of The Villages. Those customers serviced by Village Center Service Area (VCSA), Little Sumter Service Area (LSSA) and North Sumter Utilities (NSU) that will be impacted will be notified 24 hours in advance of a temporary interruption in service and will receive the following notification:

*THE PUBLIC DRINKING WATER MAINS IN YOUR AREA WILL BE SHUT DOWN TEMPORARILY FOR NEEDED MAINTENANCE.*

*AS A PRECAUTION, UPON RETURN OF WATER SERVICE, WE ADVISE THAT ALL WATER USED FOR **DRINKING, MAKING ICE, AND COOKING BE BOILED, FOR ALL OTHER HOUSE HOLD USES THE WATER IS ACCEPTABLE.** A ROLLING BOIL OF ONE MINUTE IS SUFFICIENT. AS AN ALTERNATIVE, BOTTLED WATER MAY BE USED.*

*THIS "PRECAUTIONARY BOIL WATER NOTICE" WILL REMAIN IN EFFECT UNTIL THE MAINTENANCE TASK HAS BEEN COMPLETED AND A BACTERIOLOGICAL SURVEY SHOWS THAT THE WATER IS SAFE TO DRINK. IF YOU HAVE ANY QUESTIONS, YOU MAY CONTACT DEANNA SIMMONS, FROM THE WATER DEPARTMENT AT (352) 259-2802 (NSU WWTP).*

A notice with the addresses of the affected area along with this information will be left at the door of all impacted addresses. We appreciate your patience and cooperation in order to maintain the continued integrity and safety of the District Infrastructure.

The contractor will do everything possible to minimize your inconvenience. For the SAFETY of our crews and all residents, we ask that you reschedule any work or deliveries to your Villa until the paving is complete as they may be denied access. Only residents and emergency vehicles will have immediate access during the construction.

**PLEASE DO NOT run your irrigation, wash your vehicle or empty your pool during the week as it will make the work take longer.**

**ALL vehicles and trailers must be parked OFF of the roads and overflow parking areas as this will impede the work. If you know anyone that parks in the overflow area, please remind them to move their vehicle.**

**Please be advised that newly paved roadways will take approximately one hour to cure and should not be driven on while hot! Driving before this time could result in tracking asphalt onto your driveway and damaging the new roadway.**

**If you must travel through the construction, PLEASE drive slowly and watch for and listen to directions provided by the contract workers.**

Our goal is to give you a new road that will last a maximum life with the LEAST amount of inconvenience. Your cooperation is GREATLY APPRECIATED. Candidates are recommended to have education and/or experience in any of the following areas: architecture, ability to read site plans, residential/commercial construction, building management, deed restricted communities, landscaping, county code enforcement, etc; however, this is not required. The **alternate applicant** must be a full time resident of the Lady Lake / Lake County portion of The Villages (this area does not include Fruitland Park) and have lived in The Villages for at least one year. Candidates are recommended to have education and/or experience in any of the following areas: architecture, ability to read site plans, residential/commercial construction, building management, deed restricted communities, landscaping, county code enforcement, etc; however, this is not required. ## Did You Know??



As The Villages community continues to grow, so does the Fire Rescue Division of The Villages Community Development Districts. There are many components that are involved in providing emergency services. While increasing development and population are factors, monitoring the effectiveness of delivering service to the public is important as well.

There are established parameters that are used nationwide to standardize response times. Response times can enhance ISO (Insurance Services Office) ratings and are used in conjunction with CFAI (Commission on Fire Accreditation International).

How do we measure these standards? There are three basic components that are utilized within the industry and are referenced back to the NFPA 1710 (National Fire Protection Agency) standards.

**Call processing time:** This is calculated from the time that the 911 operator picks up the phone and asks the caller the nature of the emergency. This information, along with the location of the incident, is recorded and simultaneously transferred to the primary dispatcher. This time span constitutes the call processing time. Per NFPA standards, all calls must be processed within 30 seconds.

**Reaction Time:** This time period captures the time it takes the crew to board the vehicles and start their response. It is measured as soon as the tones and information are transmitted from the primary dispatcher at the 911 center to the responding stations. It is the policy at The Villages Fire Rescue that staff is within a reaction time of 60 seconds during the day and 90 seconds at night.

**Response Time:** This component is measured from the time the apparatus starts to move in the direction of the emergency to the time it arrives on location. For emergency medical responses, the time is seconds. For fire related incidents, the time is 240 seconds.

The Villages Fire Rescue's interaction with the community goes beyond emergency services. Residents of The Villages can enroll in classes for bystander cardiopulmonary resuscitation. Part of this course involves instruction in the purpose and use of Automatic External Defibrillators (AED). We also provide guidance and direction in establishing AED community response groups within The Villages communities. Bystander CPR, community AEDs and quick Fire Rescue response times are major factors in the 40% save rate of cardiac arrest victims in The Villages community. Another well utilized program involves residential smoke detectors. This is a free service that we provide residents in which they can schedule a same day appointment to have a Public Education Technician respond with ladders specially designed to reach high ceilings. The technician will troubleshoot any problems and provide education, as well as change the 9 volt battery in the smoke detectors (batteries must be provided by the resident).

Dear Village of Fenney Resident,

On March 28<sup>th</sup>, 2019 the City of Wildwood Utility Department will be conducting routine water main valve exercising within the area of **The Village of Fenney Units 1, 2, 3, and 4 ONLY**. **We will also be in the area of Sand Pine Villas and Spanish Moss Recreational Center**. The valve exercising will start at approximately 9:00 am and last until approximately 12:00 pm. During this time you may/may not experience short periods of time for discoloration (red/brownish) water in your homes plumbing system. If this occurs, please open multiple faucets within your home slowly to clear out the discoloration.

You should not experience extended periods of time for discoloration (15-20 Minutes) in your water. If this occurs please call 352-330-1336, Utility Customer Service Department to make a report of this incident. The City will dispatch a Service Technician to your residence in a timely manner to help resolve the issue. We apologize for any inconvenience's this may have caused you.





- Fluorescent lamps and Mercury containing devices
- Fungicides
- Wood preservatives
- Herbicides
- Rechargeable household batteries
- Household electronics (TVs, VCRs, computers, etc.)
- Latex & oil based paints
- Paint removers
- Paint thinners
- Pesticides
- Pool chemicals
- Solvents
- Smoke detectors
- Propane tanks (25lbs)



### What not to bring

- Biological/Infectious waste
- Explosives
- Radioactive waste
- Empty paint cans

### HOW TO PACKAGE AND TRANSPORT CHEMICALS

- (1) Do NOT mix chemicals together.
- (2) Keep products in original labeled containers if possible.
- (3) Place containers into cardboard boxes to prevent breakage.
- (4) Place leaky container in clear plastic bag and transport in box with newspaper.
- (5) Put boxes in trunk or in back of vehicle away from passengers.
