## **Hydrilla Treatment**

During the month of May, a number of water retention areas within The Villages community will be treated with the herbicide Topramezone (called Oasis) to control hydrilla. This herbicide is a slow acting one, but a product that will provide long term control and prevent vegetation from growing to the surface for the remainder of this year. Many of the water retention areas had little vegetation, or vegetation that was well below the surface and not readily visible. In these water retention areas, the effect of the treatment will likely go unseen, but so will the vegetation. This is how a long term management program should work on hydrilla.

For those few water retention areas that do have visible vegetation, the effect of the herbicide is slow and oftentimes it seems as if nothing was done. Once the effects begin to be seen however, it will be obvious management efforts were undertaken. The first clue that the herbicide is working will be a clear “whitening” at the very tips of vegetation. This is because this herbicide works to block the formation of plant pigments which help to protect the plant from “too much sun”. Basically, the herbicide prevents the plant from using “sunblock” and the plant gets a “sunburn”. As the plant attempts to continue growing, more and more of it will turn white and eventually a combination of starvation (no new growth means no new energy) and the combined impact of sun damage will eliminate it. This process can take weeks or even months, depending on how much vegetation is present and what the conditions are. The problem will not get worse before it gets better, but it might take a while. You should start to see symptoms within 14 to 20 days and all treatments will be monitored.

On water retention areas used for irrigation that have hydrilla, the herbicide endothall (called Aquathol K) will be utilized. This is a much faster acting herbicide. Symptoms will show within several days and it will appear as though the plant is “browning” and it will start to turn mushy. Typically within 2-3 weeks, the plant material will drop out of the water and to the bottom of the water retention areas.

The one negative of these treatments, especially in the ponds with more hydrilla, would be an increase in algae growth as the treatment progresses. This occurs because all plants and algae require nutrients in order to grow. As hydrilla begins to decrease, it uses fewer nutrients in the water, freeing that source for something like algae to use. To compound this problem, as hydrilla begins to decay it releases nutrients in the water, again something the algae can utilize. District Property Management and the contractor utilized for these treatments, Clark, are proactively planning for this possibility and will work to reduce the impacts of this growth. . Prior to treating for algae the Dissolved Oxygen (DO) level will be checked if the DO is too low the treatment will be delayed. As management efforts continue, this problem will decrease and the overall health of the water retention areas will improve.

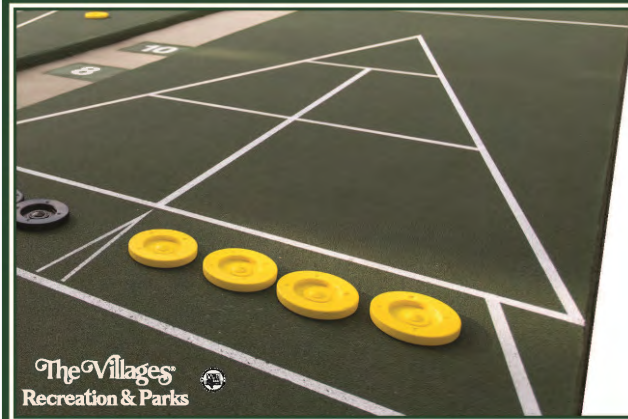

## **Information Provided by Sumter County**

At the May 3, 2019, Joint Meeting of the County, Cities, and VCCDD Staff, it was discussed that the Morse/Buena Vista from C-466 to SR 44 rehabilitation is estimated to cost \$15M each. The Buena Vista Boulevard Phase I Rehab project limits will extend from just north of Arnold Palmer Country Club to C-466 and the Morse Boulevard Phase I Rehab will extend at the Stillwater roundabout to C-466. The Notice to Proceed to DAB is pending on both projects for Phase I. Small County Road Assistance Program (SCRAP) and Small County Outreach Program (SCOP) have both been sought by Sumter County for each respective phase. A specific project schedule has not been provided by the county at this time.

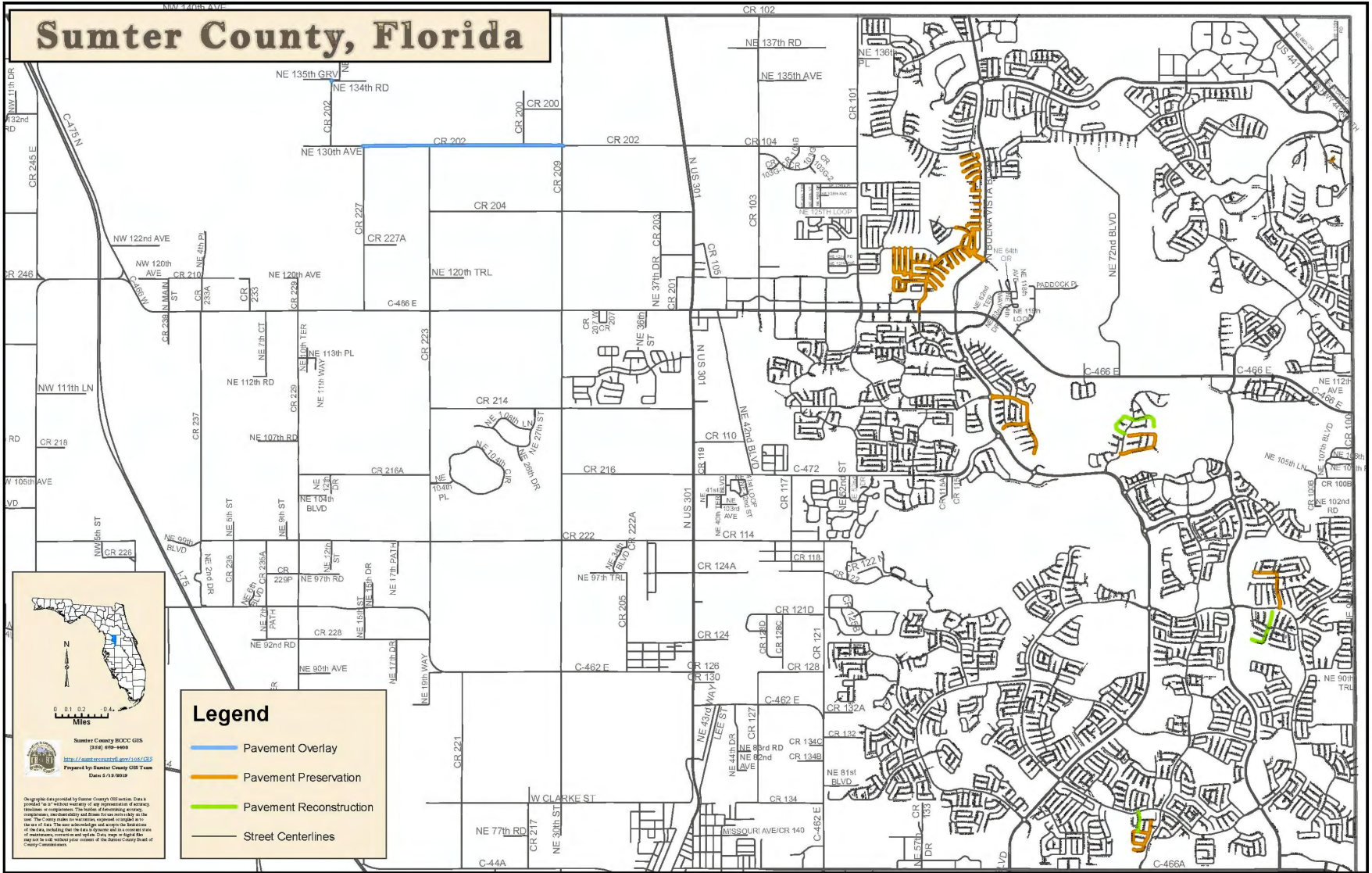

CW Roberts will be the contractor for the pavement preservation and resurfacing work for CR 202 and The Villages area. This year's program includes pavement preservation, pavement reconstruction, and one pavement overlay project. Pavement restoration locations were determined by assessing existing pavement conditions and existing traffic volumes. To increase the life of the existing pavement, Sumter County will be utilizing the latest methods of pavement preservation which include micro-surfacing and polymer modified fiber reinforced asphalt emulsions. The pavement reconstruction work includes milling 1.5 inches of asphalt off and repaving with the same amount of new asphalt. Sumter County anticipates the beginning of the construction work in mid-June and the work will be completed by the of September.

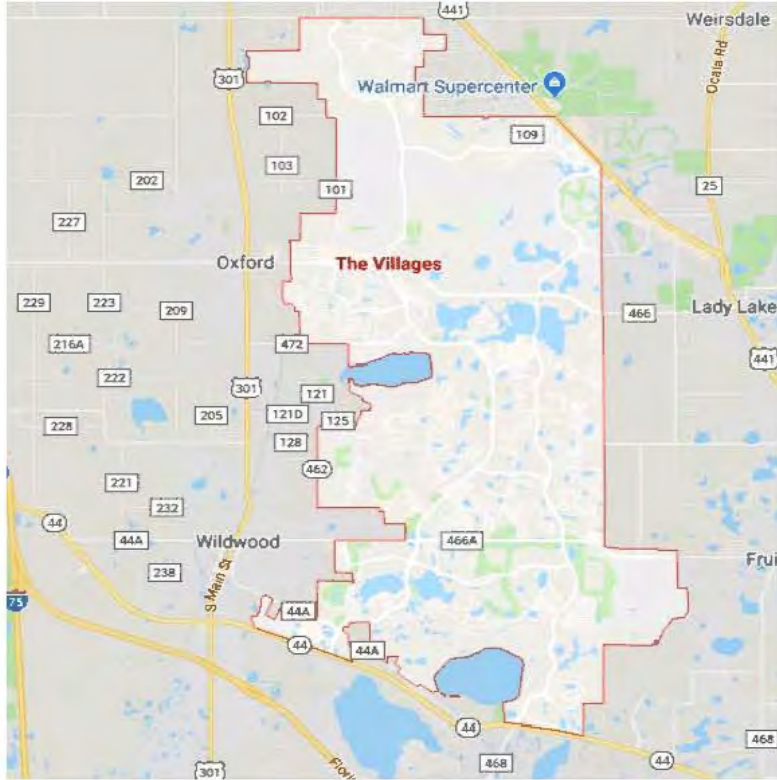
An updated schedule per road will be available after the first construction meeting to provide the targeted two weeks notification in anticipation of work including a 24 hours notice update before commencement per road. The County anticipates that partial lane closures are to be expected for a very short period. There will be construction equipment on the streets and near the residences driveways. Residents will need to travel at the posted construction speed limits during the work.

The Community Watch Patrol Division has been busy conducting training to better prepare our drivers to continue to be safe while providing the daily services to the residents of the Villages. On February 12, 2019, Forty-seven (47) patrol drivers completed a driving practical administered by the Public Safety Division EVOC training driving course. The result of this training was 100% passing successfully. The drivers also participated in a four hour classroom training as well. The training was conducted again on May 13 and 14, 2019 at the Paddock Square parking lot. Thirty-eight (38) additional drivers participated. The course is developed for emergency responder vehicles. Subject matter experts modified the training to accommodate civilian qualifications. In addition a CARFIT element was included in this second training session. Again, the results of this training were 100% passing successfully.

Preventative maintenance is occurring on the potable water system field valves throughout many areas of The Villages.
