May is the time of year Community Watch sees an increase in the number of residents taking advantage of a free service called Resident Out of Area Program. This program provides peace of mind for residents and better efficiency for first responders, saving time and lives in the event of a natural disaster. As The Villages continues to grow and summer vacations taking you away from your home for more than seven days are planned, remember this service is available. Over 195 residents have already signed up since January. The Resident Out of Area Program is different from the House Check Program in that Community Watch does not schedule any checks for your home. Community Watch only notifies the home owner in the event of a natural disaster such as a fire, tornado, thunderstorm, etc. You will be advised if your home has been damaged by utilizing the emergency contact information you have provided to contact you or another person you designate. The Resident Out of Area Program also has a benefit to emergency responders and other residents. During or after a natural disaster, time is of the essence in searching homes for injured residents. Listing your home with the Resident Out of Area Program will let us know that no one is in your home. Emergency search and rescue teams will know to skip your home; therefore, they will be able to concentrate their efforts on occupied homes. There is no fee for this service. You can sign up for this program over the phone by calling Community Watch at (352) 750-8201. Remember that this program is for emergency purposes only. If you would like your home checked on a regular basis by Community Watch, please contact us to discuss the House Check Program.

## **IMPORTANT INFORMATION FOR RESIDENTS RESIDING IN DISTRICT 12**

As part of the City of Wildwood's and the privately owned South Sumter Utility Company's (Utility) potable water system maintenance program, the Utility has contracted with Jacobs/CH2M to develop and implement a Unidirectional Flushing (UDF) Program for all areas of The Villages south of SR 44. UDF programs are commonly used across North America to improve operations, enhance the water system and improve service standards. One of the goals of this program is to help alleviate some of the discolored water issues that have been intermittently experienced. An additional goal is to help prepare the potable water system for a change in water source. During the month of July, the water source for The Villages south of SR 44 will transition to the new Water Treatment Plant (WTP) that is being constructed near the intersection of CR 468 and the Turnpike.

The UDF Program will begin during the week of May 20th and is anticipated to continue for approximately 5 to 6 weeks in order for all areas of the potable water system to be addressed. The duration for each area being flushed is anticipated to be approximately 2 to 4 days and will occur during weekdays between the hours of 7 am and 6 pm. Immediately prior to the beginning of UDF activities in each area, door hanger notices will be placed at each residence or commercial facility.

Preventative maintenance is occurring on the potable water system field valves throughout many areas of The Villages. Those customers serviced by Village Center Service Area (VCSA), Little Sumter Service Area (LSSA) and North Sumter Utilities (NSU) that will be impacted will be notified 24 hours in advance of a temporary interruption in service and will receive the following notification:

*THE PUBLIC DRINKING WATER MAINS IN YOUR AREA WILL BE SHUT DOWN TEMPORARILY FOR NEEDED MAINTENANCE.*

*THIS "PRECAUTIONARY BOIL WATER NOTICE" WILL REMAIN IN EFFECT UNTIL THE MAINTENANCE TASK HAS BEEN COMPLETED AND A BACTERIOLOGICAL SURVEY SHOWS THAT THE WATER IS SAFE TO DRINK. IF YOU HAVE ANY QUESTIONS, YOU MAY CONTACT DEANNA SIMMONS, FROM THE WATER DEPARTMENT AT (352) 259-2802 (NSU WWTP).*
