

#### What's Happening in Your District



Ciraco Underground Inc. is scheduled to begin the McLawren Drainage Project on Wednesday, June 26, 2019. The project is scheduled to be completed in 150 days.

Our contractor will do everything possible to minimize your inconvenience. For the SAFETY of our crews and the residents, we ask that you reschedule any work or deliveries while the area in front of your home is under construction, as they may be denied access. Only residents, emergency vehicles, and garbage pickup will have immediate access during the construction.

There will be intermittent road closures for the duration of the project.

Starting Tuesday, June 25, 2019 a short section of Calumet Avenue will be closed for approximately 30 days. If you do travel thru the construction area PLEASE drive slowly and watch for and listen to directions by the contract workers and follow the road detour directional signage.


#### **Multi Modal Path Signs**

The Multi Modal Path Discussion Group Guide Sign project is under construction. Starting Monday, July 1, 2019, the contractor will be onsite to commence installation of the new multi-modal trail guide signs on the new posts they previously installed. Completion of the project is expected in August 2019.



#### Remember:

To avoid conflict, do not use the right-hand lane to make a left turn through the roundabout.



#### Approaching Roundabouts

- Reduce your speed and prepare to YIELD to all traffic in the roundabout.
- Guide signs provide guidance for approach street locations, not lane use orientation.

#### Choose your lane:

Approaching a two lane roundabout, make a lane choice according to the following rules:

- If you intend to exit the roundabout more than halfway around, use the LEFT-HAND lane.
- If you intend to exit the roundabout less than halfway around, use the RIGHT-HAND lane.
- If you intend to continue straight through, use either lane unless signs or markings indicate otherwise.

#### **Navigating Roundabouts**

- Move up to the entrance line and wait for a gap in traffic. DO NOT ENTER next to a vehicle in the roundabout, as that vehicle may be exiting at the next exit.
- Within the roundabout, do not stop except to avoid a collision; you have the right-of-way over entering traffic. Keep moving in a counterclockwise direction.
- Do not change lanes in a roundabout.
- A striped channelization island is present in several roundabouts, which reduces the circulatory roadway to one lane approaching a single-lane exit.




- Follow pavement striping and arrows for guidance exit roundabouts with caution
- YIELD to emergency vehicles before or after the roundabout – DO NOT STOP in the roundabout
- Give oversized vehicles extra room because they may need both lanes to manuever
- Indicate your exit using your right-turn signal


#### **Driving Roundabouts**



#### **Turning Right**




- 1. APPROACHING: Be in the right-hand lane unless otherwise marked on the roadway, and use a right-turn signal.
- 2. CIRCULATING: Keep to the right-hand (outside) lane of the roundabout and continue to use your right-turn signal through your exit. Do not change lanes.
- 3. EXITING: Stay in the right-hand lane as you exit the roundabout.



#### **Going Straight Ahead**



- 1. APPROACHING: You can be in either lane, unless otherwise marked on roadway or posted.
- 2. CIRCULATING: Stay to the inside of the circulatory roadway if you entered from the left-hand approach lane, or stay to the outside if you entered from the right-hand approach lane. Do not change lanes.
- 3. When you have passed the last exit before the one you want, use your right-turn signal and continue to use it through your exit.
- 4. EXITING: As you exit the roundabout, be aware of vehicles traveling on the outside of the circulatory roadway that may continue to circulate around the roundabout.



#### **Turning Left or Making a U-Turn**



- 1. APPROACHING: Be in the left-hand lane unless otherwise marked on the roadway, and use a left-turn signal.
- 2. CIRCULATING: Stay in the left-hand lane of the circulatory roadway until you are ready to exit.
  - 3. When you have passed the last exit before the one you want, use your right-turn signal and continue to use it through your exit. Do not change lanes.
  - 4. EXITING: As you exit the roundabout, be aware of vehicles traveling on the outside of the circulatory roadway that may continue to circulate around the roundabout.

#### What is a Solid Waste Management Plan?

A strategic plan to ensure that the North Sumter County Dependent District (NSCUDD), Sumter Sanitation, solid waste program remains safe, effective, efficient, and environmentally sound for the future.

If you were one of the several hundred people in attendance at the NSCUDD Board Meeting last week for the "State of the Industry for Solid Waste and Recycling" presentation presented by the District and our solid waste provider JACOBS, you heard many factors directing the future of solid waste and recycling programs.

Did you know that 100 Tons of Household Waste is collected each collection day in Districts 1 through 11? Along with 55 tons of Recyclables, 125 Tons of Yard Waste, plus any bulk items collected, this amounts to about 400 Tons per week! That's a lot of trash! Another interesting fact is the recycling rate. In 2018, The Villages recycling rate was 37.1%, compared to the US recycling rate of 34.7% in 2015.

If you have been keeping up with the news you know that China has halted Recyclable Imports. So now what? That, along with many other questions are all part of developing a Solid Waste Management Plan. Some other questions may include:

- Can we sustainably recycle more waste?
- How do we remain flexible to changing markets for recyclables?
- · What alternatives are available for the disposal of solid waste?
- What changes can be made to the solid waste and recycling programs to be more cost-effective?

These questions, with many others will need to be addressed and determined while developing a Solid Waste Management Plan for The Villages. This is just the beginning! #### Don't wait...

It is human nature to put things off. We all tend to do it. But when it comes to preparing for a hurricane, you can't wait. When the weather forecasters start talking about an impending storm, water, batteries, food, and other essential items start flying off of store shelves. Make plans now. Gather the items for your disaster supply kit today! Don't wait until it's too late.

#### Have a plan!

Evacuate or stay put? Sure, every situation may be different, but have a plan set. If you are going to evacuate, know where you are heading. Remember, lots of people will be heading in the same direction. If you're going to stay, do you have a "safe room" prepared in your home? How about a shelter? In the event of a disaster such as a hurricane, The Villages Elementary School on Rolling Acres Road is a "petfriendly" shelter. Be prepared before disaster strikes.

#### **Personal Preparedness Checklist:**

- · Develop disaster and first-aid supply kits, have 7 days' worth of supplies on hand
- Store loose out-door patio items / furniture
- Prune trees or weak dead branches / wind chimes
- Place vital documents in waterproof containers
- Remove and secure valuables
- Develop a plan for handling your pets
- Register physically challenged persons with the appropriate emergency management offices

# **Too Impaired** to Work



In every industry, employees need to be healthy and focused to stay safe at work. Impairment is a major roadblock to workplace safety and the effects are more common than you think.

#### Impairment risks

The more you know about the risks of impairment and how they can arise, the better you can judge your ability to work safely.

- Missing just a few hours of sleep can hamper your driving abilities. Even if you only drive to and from work, this can be a serious risk.
- If you regularly have trouble sleeping, talk to your doctor about getting screened for sleep disorders
- Many prescription drugs, including opioids and others, can impair your ability to work and drive
- Before starting a new prescription, ask your doctor about any potential side effects and how it might impact your ability to work or drive
- Cannabis taken in any form and at any dose can have varying effects for different amounts of time. Even if cannabis is legal for recreational purposes in your state, educate yourself on its impairing effects and your employer's policies to stay safe.
- Impairment begins with the first drink. Just because you have experienced feelings of impairment from alcohol before does not mean you can overcome them or work through them.
- Emotional impairment is another serious risk. If something is causing you stress or anxiety, whether on the job or back home, it can affect your focus at work and potentially make you less safe.
- Do not take chances. Nothing not a doctor's prescription or past experience with an impairing substance – is an excuse to work unsafely.











#### Cannabis: a growing concern

As cannabis is increasingly decriminalized and legalized for recreational and medicinal use across the U.S., it raises new safety concerns in the workplace and at home.

- For all workers who drive on the job or just to and from work, there is no "safe" level of THC for driving or operating heavy machinery
- There are many unknowns associated with cannabis. Do not assume that consuming it one way is less impairing or safer than another way; there is no way to know.
- Cannabis can be consumed in a number of ways, but whether taken orally through food, drinks or pills, or inhaled through smoking or vaping, it can put you and others at risk in the workplace
- Everyone experiences the effects of cannabis differently and for different amounts of time. Factors like the food and drink you've consumed throughout the day and any medications you take can change how cannabis affects you from one day to another.
- When cannabis is used to manage pain, treat it as a medical substance, not a recreational one. Talk with your doctor about your options before considering it a solution to any health problems.

### IMPORTANT INFORMATION FOR RESIDENTS RESIDING IN DISTRICT 12

As part of the City of Wildwood's and the privately owned South Sumter Utility Company's (Utility) potable water system maintenance program, the Utility has contracted with Jacobs/CH2M to develop and implement a Unidirectional Flushing (UDF) Program for all areas of The Villages south of SR 44. UDF programs are commonly used across North America to improve operations, enhance the water system and improve service standards. One of the goals of this program is to help alleviate some of the discolored water issues that have been intermittently experienced. An additional goal is to help prepare the potable water system for a change in water source. During the month of July, the water source for The Villages south of SR 44 will transition to the new Water Treatment Plant (WTP) that is being constructed near the intersection of CR 468 and the Turnpike.

The UDF Program began during the week of May 28th and is anticipated to continue for approximately 5 to 6 weeks in order for all areas of the potable water system to be addressed. The duration for each area being flushed is anticipated to be approximately 2 to 4 days and will occur during weekdays between the hours of 7 am and 6 pm. Immediately prior to the beginning of UDF activities in each area, door hanger notices will be placed at each residence or commercial facility.
