

### **Information from Sumter County**

#### AUDIBLE PEDESTRIAN CROSSING

Sumter County installed an audible pedestrian signal to facilitate pedestrian crossings at C.R. 466 on the east side of the intersection and across Belvedere Boulevard on the south side of the intersection. The audible crossing works as follows: When the pushbutton is first pressed, it will speak a message to let you know which road you are crossing. Then it continues by playing a tone as you cross the street. As you proceed and are about halfway across the street, the pedestrian signal behind you starts to fade and then you can hear the signal in front of you pick up in volume to let you finish crossing the street. #### C.R. 466 SIGNALIZATION IMPROVEMENTS

Sumter County is proceeding with overhead traffic signal improvements on the following C.R. 466 intersections: C-101, C-103, Tatonka Terrace, Southern trace and Buena Vista Boulevard. The work is part of the County's traffic safety project for C.R. 466 and will convert the noted intersections to protected left turn only in an effort to reduce turning movement traffic accidents along the C-466 corridor. #### July 19, 2019

July 19, 2019 is an important date for any resident who would like the option of paying your bond off in full. July 19, 2019 is this year's Bond cut-off date. Every year during the budget process, we receive questions from residents regarding amenity fees, bond assessments and maintenance assessments. Below are brief explanations of each of the fees, what they pay for and how they are billed.

#### **Amenity Fees:**

Amenity Fees pay for amenity services such as Recreation Centers, Pools, Executive Golf Courses, Safety Services, Community Watch/Gates, Customer Services, Administrative Services, Property/Facilities Management along with the debt service expenses. The amenity fees are collected on a monthly basis via the utility bill. There are two amenity funds — Recreation Amenity Division (RAD) Fund which accounts for the amenity fee revenue and expenses north of CR466 and Sumter Landing Amenities Division (SLAD) Fund which accounts for the amenity fee revenue/expenses south of CR466 and north of SR44.

#### **Bond Assessments:**

Bonds are issued to pay for the infrastructure construction such as roads, tunnels, multi-modal paths, storm water systems, fences, landscaping etc. required for the development of the district. The District Bonds are paid off through bond assessments on individual lots within the specific bond phase. Bond assessments are either paid in full or billed annually on your tax bill under the non-ad valorem section. Each bond issue has a debt service fund that is included in the annual budgets for each District. Amortization schedules for each unit are located on the District's website www.districtgov.org under the Finance Department link.

#### **Maintenance Assessments:**

The elected Board of Supervisors levies maintenance assessments to provide funds for the District's operations along with the maintenance and replacement of the infrastructure acquired by the District through the bond issue(s). The infrastructure include items such as storm and gutter facilities, water retention areas, villa roads, landscaping, street lights, multi-modal paths, fences, insurance, management fees, legal fees etc. The maintenance assessment is billed annually on your tax bill under the non-ad valorem section. The maintenance assessment revenue is the major source of income for the general operating fund of each residential district and reviewed every year during the budget process. The purpose of the assessment is to provide funds to maintain the existing level of service and ensure the long-term integrity of the infrastructure and the sustainability of the District.

It's that time of year again for outside grilling and July 4<sup>th</sup> outdoor activities with family and friends. The Villages Public Safety

Department encourages you to enjoy a healthy and safe July 4<sup>th</sup> celebration without any incident or injuries. According to the National Fire Protection Administration (N.F.P.A.), 7 out of 10 adults own a smoker and (or) grill. The result can produce delicious meals in your back yard or patio; unfortunately there will be increased risk of residential fires.

In 2013-2017 fire departments responded to 10,200 home fires involving grills and hibachis. These types of grill fires accounted to 10 civilian deaths, 160 injuries and \$123 million dollars in residential property damage.

The Villages Public Safety Department is dedicated to helping you and your loved ones avoid these unnecessary grilling accidents. Follow these safety tips:

- Use propane and charcoal BBQ grills outside
- Keep all combustible items and children at least 3 feet from the area of grilling
- Never ever leave a grill unattained
- Always make sure your gas grill lid is open before ignition/lighting occurs

Fireworks can be spectacular and is much a part of our American heritage as apple pie and ice cream during our family outdoor activities during our Florida summers here at the Villages. But let's leave the "Fire Works" in the hands of licensed professionals for many reasons.

The first fact of gravity is what goes up, yes! must also come down. The large 1-1/2" through 3" shells return to the ground after they are ignited. The size of the fire work projectile shell in inches is the area of "fallout" in feet that the hot shell and embers return down in. For an example, if a 3" inch Fire Work shell is ignited into the air, it could land in a 300 feet of space on the ground. The activated fireworks shell returns to the ground still hot and burning and remains very hot once on the ground and in addition is now a hazard to start a brush or structure fire.

Did you know that sparklers burn at 1,200 degrees? That's over 4 times the temperature of your boiling water you may use for a cup of hot tea.

- More than 16,00 fires are started by Fireworks annually
- Sparklers account for approximately one-quarter of emergency room fire work injuries

#### IMPORTANT INFORMATION FOR RESIDENTS RESIDING IN DISTRICT 12

As part of the City of Wildwood's and the privately owned South Sumter Utility Company's (Utility) potable water system maintenance program, the Utility has contracted with Jacobs/CH2M to develop and implement a Unidirectional Flushing (UDF) Program for all areas of The Villages south of SR 44. UDF programs are commonly used across North America to improve operations, enhance the water system and improve service standards. One of the goals of this program is to help alleviate some of the discolored water issues that have been intermittently experienced. An additional goal is to help prepare the potable water system for a change in water source. During the month of July, the water source for The Villages south of SR 44 will transition to the new Water Treatment Plant (WTP) that is being constructed near the intersection of CR 468 and the Turnpike.

The UDF Program began during the week of May 28th and is anticipated to continue for approximately 5 to 6 weeks in order for all areas of the potable water system to be addressed. The duration for each area being flushed is anticipated to be approximately 2 to 4 days and will occur during weekdays between the hours of 7 am and 6 pm. Immediately prior to the beginning of UDF activities in each area, door hanger notices will be placed at each residence or commercial facility.
