

Construction Update



The Villages Public Safety Department Fire Station #40 located at 2455 Parr Drive:

This project is approximately 25% complete. The structural portion is finished, as is most of the underground utility work. The "rough in" of the mechanical and electrical trades for the new truck bay, sleeping quarters and fitness room are now complete. The walls are in the process of being insulated in preparation for drywall installation. Roof shingles are being installed and the exterior trim work has begun. Preparation for the new emergency generator is underway.

The underground site work is complete and the masonry portion of the building is underway.

Preventative maintenance is occurring on the potable water system field valves throughout many areas of The Villages. Those customers serviced by Village Center Service Area (VCSA), Little Sumter Service Area (LSSA) and North Sumter Utilities (NSU) that will be impacted will be notified 24 hours in advance of a temporary interruption in service and will receive the following notification:

THE PUBLIC DRINKING WATER MAINS IN YOUR AREA WILL BE SHUT DOWN TEMPORARILY FOR NEEDED MAINTENANCE.

AS A PRECAUTION, UPON RETURN OF WATER SERVICE, WE ADVISE THAT ALL WATER USED FOR **DRINKING, MAKING ICE, AND COOKING BE BOILED, FOR ALL OTHER HOUSE HOLD USES THE WATER IS ACCEPTABLE**. A ROLLING BOIL OF ONE MINUTE IS SUFFICIENT. AS AN ALTERNATIVE, BOTTLED WATER MAY BE USED.

THIS "PRECAUTIONARY BOIL WATER NOTICE" WILL REMAIN IN EFFECT UNTIL THE MAINTENANCE TASK HAS BEEN COMPLETED AND A BACTERIOLOGICAL SURVEY SHOWS THAT THE WATER IS SAFE TO DRINK. IF YOU HAVE ANY QUESTIONS, YOU MAY CONTACT DEANNA SIMMONS, FROM THE WATER DEPARTMENT AT (352) 259-2802 (NSU WWTP).

This option allows residents to save on future interest payments. If you opt not to pay off your bill, you will continue to pay in annual installments. Every year during the budget process, we receive questions from residents regarding amenity fees, bond assessments and maintenance assessments. Below are brief explanations of each of the fees, what they pay for and how they are billed.

Amenity Fees:

Amenity Fees pay for amenity services such as Recreation Centers, Pools, Executive Golf Courses, Safety Services, Community Watch/Gates, Customer Services, Administrative Services, Property/Facilities Management along with the debt service expenses. The amenity fees are collected on a monthly basis via the utility bill. There are two amenity funds – Recreation Amenity Division (RAD) Fund which accounts for the amenity fee revenue and expenses north of CR466 and Sumter Landing Amenities Division (SLAD) Fund which accounts for the amenity fee revenue/expenses south of CR466 and north of SR44.

Bond Assessments:

Bonds are issued to pay for the infrastructure construction such as roads, tunnels, multi-modal paths, storm water systems, fences, landscaping etc. required for the development of the district. The District Bonds are paid off through bond assessments on individual lots within the specific bond phase. Bond assessments are either paid in full or billed annually on your tax bill under the non-ad valorem section. Each bond issue has a debt service fund that is included in the annual budgets for each District. Amortization schedules for each unit are located on the District's website www.districtgov.org under the Finance Department link.

Maintenance Assessments:

The elected Board of Supervisors levies maintenance assessments to provide funds for the District's operations along with the maintenance and replacement of the infrastructure acquired by the District through the bond issue(s). The infrastructure include items such as storm and gutter facilities, water retention areas, villa roads, landscaping, street lights, multi-modal paths, fences, insurance, management fees, legal fees etc. The maintenance assessment is billed annually on your tax bill under the non-ad valorem section. The maintenance assessment revenue is the major source of income for the general operating fund of each residential district and reviewed every year during the budget process. The purpose of the assessment is to provide funds to maintain the existing level of service and ensure the long-term integrity of the infrastructure and the sustainability of the District.

You may review current and past budgets on the District website www.districtgov.org to view the amenity funds along with each District's operating and debt service funds. The approved FY19-20 Proposed Budgets have been added to the District website.



VCDD Utility and Amenity Envelopes

In August, the return envelopes that may be provided with your monthly VCDD Utility & Amenity statement will be white rather than colored based on your utility (If you are on automatic draft, you do not receive a return envelope). Rather than colored envelopes, you will notice that our return address has a shaded back ground for routing once we receive your payment.

Please continue to use the white envelope in exactly the same manner that you have previously used the colored envelopes. How much is enough?

Always wondered if your water bill and water consumption could be less, but not sure what it should drop to? Based on guidelines from SWFWMD and the University of Florida, a local engineering firm produced guidelines for average monthly consumption based on the type of home you have. However, with active management, your water usage and bill could be significantly less.

If you live north of C.R. 466 with a single water meter

Courtyard style	7,000 gallons
Ranch style	10,800 gallons

Lawn and Landscaping watering is limited to two days per week during the hours of 12:00 AM—10:00 AM or 4:00 PM—12:00 AM. To find the correct irrigation schedule for your residence please visit www.DistrictGov.org and click on the Water Wisdom icon on the lower right of the screen.

Know and follow your watering restrictions and don't water just because it is your day! Irrigate your lawn only when it shows signs of stress from lack of water, such as grass blades that do not spring back leaving footprints on the lawn for several minutes after walking on it. Other signs could be grass blades that appear blue-grey or the top of the soil feels dry.

Understanding basic recycling rules and tips.

RECYCLE ALL BOTTLES, CANS, PAPER, AND CARDBOARD

Item	Rule	Expert Tip
Plastic Bottles & Containers	Recycle plastics like empty bottles, jars, jugs, and tubs by their shapes. Chasing arrows don't necessarily indicate recyclability.	Caps are now recyclable, but you must put them back on empty containers before tossing in the bin.
Food & Beverage Cans	Recycle all empty tin, aluminum, and steel cans.	Empty aerosol cans can also be recycled. If the can has a plastic lid, you should remove it.
Paper	Paper, newspaper, and magazines are good to recycle.	Soiled and wet paper should be placed in the trash.
Flattened Cardboard & Paperboard What Bu	Flatten and recycle all cardboard and paperboard.	Break down and flatten cardboard boxes to make room for more materials to fit in your recycling.

NO Plastic Bags



Plastic bags are included in a few curbside programs, check with your local program.

Do not bag recyclables.
Plastic bags get tangled in equipment and threaten worker safety. Find where you can recycle them at plasticfilmrecycling.org.

NO Plastic Wraps & Film



Plastic wrap, bubble wrap, plastic sandwich bags, and freezer bags should not go in the recycle bin. Reuse whenever possible for presents, moving, or storage of similar items.

NO Flexible Packaging



Flexible packaging like chip bags and juice or soup pouches cannot be recycled in curbside programs. This type of packaging is made from multiple materials preventing it from being recycled. It must be trashed.

TRASH IT INSTEAD

ltem	Rule	Expert Tip
NO Garden Hoses, Rope, Leashes, Wire & String	Garden hose, rope, leashes, wire, and string should never go in the recycle bin.	These wrap around equipment, threaten the safety of MRF workers, and can shut down entire recycling centers! Ensure they only go in the trash.

Did You Know?

NO Dirty Diapers



Dirty diapers' and pet waste's yuck factor increase when they end up where they shouldn't—the recycle bin!

These will soil all of the recyclables, turning the load to trash. Trash these instead and keep recyclables clean.

NO Cups with Plastic or Wax Coating



Cups with plastic or waxed coatings are not recyclable.

The plastic lid should be trashed as well.

NO Polystyrene Foam & Plastic | Polystyrene foam and plastic



Polystyrene foam and plastic "to-go" containers and cups are made of unrecyclable materials, and cannot be collected curbside. Packing peanuts aren't recyclable either, however some shipping stores will take peanuts back for reuse.

NO Soiled Paper Towels



Soiled paper towels, napkins, and tissues are not recyclable.

Compost the soiled stuff, and remember to recycle the paper towel cardboard tube.

Food & Beverage Containers



Recycle empty milk cartons, juice boxes, and food cartons.

Make sure containers are completely empty to avoid contamination.

Pizza Boxes



Cardboard pizza delivery boxes without leftovers or liners should be recycled. Empty the box of all food residue and recycle.

NO Needles



Medical waste doesn't belong in curbside recycling or waste!

Needles can cause serious injuries to workers, so dispose of them in a safe container like Waste Management's MedWaste Tracker® box, or contact your local service provider.

NO Scrap Metal, Auto Parts & Tires



Metal waste (car parts, propane cylinders, lawn mowers, and microwaves) cause damage and are safety hazards if put in curbside recycling or waste bins.

Check locally for special collection options or take them to a local retailer or scrap recycler for donation or proper recycling.

NO Batteries



Batteries can destroy recyclable material and even worse – they injure workers and cause fires! Lithium-ion batteries and other batteries don't belong in curbside recycling or trash containers.

Helpful Gate Information

- In The Villages, there are 109 Gate Complexes. Of those 109, 23 are staffed, with 13 of those staffed 24/7.
- The speed limit while approaching or exiting a gate is 5 MPH.
- A majority of gates have two entrances: Visitor and Resident. Residents may use either lane as gate cards will work at either entrance. All guests, vendors, contractors, deliveries, commercial vehicles and other vehicles should use the Visitor's Lane.
- Vehicle access gates were installed to control access to the community. This reduces and slows traffic entering the community. In addition, it provides a deterrent to individuals who have no legitimate business in the community.
- Please do not tailgate other cars/golf cars through the gates only one vehicle is permitted at a time. Allow the gates to close and activate the gate with your gate card or by pressing the red button.
- The entry gates are equipped with an automatic timer to close. Please remember to get through the gate promptly once it has fully opened.
- The exit gate will automatically open when you drive your vehicle over the sensor located in the roadway. Simply approach the gate slowly, wait for the gate to open completely and proceed through promptly. Do not attempt to back up as the gate arm has already begun its downward motion as this may result in damage.
- The exit gate will begin to close once it no longer detects a vehicle by a sensor. Please make sure your vehicle clears the passage and

travels through the gate once it has fully opened. Like with the entrance gates, do not tailgate.

• In the event of a power failure, the gates are equipped with a battery backup system. The gates will automatically open when power is interrupted and automatically close when power is restored.

Station 47 and Customer Service Satellite Office Grand Opening.

Station 47 was officially opened July 9, 2019 and Engine 47 was put into service. The station will primarily serve the north end of Fenney and north of SR 44.

The station features a design to enable crews to get the apparatus quicker. Cancer prevention devices were installed including extractor, bunker gear dryer, separate bunker gear room. An exhaust extraction system was installed to remove exhaust from the apparatus bay.

Billy Schools, Commander of the Continental Veterans Association presented the first flag to be flown in front of Station 47. Thank you, Mr. Schools, for your group's generosity. We are proud to fly the flag.

The Community Emergency Response Team of The Villages (CERT) of The Villages set up the firefighter rehab station for display and first aid station for the event. C.E.R.T. of The CERT is one of a handful of CERT organizations that will respond at all hours of the day to provide cooling, drinks, and snacks to our firefighters during structure fires or extended events. CERT of The Villages has been trained to the FEMA standards to provide firefighter rehab.

Fire department staff provided tours of the new station along with answering questions about the services we provide.

Learn How to Avoid Heat-related Illnesses and Death

The human body is normally able to regulate its temperature through sweating, until it is exposed to more heat than it can handle. Heat exhaustion and heat stroke can escalate rapidly, leading to delirium, organ damage and even death.

People most at risk include:

- Infants and young children, especially if left in hot cars
- People 65 and older
- People who are ill, have chronic health conditions or are on certain medications
- People who are overweight

Heat Exhaustion

When the body loses excessive water and salt, usually due to sweating, heat exhaustion can occur. According to the free NSC First Aid Quick Reference app, signs and symptoms include:

- Sweating
- Pale, ashen or moist skin
- Muscle cramps (especially for those working or exercising outdoors in high temperatures)
- Fatigue, weakness or exhaustion
- Headache, dizziness or fainting
- Nausea or vomiting
- Rapid heart rate
- Uncontrolled heat exhaustion can evolve into heat stroke, so make sure to treat victims quickly:
- Move victims to a shaded or air-conditioned area
- Give water or other cool, nonalcoholic beverages
- Apply wet towels, or have victims take a cool shower

Heat Stroke

Seek medical help immediately if someone is suffering from heat stroke. Signs include:

- Body temperature above 103 degrees
- Skin that is flushed, dry and hot to the touch; sweating has usually stopped
- Rapid breathing
- Headache, dizziness, confusion or other signs of altered mental status
- Irrational or belligerent behavior
- Convulsions or unresponsiveness

Heat Related Illness Continued...

Immediately take action:

- Call 911
- Move the victim to a cool place
- Remove unnecessary clothing
- Immediately cool the victim, preferably by immersing up to the neck in cold water (with the help of a second rescuer)
- If immersion in cold water is not possible, place the victim in a cold shower or move to a cool area and cover as much of the body as possible with cold, wet towels
- Keep cooling until body temperature drops to 101 degrees
- Monitor the victim's breathing and be ready to give CPR if needed

DO NOT:

- Force the victim to drink liquids
- Apply rubbing alcohol to the skin
- Allow victims to take pain relievers or salt tablets

The best way to avoid a heat-related illness is to limit exposure outdoors during hot days. According to the Centers for Disease Control and Prevention:

- Air conditioning is the best way to cool off
- Drink fluids, even if you don't feel thirsty, and avoid alcohol
- Wear loose, lightweight clothing and a hat
- Replace salt lost from sweating by drinking fruit juice or sports drinks
- Avoid spending time outdoors during the hottest part of the day, from 11 a.m. to 3 p.m.
- Wear sunscreen; sunburn affects the body's ability to cool itself
- Pace yourself when you run or otherwise exert your body

In your community, please check in on neighbors who are elderly, house-bound or otherwise may be reluctant to ask for help. You can offer to host them in the air-conditioned comfort of your living room on hot days, drive them to a local cooling center, or call relatives or city services to arrange for them to stay cool.
