- Dogs must wear current license tags and have up to date vaccinations.

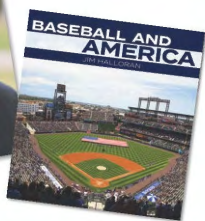

First Responders Recreation Center

At the July 24, 2019 First Responders Recreation Center Workshop hosted by the Amenity Authority Committee, staff provided a conceptual site plan based on resident input, property configuration, programming and operational expectations for this capital improvement project. A significant amount of time was expended on reviewing the facility and grounds to develop this plan with a focus on adjacent uses of indoor and outdoor layouts. Currently, staff has begun to receive inquiries concerning memorabilia donations to the First Responders Recreation Center and will be developing a formal communication plan with an application process.

This conceptual plan is posted online and accessible via a Quick Link titled “First Responders Recreation Center” at www.DistrictGov.org. In addition to the link providing information and updates, residents will have an opportunity to provide input on this project from Wednesday July 24, 2019 - Friday August 23, 2019 via email at RecreationDepartment@districtgov.org.

Staff will work with our design and planning team to review suggestions from August 26 – September 6, 2019. A public meeting will be held with staff for residents to review the conceptual site plan and additional information from 2:00 p.m. to 5:00 p.m. on September 24, 2019 at the Savannah Regional Recreation Center, Ashley-Wilkes Room. All resident suggestions will be reviewed along with other factors (costs, space, programming, etc.) that will be taken into consideration to achieve the best use of location.



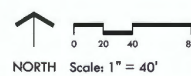
First Responders Recreation Center

Did you know???

Paving schedule along Buena Vista Boulevard and Morse – Information provided by Sumter County

A Sumter County Public Works resurfacing project for Buena Vista Boulevard began on Sunday, July 21, 2019. A resurfacing project for Morse Boulevard is scheduled to begin on Sunday, August 4, 2019. The work is expected to be completed overnight with intermittent lane closures. Each project will take approximately 90 days.

The Buena Vista Boulevard resurfacing will be done on 1.25 miles of the road from 300 feet south of Lake Miona Drive to County Road 466A, including roundabouts. The Morse Boulevard project will cover a distance of about 0.8 miles from County Road 466 to about 1,000 feet south of Stillwater Trail, including roundabouts and the Morse Boulevard Bridge.

Sumter County commissioners this past April approved contracts with D.A.B. Constructors, the lowest bidder on both projects, to complete the work. Three companies bid on the Buena Vista project and four on the Morse project.

D.A.B.'s bids were \$1.05 million for Buena Vista Boulevard and \$848,889 for Morse Boulevard.

Both projects, which involve milling, paving, base reconditioning and pavement markings, are expected to take 105 days.

District 4 Stormwater Update

Ciraco Underground Inc. is progressing in the construction of the new drainage system within Unit 56 of the Villages of Marion. The contractor has completed 40% of the pipe installation to date. The pipe installation crews are currently on Marchmont Place preparing to begin installation on Locustwood Court by the end of this week. The recent heavy rains have impacted the work to properly prepare the roadway subgrade for the roadway restoration along Calumet Avenue and the entry to McLawren Terrace. For this reason, the temporary road closure will need to be extended for at least another two weeks to facilitate the restoration work. The overall project is scheduled to be fully completed by November 2019.

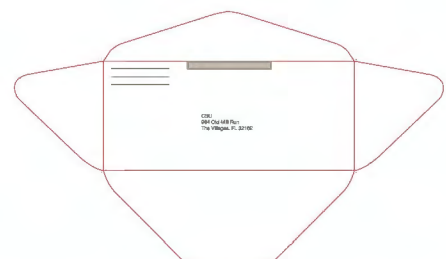

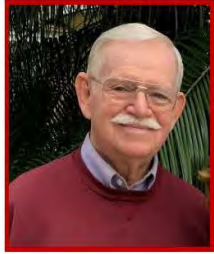

Did You Know?

July Is National UV Safety Month

Simply staying in the shade is one of the best ways to limit your UV exposure. However, if you are going to be in the sun, “Slip! Slop! Slap! and Wrap” is a catchphrase that can help you remember some of the key steps you can take to protect yourself from UV rays:

- Slip on a shirt.
- Slop on sunscreen.
- Slap on a hat.
- Wrap on sunglasses to protect the eyes and skin around them.



SLIP: Protect your skin with clothing

Clothes provide different levels of UV protection. Long-sleeved shirts, long pants, or long skirts provide the most protection. Dark colors generally provide more protection than light colors. Dry fabric is generally more protective than wet fabric. Be aware that if you can see light through a fabric, UV rays can get through, too. Many companies make clothing that’s lightweight, comfortable, and protects against UV exposure even when wet. It tends to be more tightly woven, and may have special coatings to help absorb UV rays. Such clothing may have a label listing the UV protection factor (UPF) value (on a scale from 15 to 50+). The higher the UPF, the higher the protection from UV rays.

SLOP: Use sunscreen

Even with proper sunscreen use, some UV rays still get through.

Sunscreens with broad spectrum protection (against both UVA and UVB rays) and with sun protection factor (SPF) values of 30 or higher are recommended. **Read the labels!**

Sun protection factor (SPF): The SPF number is the level of protection the sunscreen provides against UVB rays, which are the main cause of sunburn. A higher SPF number means more UVB protection (although it says nothing about UVA protection). For example, when applying an SPF 30 sunscreen correctly, you get the equivalent of 1 minute of UVB rays for each 30 minutes you spend in the sun. (1 hour in the sun wearing SPF 30 sunscreen is the same as spending 2 minutes totally unprotected.). A higher SPF number does mean more protection, however, **no sunscreen will protect you completely from UV rays.**

Did You Know?

Broad spectrum sunscreen: Sunscreen products can only be labeled “broad spectrum” if they have been tested and shown to protect against both UVA and UVB rays.

Water resistant sunscreen: Sunscreens are no longer allowed to be labeled as “waterproof” or “sweatproof”. Sunscreens can claim to be “water resistant,” but they have to state whether they protect the skin for 40 or 80 minutes of swimming or sweating, based on testing.

Expiration dates: Most sunscreen products are good for at least 2 to 3 years, but you may need to shake the bottle to remix the sunscreen ingredients. If sunscreens are exposed to heat for long periods of time they may be less effective.

APPLY SUNSCREEN PROPERLY: Ideally, about 1 ounce of sunscreen (about a shot glass or generous palm full) should be used to cover the arms, legs, neck, and face of the average adult. If you’re going to wear insect repellent or makeup, put the sunscreen on first.

- Sunscreen needs to be reapplied at least every 2 hours to maintain protection.
- Sunscreens can wash off when you sweat or swim and then wipe off with a towel, so you would need to apply more often under those conditions.
- And don’t forget your lips!! Lip balm with sunscreen is recommended.

**Some sunscreen products can irritate the skin and it is recommend that you apply a small amount to the soft skin on the inside of your elbow each day for 3 days. If your skin does not turn red or become itchy, the product is probably OK for you.

SLAP: Wear a hat

A hat with a 2- to 3-inch brim all around will protect areas that are often exposed to intense sun, such as the ears, eyes, forehead, nose, and scalp. A shade cap (which looks like a baseball cap with about 7 inches of fabric draping down the sides and back) will provide more protection for the neck. (You can make one by wearing a large handkerchief or bandana under a baseball cap.)

A baseball cap protects the front and top of the head but not the neck or the ears, where skin cancers commonly develop.

Did You Know?

WRAP: Wear sunglasses that block UV rays

Research has shown that hours in the sun without UV-blocking sunglasses to protect your eyes and the skin around them will increase your chances of developing certain eye diseases.

The ideal sunglasses should block 99% to 100% of UVA and UVB rays. Labels that say “UV absorption up to 400 nm” or “Meets ANSI UV Requirements” mean the glasses block at least 99% of UV rays. Those labeled “cosmetic” block about 70% of UV rays. (If there is no label, don’t assume the sunglasses provide any UV protection--Look for an ANSI label.)

Large-framed and wraparound sunglasses are more likely to protect your eyes from light coming in around the edges. Children need smaller versions of real, protective adult sunglasses – not toy sunglasses.

Some contact lenses are now made to block most UV rays. But because they don’t cover the whole eye and surrounding areas, they are not sufficient eye protection when used alone.

IMPORTANT INFORMATION FOR RESIDENTS RESIDING IN DISTRICT 12

As part of the City of Wildwood's and the privately owned South Sumter Utility Company's (Utility) potable water system maintenance program, the Utility has contracted with Jacobs/CH2M to develop and implement a Unidirectional Flushing (UDF) Program for all areas of The Villages south of SR 44. UDF programs are commonly used across North America to improve operations, enhance the water system and improve service standards. One of the goals of this program is to help alleviate some of the discolored water issues that have been intermittently experienced. An additional goal is to help prepare the potable water system for a change in water source. During the month of July, the water source for The Villages south of SR 44 will transition to the new Water Treatment Plant (WTP) that is being constructed near the intersection of CR 468 and the Turnpike.

The UDF Program began during the week of May 28th and is anticipated to continue for approximately 5 to 6 weeks in order for all areas of the potable water system to be addressed. The duration for each area being flushed is anticipated to be approximately 2 to 4 days and will occur during weekdays between the hours of 7 am and 6 pm. Immediately prior to the beginning of UDF activities in each area, door hanger notices will be placed at each residence or commercial facility.
