- ⇒ External Deed Restriction Standards **prohibit** household waste or recycling to be placed at the end of your driveway before 5:00 pm on the day preceding your scheduled collection.
- ⇒ Bags must be placed for collection before 6:00 am on the day of your scheduled collection.
- ⇒ Household waste should be placed in sealed white or black standard 20-30 gallon trash bags, and must not weigh over 40 pounds.
- ⇒ Recyclables must be placed in a clear plastic bag and not weigh over 40 pounds.
- ⇒ Tree limbs or branches may not exceed four feet in length or exceed 40 pounds, and need to be bundled and tied and placed at the end of your driveway.
- ⇒ Lawn clippings and similar yard waste should be placed in biodegradable bags.

If you reside South of SR 44 all of your waste, household and recyclables, co-mingled together, are transported to the Covanta Energy from Waste Plant. Household waste is turned into electricity, which powers homes locally.

Please join us for the third interactive Solid Waste Workshop presented by the North Sumter County Utility Dependent District (NSCUDD) and Jacobs, formerly CH2M, the waste hauler for Districts 1 – 11 on Wednesday, October 23, 2019 at The Savannah Center from 9:00 to 12:00!

The first workshop provided information on the District's current Solid Waste and Recycling Program, and the need to develop a Solid Waste Management Plan, as well as the state of the industry and the impacts this has on our current program. China and other Asian countries have placed policies and restrictions on the import of recyclables and which is impacting recycling throughout the world.

The second workshop recapped what we learned in the first along with additional information on the methods of solid waste disposal, as well as the rising costs. With the use of electronic survey clickers a series of questions were asked of the attendees and the results stated that the majority feels there is no need to change the solid waste collection process and are very satisfied with the service that is provided. The participants also indicated a willingness to pay slightly more per month to maintain the current solid waste and recycling program.

During the third workshop, alternative waste management options, options for waste disposal, and the associated costs will be presented followed by asking for additional input from the attendees. The District and Jacobs appreciate the participation and suggestions we have received so far and look forward to meeting with you again in October. ## Did You Know??



On Thursday, September 19<sup>th</sup>, the North Sumter County Utility Dependent District (NSCUDD) took the first step in purchasing Central Sumter Utility Company, LLC (CSU). The agreement for purchase and sale was approved and now initiates the due diligence period for NSCUDD to perform or to have performed one of many items. Those items include, but not limited to, a valuation of CSU performed by a third party consultant and a facility assessment review. The seller will also have a valuation completed by a third party consultant. Once complete the two valuations will be compared as outlined in the agreement to determine a sale price.

If the sales transaction is completed, NSCUDD would be the water and waste water provider in Districts 9, 10 and 11 to complement North Sumter Utility (NSU) that serves Districts 5, 6, 7 & 8. The resident will see no impact to their service as a result of the potential sale.

## Did You Know?



If you have visited the new District Customer Service Satellite office at The Villages Public Safety Department Station 47 south of Hwy 44, you may have noticed two buildings under construction behind the station. One building is for the utility company and the other building will be a satellite for District Property Management (DPM). The office will have 7 or 8 current staff, one assistant manager, two facility supervisors that are responsible recreation centers south of Cr 466 A, two infrastructure supervisors responsible for Districts 9, 10, 11 and 12 infrastructure and two landscape supervisors. This new location will save at least one hour a day in travel time for each team member that currently works out of the Lake Sumter Landing office. Later in 2020, Community Watch will occupy the same building resulting in additional savings. For construction progress, stay tuned to the District Weekly Bulletin!

### **Gate Card Services**

When replacing gate cards, please bring all remaining gate cards as they are issued in sets of two. Lost or stolen gate cards will be replaced at a \$15.00 charge per card. 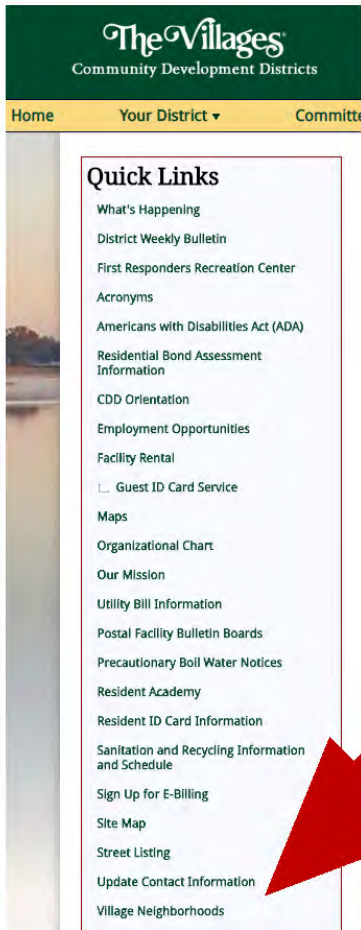

## Did You Know??



Tuesday October 1, 2019 marks the official date Customer Service is solely responsible for registering residents for Community Watch's three resident programs. Residents interested in signing up for Community Watch's Adult Watch, House Check and Resident Out of Area programs will be able to do so at either Customer Service location – 984 Old Mill Run in Lake Sumter Landing and their Satellite Office at 4856 South Morse Blvd. This makes it possible for a resident to handle all of their needs in one location.

The **Adult Watch Program** is a service provided for residents that live alone or residents with a partner who need someone to give them a call to make sure they are in good standing. Currently the Community Watch staff calls approximately 100 residents daily. If any resident does not answer, Community Watch goes into action, sending a patrol driver to knock on the door, calling local hospitals, key holders and if all else fails law enforcement. It is a very effective program. There is no charge for this program.

**Houses Checks** is a service provided for any residents that are going to be leaving the area for more than seven days. Community Watch will check the perimeter of the house checking windows, doors, any packages left at the home. We will not enter the home, and it is recommended to have a local key holder. At this time the charge is \$5.35 per week.

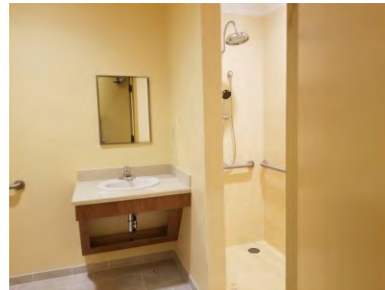
**Resident out of Area** is a service provided to any residents that are going to be leaving the area for more than seven days. In the event of a natural disaster, Community Watch will notify the homeowner if any damage is noticed. This also allows emergency personnel to concentrate evacuation efforts on occupied homes. There is no charge for this program.

On Friday, September 20, 2019, The Villages Public Safety Department B-Shift technical rescue team members trained on the Arizona Vortex tripod which is used in confined space rescues and over the edge high angle rescues.

Technical Rescue Team members train monthly on the different disciplines. The team is highly trained and is capable of vehicle & machinery rescues, confined space rescues, trench collapse rescues, high/low angle rope rescues and structural collapse rescues.

The Villages Technical Rescue team recently went through an evaluation process by the State of Florida to become a Type 1 Technical Rescue Team. We are awaiting the results of this evaluation.

## Week 3: Youth Preparedness

### 9 Priority Steps for Creating a Nation of Prepared Youth

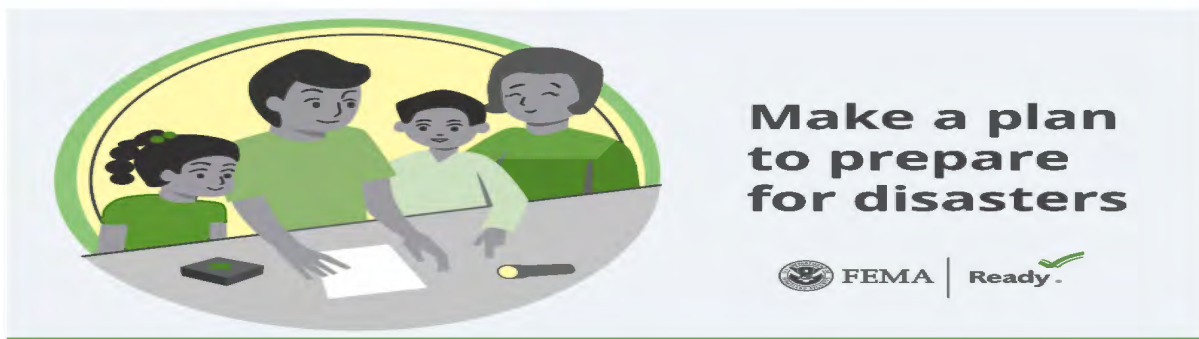
