#### I lost my Villages ID. How do I get a new one?

Please come to one of the District Customer Service Centers located at 984 Old Mill Run in Lake Sumter Landing or 4856 South Morse Boulevard just south of SR 44. There are two options to replace your ID. You can receive a free temporary 30 Day ID which will give you an opportunity to find your original ID. If you prefer not to get a temporary card, we can replace your ID with a new permanent card. Lost, stolen, or damaged Villages Resident ID cards will be replaced for a \$15.00 charge. A new resident ID number will be issued and a new photo will be taken each time a new ID is issued.

#### How do I replace my gate cards?

Please come to one of the District Customer Service Centers located at 984 Old Mill Run in Lake Sumter Landing or 4856 South Morse Boulevard just south of SR 44. Bring any remaining gate cards you still have issued to your home as they are issued in sets of two. We will deactivate the missing card(s). If the missing card is part of a set, the set will be deactivated. We will issue you a new single card or a set of cards. It will cost \$15.00 to replace the missing card.



# Gates and Gate Arms- Why do we have them and can we have additional lights/markings on the gate arms?

In The Villages, we have 109 Gate Complexes. Of those 109 gates, 23 are staffed. Of the 23 staffed, 13 are staffed 24/7.

A majority of our gates have two entrances: Visitor and Resident. Our residents may use either lane; their gate cards will work at either entrance. All guests, vendors, contractors, deliveries, commercial vehicles and other vehicles must use the Visitor's Lane.

The vehicle access gates were installed to control (not restrict) access to the community, thus reducing traffic. Gate arms were implemented to slow traffic as it enters the community and the gate arms fall under the ownership and maintenance of government jurisdictions for use on their roads. Below is the reference from the US Department of Transportation Federal Highway Administration - MUTCD:

MUTCD – Manual on Uniform Traffic Control Devices (2009 Edition):

Section 2B.68 Gates


Standard:

05. Except as provided in Paragraph 6, gate arms, if used, shall be fully retro-reflectorized on both sides, have vertical stripes alternately red and white at 16-inch intervals measured horizontally as shown in Figure 8C-1.

Option:

06. If used on a one-way roadway or ramp, the retro-reflectorization may be omitted on the side of the gate facing away from approaching traffic.

Drivers are more likely to stop at a gate arm with proper striping and are less likely to exceed the reduced speed area at the gate entrance when a gate arm is used. Multi-modal path users can visibly see the position of the gate arm to aid in safe crossing areas where the multimodal trail is close to the gated entry.

Please do not tailgate other cars through the gates – only one car at a time. Allow the gates to close and activate the gates with your gate card or by pressing the red button.

The entry gates are equipped with an automatic timer to close; therefore, please remember to get through the gate promptly once it has fully opened.

The exit gate will automatically open when you drive your vehicle over the "exit loop" which is buried in the roadway. Simply approach the gate slowly, wait for the gate to open completely, and proceed through promptly.







#### **DID YOU KNOW?**

- 64% of U.S. adults have noticed or been notified of a major data breach affecting their sensitive accounts or personal data.
- Roughly half of Americans (49%) feel that their personal information is less secure than it was five years ago.
- 58% of Americans age 50 and older are more likely to feel that their personal information has become less safe in recent years: 58% of Americans in this age group express this opinion.

#### SIMPLE TIPS TO OWN IT.

#### Double your login protection.

Enable multi-factor authentication (MFA) to ensure that the only person who has access to your account is you. Use it for email, banking, social media, and any other service that requires logging in. If MFA is an option, enable it by using a trusted mobile device, such as your smartphone, an authenticator app, or a secure token—a small physical device that can hook onto your key ring.

#### • Shake up your password protocol.

According to NIST guidance, you should consider using the longest password or passphrase permissible. Get creative and customize your standard password for different sites, which can prevent cyber criminals from gaining access to these accounts and protect you in the event of a breach. Use password managers to generate and remember different, complex passwords for each of your accounts.

• **Be up to date.** Keep your software updated to the latest version available. Maintain your security settings to keeping your information safe by turning on automatic updates so you don't have to think about it, and set your security software to run regular scans.

• **If you connect, you must protect.** Whether it's your computer, smartphone, game device, or other network devices, the best defense against viruses and malware is to update to the latest security software, web browser, and operating systems. Sign up for automatic updates, if you can, and protect your devices with anti-virus software.

Now more than ever, consumers spend increasing amounts of time on the Internet. With every social media account you sign up for, every picture you post, and status you update, you are sharing information about yourself with the world. How can you be proactive to stay safe online and, "Own IT. Secure IT. Protect IT."? #BeCyberSmart and take these simple steps to connect with confidence and safely navigate the social media world.

#### **DID YOU KNOW?**

- 3.48 billion people worldwide now use social media worldwide. That's an increase of 9% from 2018. Put another way: 45% of the total world population are using social networks.<sup>1</sup>
- Digital consumers spend nearly 2.5 hours on social networks and social messaging every day.<sup>2</sup>
- 69% of U.S. adults use at least one social media site<sup>3</sup> and the average American has 7.1 social media accounts.<sup>4</sup>

#### SIMPLE TIPS TO OWN IT.

- Remember, there is no 'Delete' button on the Internet. Share with care, because even if you delete a post or picture from your profile seconds after posting it, chances are someone still saw it.
- Update your privacy settings. Set the privacy and security settings to your comfort level for information sharing. Disable geotagging, which allows anyone to see where you are—and where you aren't—at any given time.
- Connect only with people you trust. While some social networks might seem safer for connecting because of the limited personal information shared through them, keep your connections to people you know and trust.
- Never click and tell. Limit what information you post on social media—from personal addresses to where you like to grab coffee. What many people don't realize is that these seemingly random details are all that criminals need to know to target you, your loved ones, and your physical belongings—online and in the real world. Keep Social Security numbers, account numbers, and passwords private, as well as specific information about yourself, such as your full name, address, birthday, and even vacation plans. Disable location services that allow anyone to see where you are—and where you aren't—at any given time. Read the Social Media Cybersecurity Tip Sheet for more information.
- **Speak up if you're uncomfortable.** If a friend posts something about you that makes you uncomfortable or you think is inappropriate, let him or her know. Likewise, stay open-minded if a friend approaches you because something you've posted makes him or her uncomfortable. People have different tolerances for how much the world knows about them, and it is important to respect those differences. Don't hesitate to report any instance of cyberbullying you see.
- **Report suspicious or harassing activity.** Work with your social media platform to report and possibly block harassing users. Report an incident if you've been a victim of cybercrime. Local and national authorities are ready to assist you.

### HEALTH OFFICIALS ISSUE MOSQUITO-BORNE ILLNESS ADVISORY

**Bushnell, Fla.**—The Florida Department of Health in Sumter County (DOH-Sumter) and Sumter County Mosquito Control are advising residents of an increase in mosquito-borne disease activity in areas of Sumter County.

Sumter County Mosquito Control has increased mosquito prevention and surveillance efforts, however, taking personal safety measures can help you and your pets avoid irritating mosquito bites and prevent mosquito-borne infectious diseases.

Avoid being bitten by mosquitoes by taking the following precautions:

#### **DRAIN** standing water to stop mosquitoes from multiplying.

- <u>Drain</u> water from garbage cans, house gutters, buckets, pool covers, coolers, toys, flower pots or any other containers where sprinkler or rain water has collected.
- <u>Discard</u> old tires, drums, bottles, cans, pots and pans, broken appliances and other items that aren't being used.
- Empty and clean birdbaths and pet's water bowls at least once or twice a week.
- Protect boats and vehicles from rain with tarps that don't accumulate water.
- <u>Maintain</u> swimming pools in good condition and appropriately chlorinated. Empty plastic swimming pools when not in use.

#### COVER skin with clothing or repellent.

- <u>Clothing</u> Wear shoes, socks, and long pants and long-sleeves. This type of protection may be necessary for people who must work in areas where mosquitoes are present.
- <u>Repellent</u> Apply mosquito repellent to bare skin and clothing.
  - Always use repellents in accordance with the label instructions. Repellents with DEET, picaridin, oil of lemon eucalyptus, para-methane-diol, and IR3535 are effective.
  - Use mosquito netting to protect children younger than 2 months old.

#### **Tips on Repellent Use**

- Always read label directions carefully for the approved usage before you apply a repellent. Some repellents are not suitable for children.
- Products with concentrations of up to 30 percent DEET (N, N-diethyl-mtoluamide) are generally recommended. Other U.S. Environmental Protection Agency-approved repellents contain picaridin, oil of lemon eucalyptus, para-

methane-diol, or IR3535. These products are generally available at local pharmacies. Look for active ingredients to be listed on the product label.

- Apply insect repellent to exposed skin, or onto clothing, but not under clothing.
- In protecting children, read label instructions to be sure the repellent is ageappropriate. According to the Centers for Disease Control and Prevention (CDC), mosquito repellents containing oil of lemon eucalyptus should not be used on children under the age of three years. DEET is not recommended on children younger than two months old.
- Avoid applying repellents to the hands of children. Adults should apply repellent first to their own hands and then transfer it to the child's skin and clothing.
- If additional protection is necessary, apply a permethrin repellent directly to your clothing. Again, always follow the manufacturer's directions.

#### COVER doors and windows with screens to keep mosquitoes out of your house.

• Repair broken screening on windows, doors, porches, and patios.

# **Information Provided By SECO**

### KEEP IT CLEAR – WE WORK HERE



SECO personnel routinely perform work on transformers and meters on members' property. Field employees find it challenging to safely access padmount transformers and underground facilities when shrubs or fencing have been placed surrounding the front and sides of the equipment. The clearance zone is 10 feet in front and 3 feet on the sides and back of equipment. On meters, SECO needs unobstructed access to read the face and perform work safely. In maintenance and outage situations, the obstacles cause the work to take longer than necessary and most important, pose safety risks to our employees and can cause readings to be estimated rather than actual - resulting in an inaccurate electric bill.

Per our Terms & Conditions, these obstructions are simply unacceptable, and SECO is taking a firm stand on such violations. To raise awareness the co-op developed a new communications campaign called <u>Keep It Clear – We Work Here</u>. The campaign renews SECO Energy's commitment to employee safety in the field.

Keep fences, shrubs and other lawn ornaments at least 10 feet away from the front of the transformer and three feet away from the back and the sides. Open gates, clear obstructions and relocate animals that restrict SECO access to metering equipment. Trim landscaping that blocks the meter face. If SECO is unable to obtain a clear view of the meter and record an accurate meter reading, the member may receive an estimated (and inaccurate) bill for that reading cycle.

In the spirit of customer service, SECO has practiced diplomacy and patience with members who have refused to comply with our safe clearance requirements. The Keep it Clear campaign changes our approach. Unimpeded, safe access to SECO's transformers and metering equipment is a necessity.

As SECO personnel conduct equipment audits across our service territory, members with equipment obstructions on their property will be required to clear the obstructions or trim the landscaping that impedes SECO personnel's safe access. The Keep it Clear campaign provides affected members with letters, door hangers, emails and other notifications advising of the need for obstruction removal. If those notices are ignored, disconnection of service is a last resort but a step that will be taken in extreme cases.

Please join us for the third interactive Solid Waste Workshop presented by the North Sumter County Utility Dependent District (NSCUDD) and Jacobs, formerly CH2M, the waste hauler for Districts 1 – 11 on Wednesday, October 23, 2019 at The Savannah Center from 9:00 to 12:00!

The first workshop provided information on the District's current Solid Waste and Recycling Program, and the need to develop a Solid Waste Management Plan, as well as the state of the industry and the impacts this has on our current program. China and other Asian countries have placed policies and restrictions on the import of recyclables and which is impacting recycling throughout the world.

The second workshop recapped what we learned in the first along with additional information on the methods of solid waste disposal, as well as the rising costs. With the use of electronic survey clickers a series of questions were asked of the attendees and the results stated that the majority feels there is no need to change the solid waste collection process and are very satisfied with the service that is provided. The participants also indicated a willingness to pay slightly more per month to maintain the current solid waste and recycling program.

During the third workshop, alternative waste management options, options for waste disposal, and the associated costs will be presented followed by asking for additional input from the attendees. The District and Jacobs appreciate the participation and suggestions we have received so far and look forward to meeting with you again in October. - (2) Keep products in original labeled containers if possible.
- (3) Place containers into cardboard boxes to prevent breakage.
- (4) Place leaky container in clear plastic bag and transport in box with newspaper.
- (5) Put boxes in trunk or in back of vehicle away from passengers.
