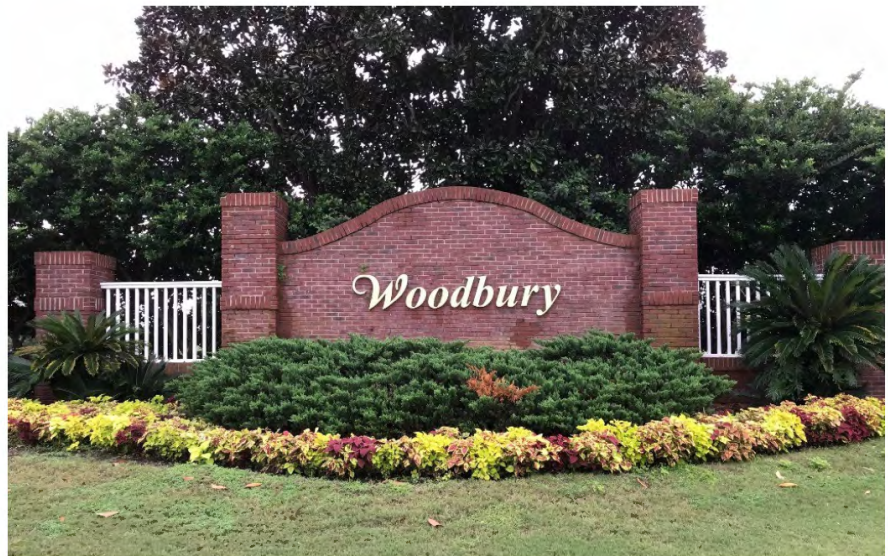

The Sterling Heights Recreation Center will be closed for maintenance on December 8th.

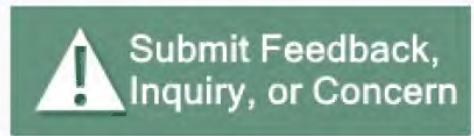

How can I obtain a guest pass and who qualifies for a pass?

Guest ID Card Services are available 7 days a week:

- Monday – Friday 8:30am – 5pm: All regional recreation centers (Paradise, La Hacienda, Savannah, Mulberry Grove, Laurel Manor, Lake Miona, Colony Cottage, SeaBreeze, Eisenhower, Rohan, Fenney and Everglades)
- Saturday & Sunday 8am-12pm: La Hacienda, Lake Miona, Eisenhower and Rohan Regional Recreation Centers Only (effective January 4, 2020 time changes to 8:30 a.m. – 12pm)

Guests of Villages’ residents whose home address is outside Lake, Sumter and Marion Counties are eligible to use selected amenity-supported recreational facilities. An original Villages Guest ID Card is required for all guests one (1) year of age and older. Village Community Development Districts Guest ID Card Program Policy

Purpose:

To set forth the rules, regulations and expectations for allowing approved guest(s) of eligible resident's limited use of District supported facilities and services.

Application:

Any resident requesting a Guest ID card(s) must make initial application to the Districts at the District Customer Service Center located at 984 Old Mill Run, at any Regional Recreation Center (Paradise, La Hacienda, Savannah, Mulberry Grove, Laurel Manor, Lake Miona, SeaBreeze, Colony Cottage, Eisenhower or the District web site, www.districtgov.org. In-Area Guest ID applications must be completed in person at one of the locations listed above.

The resident must provide all required guest(s) information requested on the application in order to be issued a Guest ID card. Any falsification or misrepresentation of guest information on the application will be considered a violation of the Guest ID card policy and subject to appropriate action as provided for in this policy.

Eligibility Requirements:

A resident with a valid Resident ID card can make application for a Guest ID card. A qualified guest is defined as an individual whose current residence is outside Lake, Marion and Sumter counties. A resident who has a son, daughter, grandchild or great grandchild (and their spouses) who reside in Lake, Marion or Sumter counties may apply for an In-Area Guest ID card.

Issuance:

Guest ID cards are issued for a guest (s) whose current residence is outside Lake, Marion and Sumter counties for up to 30 days from the issue date. Guest ID card renewals may be requested after the 30th day for an additional 30 days and renewals may continue to be issued every 30 days.

The In-Area Guest ID card for qualified family members is valid for one (1) year from date of issuance.

Supervision Requirements:

Guests are required to carry their original Guest ID card when using a District amenity facility even if accompanied by a resident. If the guest is under 19 years of age, they must be accompanied by a Village resident or a guest 19 years of age. *The information provided in this policy is current as of December 2009. The AAC and the District Boards reserve the right to amend and revise this policy, as deemed necessary.*

age or older with a valid Guest ID card and photo ID. The accompanying resident is required to have a valid Resident ID card. If a guest(s) does not have a valid Guest ID card with them, the guest(s) will be denied access to District amenity facilities.

In- Area Guests, regardless of age, will be required to have the sponsoring resident in attendance with them at all times when using District amenity facilities. If the In-Area Guest(s) is not with the sponsoring resident they will be denied access to District amenity facilities.

Age Requirements for Guest ID Cards:

All approved guests 1 year of age and older will be issued a Guest/In-Area Guest ID card. All approved guests 19 years of age and older must also have photo identification when using District amenity facilities. Some facilities have minimum age requirements. Please refer to www.districtgov.org, or The Villages Phone Book for more information regarding age restricted facilities.

Facilities Available for Use:

Please refer to the Recreation News Quick Link at www.districtgov.org or The Villages Phone Book for guest approved facilities. All approved facilities are also listed on the Guest ID/In-Area Guest ID card forms. All guests are required to follow all District rules and regulations governing use of District amenity facilities. Residents and Guests are encouraged to check-in at a Recreation Center prior to using any recreation facility.

Penalty for Misuse of Facilities or Falsification of Information:

If District Management confirms that any misuse of facilities has occurred or falsification of information to secure the ID has occurred, the following actions will be taken*.

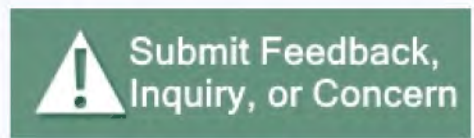
1. First infraction: A written letter will be sent to the resident with infraction details along with a follow up phone call and/or meeting to discuss the situation.
2. Second infraction within one (1) year: The resident's active Guest ID cards and/or In-Area Guest ID cards will be deactivated for a period of six (6) months. During the six (6) month period, the household (unit/lot) forfeits its right to be issued any Guest ID cards and/or In-Area Guest ID cards. The six (6) month time period will start from date of deactivation. After the six (6) month period, the household (unit/lot) will be eligible to re-apply for Guest ID card and In-Area Guest ID card privileges.
3. Third infraction within one (1) year: Guest ID card and In-Area Guest ID card privileges will be denied for the household (unit/lot) for one (1) year from the date of deactivation.

**If a resident knowingly falsifies the application, the resident will be subject to infraction number two regardless of infraction history, unless a second infraction has already occurred, then it will be considered the third infraction.*

The information provided in this policy is current as of December 2009. The AAC and the District Boards reserve the right to amend and revise this policy, as deemed necessary.

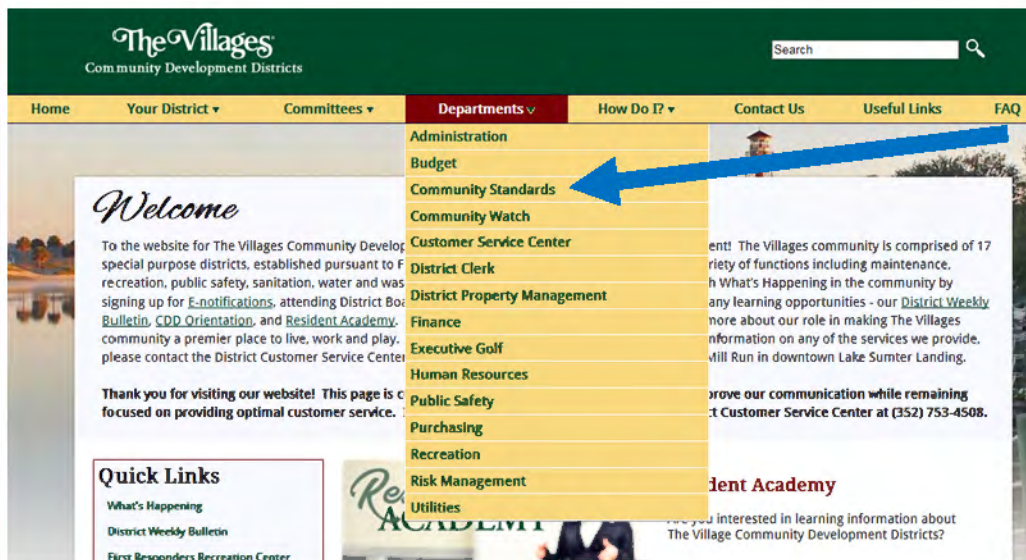

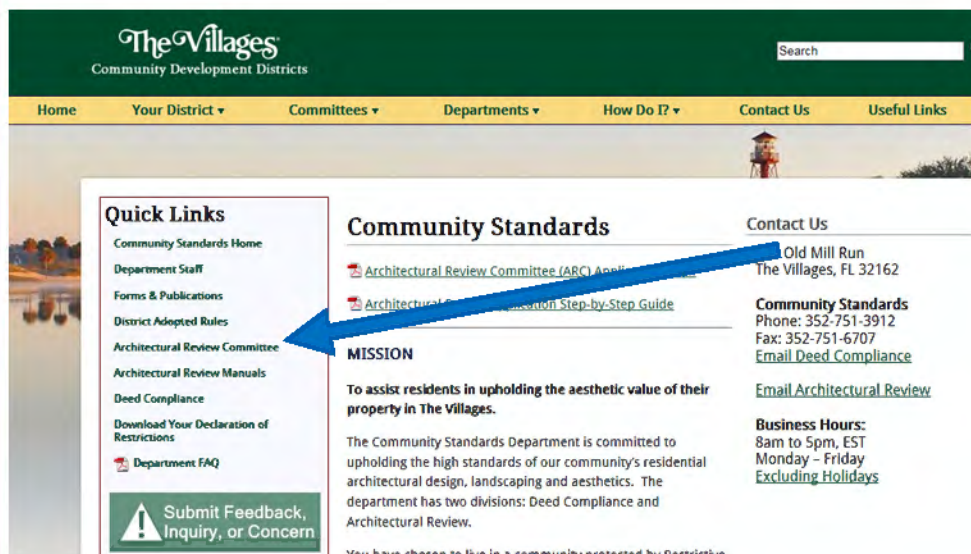


How do I obtain my Architectural Review Application Form results?

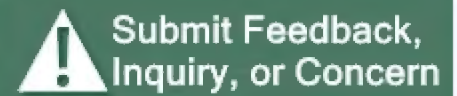

There are no schedule changes due to the holidays.

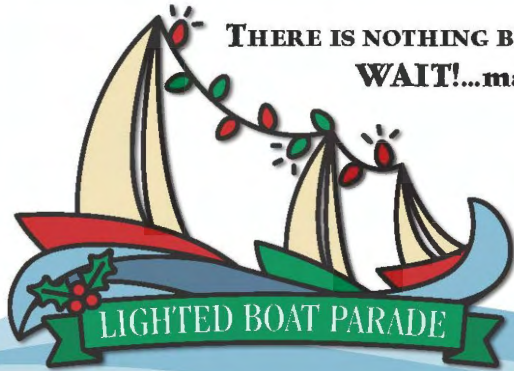

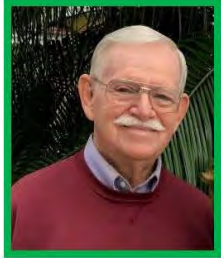

Older Driver Safety Awareness Week

December 3rd-7th 2019



It is a fact of life that people grow older every day. With increasing age comes changes in physical, mental and sensory abilities that can challenge a person's continued ability to drive safely. There are a variety of safe travel options for people of all ages. The real need is a broader awareness of the solutions, rather than a narrow focus on the problem.

The American Occupational Therapy Association (AOTA) believes that occupational therapy practitioners have the skills to evaluate a person's overall ability to operate a vehicle safely and provide rehabilitation, if necessary. Many are specially trained in the full scope of driving rehabilitation. Occupational therapy practitioners work with older adults as well as their families and caregivers, offering individualized assessment. They can identify individuals' unique challenges and find strategies that will help them live life to its fullest by keeping them active, healthy and safe in their communities.

- One in six drivers in the United States are 65 years or older.
- Older adult drivers are more than twice as likely to report having a medical problem that makes it difficult to travel as compared with drivers ages 24–64.
- Four in five older adults take one or more medications daily. Physical changes that occur with age can change the way the body reacts to medicines, causing more side effects and affecting the ability to concentrate and drive safely.

Here are some steps that older adults can take to stay safe on the road:

- Discuss any medical issues with your doctor to determine if they might affect your driving.
- Discuss stopping or changing your medications with your pharmacist or doctor if you experience any side effects that could interfere with safe driving such as blurry vision, dizziness, sleepiness, confusion, fatigue, and/or loss of consciousness.
- Have your eyes checked by an eye doctor at least once a year. Wear glasses and corrective lenses as directed.
- Plan your route before you drive.
- Consider potential alternatives to driving, such as riding with a friend, using public transit, or car ride services.

Risk Management

We all experience physical and mental changes as we age. Some may be so minor that we don't notice them, while others may interfere with daily life. Slower reaction time, night blindness, and pain and stiffness can affect driving skills but do not need to prohibit driving.

Another proactive way for older adults to enhance their safety behind the wheel is to be sure their car's adjustments are best for them by participating in a CarFit event. CarFit is an educational program developed by the American Society on Aging in collaboration with AAA, AARP, and AOTA. The volunteer leaders include occupational therapy practitioners who use a 12-point checklist to ensure that each driver's car is adjusted properly for the best "fit," and that the safety features of the vehicle are explained, increasing the likelihood that they are being used optimally. The entire process takes about 20 minutes. Go to <https://www.car-fit.org/> to find locations near you.

Many older adults may think about what they can do to remain fit to drive as long as safely possible while silently wondering if a day will come when they might have to stop driving. Early conversations between families and friends can bring up questions that focus on the importance of physical and mental health to preserve essential driving skills as well as options supporting an engaged life after driving, such as, "how do you think you could get to church if you ever quit driving?" Following a family conversation an older driver may decide that it is time to get a check-up for his or her driving fitness. Checking one's driving fitness is important because driving requires complex physical, visual, and cognitive abilities. These abilities can change in subtle ways, such as difficulties driving at night but having no problems driving in the daylight. Driving fitness evaluations range from self-assessments, which can be useful educational tools to help identify potential challenges, to a comprehensive driving evaluation from an occupational therapy driving rehabilitation specialist.

Ask your healthcare provider if it is time for you to have a driver fitness evaluation. Your safety and the safety of the public is very important while you're behind the wheel.

During Older Driver Safety Awareness Week, December 2-6, 2019, the Florida Department of Transportation's (FDOT) Safe Mobility for Life Coalition encourages all Floridians to be proactive about their safe driving skills.

Sixty-seven percent of the participants in the 2017 Florida Aging Road User Survey fear they will be isolated if they cannot drive. The Safe Mobility for Life Coalition is here to change that by providing everything a person needs to maintain safe driving skills and tools to plan for their transportation future in one easy-to-access location. The SafeMobilityFL.com/ODSAW2019.htm website has a wealth of information:

- Browse a statewide interactive map showing events such as CarFit, AARP Smart Driver Courses, AAA Mature Driver Improvement Courses and FLOW Mobile locations.
- Download or flip through the new "Florida's Guide to Safe Mobility for Life" e-book in either English or Spanish to learn about resources in each of Florida's 67 counties.
- Access helpful brochures, booklets and tip cards such as the "Tips on Using Transportation Options in Florida" series that explores various transportation options.
- Complete worksheets to design the perfect transportation plan for your mobility needs.

During Older Driver Safety Awareness Week, we want all aging road users in Florida to understand the impact aging has on driving, learn how to be proactive about safe driving skills, and plan for a safe transition from driving.
