Christmas Tree Collection

If you live in Village Community Development Districts 1-11 in the Sumter County, Marion County or Fruitland Park portions of The Villages, discarded live Christmas Trees can be placed at the curb (trees cannot be more than 4' in height or must be cut to 4' lengths) and will be picked up with your yard waste collection only. No yard waste will be collected on Wednesday, December 25th or Wednesday, January 1st. Make up days will be Saturday, December 28th and Saturday, January 4th.

Artificial trees should be taken apart and placed curb side in sections and will be collected with your regular household trash (not recycling) on your designated day. If you have any questions please contact sanitation at 352-748-0109.

Q & A with AAC Chair Ann Forrester

What is the Amenity Authority Committee (AAC)?

The AAC is a committee of the Village Center Community Development District (VCCDD). We are responsible for

amenity infrastructure and services north of C.R. 466 which entails the review of budgets, development of recreational policy and the operation of amenity facilities and services. The facilities under our purview include recreation centers, executive golf courses, gate houses, postal facilities and all non-commercial District owned property; not under the purview of the CDDs. The Fiscal Year 2019-2020 Village Center- Recreation Amenities Division (RAD) budget is \$43,216,931.

What is the Committee's purview?

The facilities north of C.R. 466 under our purview include recreation centers, executive golf courses, gate houses, and postal facilities as well as District owned properties not under the purview of the various CDDs.

What were the Committee's largest accomplishments last year?

Aquatic Access Lift Chairs, Multi-Modal Path Signage, Executive Golf Course Improvements, Del Mar Gate Improvements, First Responders Recreation Center Project site/interior planning and a successful capital projects workshop.


How many residents interact with the Committee?

It varies by time of year and projects but normally 25-30 persons per meeting. Overall, there are approximately 22,000 rooftops north of C.R. 466.

What is this First Responders Recreation Center Project that I read about?

The First Responders Recreation Center project is a project for a new recreation center just south of C.R. 42 and west of Buena Vista Blvd., behind the Baptist Church. The Center and its property will be yet a showcase for unique and new (as referring to the features of Recreation Centers north of C.R. 466) recreational amenities as it is on approximately 19.2 acres and the center will be repurposing the existing 9200 square foot Fellowship Hall facility. 
What are the sources of funding for the work of the Committee?





Aerification will be done during the normal closures.

Overseed will be scheduled separately.

The superintendent, as needed, may request small blockages of time to accomplish maintenance practices, such as topdressing before play from the facility manager.





Holidays with Family and Friends

Take steps to make sure your holiday get-togethers are safe and healthy.

Plan menus for everyone:

You can accommodate the dietary needs of relatives or friends by offering options that are low in calories, sugar, salt, fat and alcohol. Find helpful meal planning hints to enjoy your favorite foods with healthier ingredients. Learn ideas for nutritious snacks at <u>https://www.cdc.gov/healthyweight/healthy_eating/meals.html</u>.

Prepare Food Safely Foodborne illness or food poisoning is caused by consuming contaminated foods or beverages. To protect yourself and loved ones, follow these guidelines:

Clean/Wash Produce:

- Rinse fresh fruits and vegetables in running tap water to remove visible dirt and grime.
- Remove and discard the outermost leaves of a head of lettuce or cabbage.
- Because bacteria can grow well on the cut surface of fruit or vegetables, be careful not to contaminate these foods while slicing them up on the cutting board and avoid leaving cut produce at room temperature for many hours.
- Don't be a source of foodborne illness yourself:

*Wash your hands with <u>soap and water</u> before preparing food.

*Avoid preparing food for others if you have a diarrheal illness.

Separate. Don't cross-contaminate one food with another.

- Avoid cross-contaminating foods by washing hands, utensils, and cutting boards after they have been in contact with raw meat or poultry and before they touch another food.
- Put cooked meat on a clean platter, rather than back on one that held the raw meat.



Risk Management

Cook. Cook meat, poultry, and eggs thoroughly.

- Using a thermometer to measure the internal temperature of meat is a good way to be sure that it is cooked sufficiently to kill bacteria.
- Eggs should be cooked until the yolk is firm.

Chill. Refrigerate leftovers promptly.

- Bacteria can grow quickly at room temperature, so refrigerate leftover foods if they are not going to be eaten within 4 hours.
- Large volumes of food will cool more quickly if they are divided into several shallow containers for refrigeration.

Go Green

• Be conscious of the environment—and help sustain it for future generations! Whenever possible, recycle items from your reunion such as aluminum, glass, plastic, or paper. Use less and therefore throw away less. Reduce greenhouse gas emissions that contribute to global climate change.

Travel Smart

- Whether you're traveling down the street, across the country, or overseas, be prepared.
- <u>Don't drink and drive, and don't let someone else drink and drive</u>.
- Always wear a seat belt while riding in a motor vehicle.
- Always buckle children in child safety seat, booster seat or seat belt depending on their age and size.
