



#### How can I be notified when new District positions are open?




Please note:




#### What types of calls do The Villages Public Safety personnel respond to?

The Villages Public Safety Department consists of 9 Fire Stations and 126 Full-time firefighter personnel in addition to 6 Battalion Chiefs and 15 Administrative personnel. Our Public Education Technicians responded to 6,624 requests for battery changes in 2019.

The Villages Public Safety Department responded to 29,219 calls in FY2019 with an average response time of 4 minutes and 26 seconds.

In FY 2020 we have already responded to 10,609 calls. Below is a breakdown of the types of calls the department responded to.



## The Villages® Community Development Districts Property Management Notice of Construction and Partial Road Closure Shay – Silver Lake Gate House Restroom Addition 1000 Shay Blvd, The Villages FL 32159

The referenced project new start date is 2-18-20

On February 18, 2020, the District will begin a construction project at the Shay Gate located at the corner of Shay Boulevard and Griffin Road. The project generally consists of the renovation of the interior and exterior of the existing gate house, as well as constructing a restroom addition to the building. There are site improvements included in the project such as utility upgrades and lane / parking improvements. The project will be completed on or about May 5, 2020.

All of the construction and site improvements will take place in the right-of-way along Shay Boulevard. There should be no interruption in utility services to any of the nearby homes. The westerly outbound or exit lane of Shay Boulevard from the corner of Shay Boulevard and Tarrson Boulevard to Griffin Road will be closed while this work is completed. The easterly entry lane from Griffin Road will remain open. Please proceed with caution. Detour signage and other means of directing traffic will be used to guide the flow of traffic safely through the neighborhood. In addition, the gate house will be closed during the construction.

Heart disease is not only found in older adults. It has become more common in young adults due to conditions that lead to heart disease becoming more common at younger ages. February is Heart Month, the perfect time to learn the steps you need to take now to help your heart. Heart disease—and the conditions that lead to it—can happen at any age. High rates of obesity and high blood pressure among younger people (ages 35-64) are putting them at risk for heart disease earlier in life. Half of all Americans have at least one of the top three risk factors for heart disease (high blood pressure, high cholesterol, and smoking).

#### You Could Be at Risk

- <u>High blood pressure</u>. Millions of Americans of all ages have high blood pressure, including millions of people in their 40s and 50s. About half of people with high blood pressure don't have it under control. Having uncontrolled high blood pressure is one of the biggest risks for heart disease and other harmful conditions, such as stroke.
- <u>High blood cholesterol</u>. High cholesterol can increase the risk for heart disease. Having diabetes and obesity, smoking, eating unhealthy foods, and not getting enough physical activity can all contribute to unhealthy cholesterol levels.
- Smoking. More than 37 million U.S. adults are current smokers, and thousands of young people start smoking each day. Smoking damages the blood vessels and can cause heart disease.

## Other conditions and behaviors that affect your risk for heart disease include:

- Obesity. Carrying extra weight puts stress on the heart. More than 1 in 3 Americans—and nearly 1 in 6 children ages 2 to 19—has obesity.
- Diabetes. Diabetes causes sugar to build up in the blood. This can damage blood vessels and nerves that help control the heart muscle.
   Nearly 1 in 10 people in the United States has diabetes.
- Physical inactivity. Staying physically active helps keep the heart and blood vessels healthy. Only 1 in 5 adults meets the physical activity guidelines of getting 150 minutes a week of moderate-intensity activity.

• Unhealthy eating patterns. Most Americans, including children, eat too much sodium (salt), which increases blood pressure. Replacing foods high in sodium with fresh fruits and vegetables can help lower blood pressure. But only 1 in 10 adults is getting enough fruits and vegetables each day. Diet high in transfat, saturated fat, and added sugar increases the risk factor for heart disease.

#### **<u>4 Ways to Take Control of Your Heart Health</u>**

You're in the driver's seat when it comes to your heart. Learn how to be heart healthy at any age.

**Don't smoke.** Smoking is the leading cause of preventable death in the United States. If you don't smoke, don't start. If you do smoke, learn how to quit.

**Manage conditions**. Work with your health care team to manage conditions such as high blood pressure and high cholesterol. This includes taking any medicines you have been prescribed. Learn more about preventing and managing high blood pressure and high cholesterol.

**Make heart-healthy eating changes.** Eat food low in trans-fat, saturated fat, added sugar and sodium. Try to fill at least half your plate with vegetables and fruits, and aim for low sodium options. Learn more about how to reduce sodium.

**Stay active.** Get moving for at least 150 minutes per week. You can even break up the 30 minutes into 10-minute blocks. Learn more about how to get enough physical activity.
