As we continue to do our part in slowing the spread of COVID-19 in our community, we would like to remind everyone of the CDC Guidelines that should continue to be followed to ensure the protection of health for all residents, visitors, staff, and children who will be returning to school in the next few weeks.

What you need to know

- **Anyone at any age** can have mild to severe symptoms.

Symptoms

When to Seek Emergency Medical Attention

Look for **emergency warning signs*** for COVID-19. If someone is showing any of these signs, **seek emergency medical care immediately:**

- Trouble breathing
- Persistent pain or pressure in the chest
- New confusion
- Inability to wake or stay awake
- Bluish lips or face

*This list is not all possible symptoms. Please call your medical provider for any other symptoms that are severe or concerning to you.

IT'S BACK TO SCHOOL MONTH! We would like to remind you to be extra vigilant as students return to school with regard to stopping the spread of COVID-19. Please make sure your children and grandchildren know how to prevent the spread of germs. We can only **stop** the spread of COVID-19 when **everyone participates!**



How can you help prevent the spread of respiratory diseases like COVID-19?

Age Requirements

De La Vista Fairway Renovation Update

The fairways at De La Vista were planted with grass this past week and now the grow-in period begins. This process will take 8-10 weeks and involves attention to watering, agronomic practices and fertilization.



The collars and approaches were sodded with Tif-Grand Bermuda grass.



The fairways were hand sprigged with Celebration Bermuda grass.



Sprigging is the broadcast spreading of the turf grass vegetation; stolons and rhizomes that have little soil attached.



The sprigs are cut into the soil in a couple different directions.

Storm Water Management System

To ensure adequate capacity of the storm water management system throughout the community, the District will be lowering certain water retention areas that are above recommended levels. The water level is being lowered to ensure there is sufficient capacity in the water retention area to capture water run-off from streets, yards and golf courses in preparation of future rain events. Please be advised that water being utilized through the irrigation system is storm-water resulting from rain events.

Here are the Storm Water Management procedures taking place in anticipation of storms and excess rain during the Hurricane season.

- Paradise Lake & Lone Oak Lake have been lowered in the Lady Lake/Lake County portion of The Villages.
- Basins D6-22 and Basin D6-23 have been lowered in District 6.
- El Diablo Basin is being lowered in District 2.
- We are irrigating from Basin 14-1 to maintain a safe water level in District 1.
- Golfview Lake is being maintained to a safe minimum level to support any rising of Lake Mira Mar located in the Lady Lake/Lake County portion of The Villages.
- Lake Lago Poco is maintained to an equalization level with Paradise in the Lady Lake/Lake County portion of The Villages.
- Cichiello Preserve over flows have been cleaned and tested in District 1.
- Lake Laguna is still being maintained at a low level to be able to except excess water from Lake Diablo and Lake El Santiago located in District 2.
- Manual transfer valves have been massaged to assure proper operation in District 4.

Fall Hydrilla Treatments

There will be two visual inspections taking place to determine what Basins are needing treatment for the fall Hydrilla treatments. The 1st sight visit of all Basins will be completed on August 28, 2020. The second sight visit will begin on October 1, 2020. These site visits will allow the development of the list of treatments needing to take place in October for the fall Hydrilla treatments.

Can signs be placed in yards in The Villages?

The District office routinely receives inquiries regarding signs located on residential properties, so we have prepared an overview of signage enforcement for each District.

In **Village Community Development Districts 2 through 4** and the **Lady Lake/Lake County portion of The Villages** the deed restrictions provide, by an Affirmation and Consent by the Developer, one professional sign no larger than 24 inches wide by 24 inches high may be placed on an exterior window of the home.

Village Community Development District No. 1 chose not to enforce the sign restriction.

In **Village Community Development Districts 5 through 12** the deed restrictions provide: One professional sign advertising a property for sale or for rent which shall be no larger than 12 inches wide by 12 inches high and located wholly within the home and only visible through a window of a home.

The following exceptions apply:

- Security: Small decals or small signs may be placed on doors, windows and planting beds next to the house.
- Lawn Care: State law allows for a sign to be placed on the newly-treated lawn until dry.

Preventative maintenance is occurring on the potable water system field valves throughout many areas of The Villages. Those customers serviced by Village Center Service Area (VCSA), Little Sumter Service Area (LSSA) and North Sumter Utilities (NSU) that will be impacted will be notified 24 hours in advance of a temporary interruption in service and will receive the following notification:

THE PUBLIC DRINKING WATER MAINS IN YOUR AREA WILL BE SHUT DOWN TEMPORARILY FOR NEEDED MAINTENANCE.

*AS A PRECAUTION, UPON RETURN OF WATER SERVICE, WE ADVISE THAT ALL WATER USED FOR **DRINKING, MAKING ICE, AND COOKING BE BOILED**, **FOR ALL OTHER HOUSE HOLD USES THE WATER IS ACCEPTABLE**. A ROLLING BOIL OF ONE MINUTE IS SUFFICIENT. AS AN ALTERNATIVE, BOTTLED WATER MAY BE USED.*

THIS "PRECAUTIONARY BOIL WATER NOTICE" WILL REMAIN IN EFFECT UNTIL THE MAINTENANCE TASK HAS BEEN COMPLETED AND A BACTERIOLOGICAL SURVEY SHOWS THAT THE WATER IS SAFE TO DRINK. THIS USUALLY CONSISTS OF A TWO DAY SAMPLING PERIOD TO INSURE SAFE DRINKING WATER.

Gate Information for Election Dates



Subject: Political Campaign Activities



Each election period raises questions about allowable campaign activities within the Village Community Development Districts. In order to assist all candidates, we have prepared the following overview. However, any questions with regard to activities allowed or prohibited should be directed to District Administration at (352) 751-3939.

Signs:

1. As it relates to political signage, the Declaration of Restrictions provides that no exterior signs will be permitted without the express written consent of the Developer. The Developer provided consent for properties north of C.R. 466 for the placement of one (1) professionally prepared sign not exceeding 24"x24" affixed to an exterior window of a residence. The Developer provided consent for properties south of C.R. 466 for the placement of one (1) professionally prepared "For Sale" or "For Rent" sign not exceeding 12"x12" affixed to an interior window of a residence. As information, the Board of Supervisors for Village Community Development District No. 1 elected not to enforce the deed restriction prohibiting signage within their respective District boundary.
2. Signs may not be affixed to the exterior walls of District-owned property.
3. Signs may be affixed to golf carts or Low-Speed Vehicles. Signs may be held by candidates or their supporters.
4. Signs may not be placed on District property. Signs placed on District property will be removed and the District is not liable for the return of removed signs.

Election Day Polling Places:

1. Activities at polling places shall be in accordance with the interpretation of state statute or local ordinance by the applicable Supervisor of Elections. The Supervisor of Elections is the entity to interpret the statutes and local ordinances.
2. Persons in support of candidates or issues shall not interfere with any member of the public accessing/using District property or voters attempting to enter a polling place located on District property.

Community Development District Public Facilities

1. Candidates and their supporters are allowed to stand on the exterior of District-owned facility property (i.e. postal facilities, recreation centers and at public events) in compliance with the Rules of the District.
2. Candidates and their supporters are not allowed to interfere with persons attempting to access District facilities and/or activities.
3. Candidates and their supporters are not allowed to implant or affix, in any way, any signage at these facilities. Signs may be affixed to golf cars, Low-Speed Vehicles or held by candidates or their supporters.

Per District Legal Counsel, a reminder as to:

- Fla. Stat. s. 102.031(4)(a): No person, political committee, or other group or organization may solicit voters inside the polling place or within 150 feet of the entrance to any polling place, a polling room where the polling place is also a polling room, an early voting site, or an office of the supervisor where vote-by-mail ballots are requested and printed on demand for the convenience of electors who appear in person to request them. Before the opening of the polling place or early voting site, the clerk or supervisor shall designate the no-solicitation zone and mark the boundaries.
- Fla. Stat. s. 102.031(4)(e): The owner, operator, or lessee of the property on which a polling place or an early voting site is located, or an agent or employee thereof, may not prohibit the solicitation of voters outside of the no-solicitation zone during polling hours.

What's Happening In Your District...



Callahan and Belle Glade Villas

District Property Management (DPM) has received the necessary permit modification from Southwest Florida Water Management District (SWFWMD) to complete work within Wetland 88 (District wetland asset identification) under conditions of the Environmental Resources Permit. Regular updates of the District's progress to design, permit and advance the work are presented monthly to the District 10 Board of Supervisors. Now that the design is complete and the permit modification has been approved by SWFWMD, the District is proceeding with the procurement of a contractor to complete the work within the wetland. DPM will present a recommendation to award the contract for this project within Wetland 88 to the Project Wide Advisory Committee (PWAC) and the Sumter Landing Community Development District (SLCDD) for approval to proceed with the award of the contract.

The engineering review process of all existing conditions potentially impacting the pavement life span was necessary to develop the best solution to provide improved pavement conditions. It was determined from the review of the geotechnical borings performed that the pavement condition was being impacted by the seasonal groundwater intrusion into the pavement subgrade. Once the project within the wetlands is completed, DPM will monitor the groundwater elevations beneath the road surface for a few months to verify the intended results are achieved. Once the intended results are verified, the District will be able to move forward with the planned pavement restoration project. Based on current schedules the paving project is most likely to occur late in 2020 as part of the fiscal year 20-21 budget (beginning October 2020). The District will continue to provide regular updates to the District 10 Board, PWAC and Villa residents regarding project milestones and related project progress. Thank you for your patience and be assured the District is working diligently to provide a long-term and cost-effective pavement restoration solution. Information Provided By The Florida Department of Transportation

As part of the Multi-Modal Bridge project over Florida's Turnpike at milepost 303, in Sumter County, we will be performing a full closure of northbound and southbound Florida's Turnpike between CR 470 (Exit 296) and US 301 (Exit 304) to allow crews to set the bridge.

To perform this work, traffic will be detoured during the following dates and times:

Northbound and southbound Florida's Turnpike/SR 91 between CR 470 (Exit 296) and US 301 (Exit 304)

Overnight full road closure, 11 p.m. Wednesday, August 26, to 5 a.m. Thursday, August 27.
