The Facilities Division of District Property Management (DPM) has been hard at work ensuring the many amenities within The Villages are maintained to the highest standards. It is unbelievable how many projects our hard-working Facilities Division team has been able to complete so far this year to support our residents and community. The dedication and pride each team member displays is evident across all of the recreation facilities managed by DPM. Always striving to maintain the “Resort Level” Standards of this community, our projects range from exterior painting, sports court renovations, pool renovations, installation of outdoor fitness equipment, HVAC replacements, roof replacements and even complete facility renovations. Your Declaration of Restrictions stipulates who is responsible for maintaining the wall or fence on your property. You can download them from [DistrictGov.org](http://DistrictGov.org). If you're still unclear, please call District Property Management at 352-753-4022 for assistance.

### **What can I do if I notice the plants and flowers are dying at my gate entrance?**

Each year District contractors replace millions of seasonal and ornamental plants throughout The Villages. Because of these quantities, all material is contract grown or acquired by reputable growers to ensure a consistent product. At times, some plants may decline prematurely. This can be caused by wet or dry conditions, temperature changes, or simply outliving its intended lifespan. We are continuously monitoring all Districts and planning and scheduling these improvements. If you see an area in need of attention, please contact District Property Management at 352-753-4022.

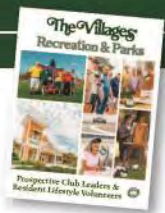

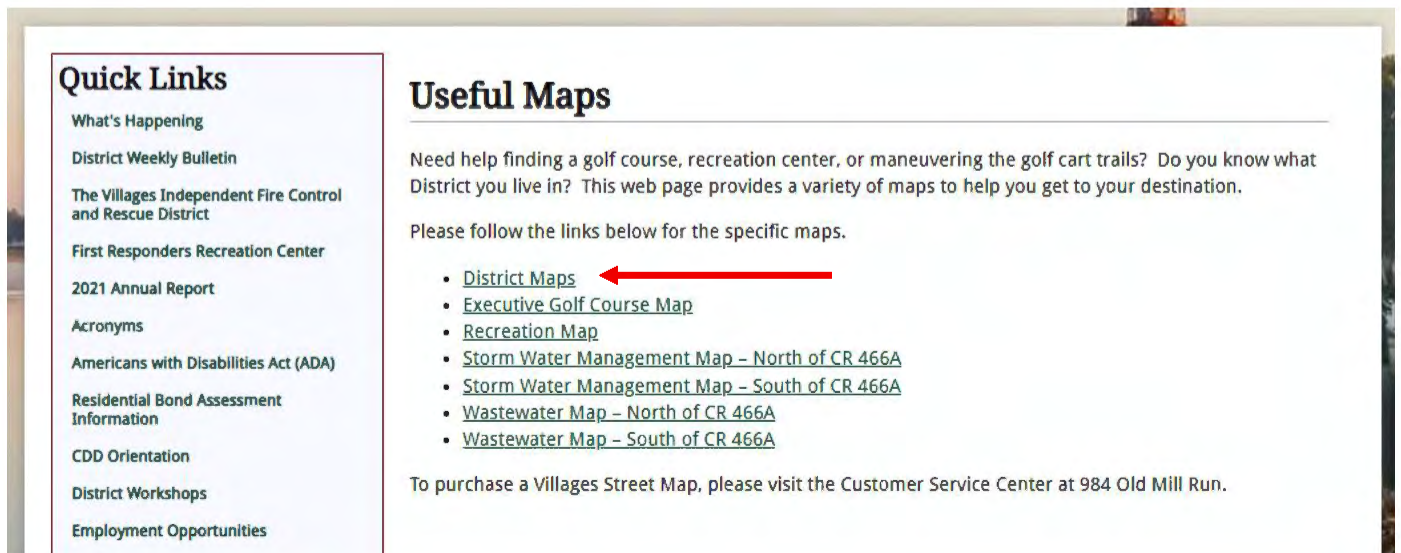

## Did You Know??

### 5 Utilities Serving The Villages

The District is pleased to be able to serve its residents with a supply of pure and safe water while providing dependable wastewater services.

The Utilities serving the residents of The Villages are:

- **Village Center Service Area** – Serving Lake County and District 1 in Sumter County is owned by Village Center Community Development District.
- **Little Sumter Service Area** – Serving Districts 2, 3 in Sumter County and District 4 in Marion County) is owned by Village Center Community Development District. **EXCLUDES Dist. 4 Ph. IV Phillips (M232) / Soulliere (M233) / Chatham Acres (M839).**
- **North Sumter Utility** – Serving Districts 5, 6, 7, 8 and a small section of District 9 in Sumter County is owned by North Sumter County Utility Dependent District.
- **Central Sumter Utility** – Serving a majority of District 9 and all of Districts 10 and 11 in Sumter County is owned by North Sumter County Utility Dependent District.
- **South Sumter Utility** – Serving District 12, 13 and a portion of District 14 is owned by the Wildwood Utility Dependent District.

The District Utilities Department is responsible for the operations and management of the water and wastewater treatment systems. The District Finance Department is responsible for the billing and payment collection for those services.

Water supply quantities are regulated by the St. Johns Water Management District (Lake County) and Southwest Florida Water Management District (Sumter and Marion County) which have issued consumptive use permits to the five utilities serving the residents of The Villages. Water and wastewater treatment and distribution are regulated by the Florida Department of Environmental Protection.

## Information Provided By...

### For residents living in Village Community Development Districts 1-11 in Sumter County, Marion County and The Villages of Fruitland Park:

- All Household Solid Waste and Yard Waste is picked up twice a week—same time, same truck, all together!
- All household waste should be placed in sealed tall kitchen trash bags or 20-30 gallon trash bags (any color with the exception of red, which is used for medical waste).
- All materials can be placed in the same bag, no need to sort!
- The trash bags should be left at the end of your driveway, **no garbage cans are allowed.**
- Each bag should weigh no more than forty (40) pounds.
- Bags must be placed for collection before 6:00 a.m. on your collection day or the night before (no sooner than 5:00 p.m.)
- Wrap broken glass or other sharp objects in newspaper and place them where they cannot cause injury.
- Limbs & branches should be bundled and tied and may not exceed 4” in diameter, 4’ in length or exceed 40 pounds.

**Town of Lady Lake Residents** may contact Waste Management at 352-787-4416 with questions.

**Unincorporated Lake County Residents (not including District 11)** may contact Lake County Solid Waste at 352-343-3776 with questions.

### **WATER SYSTEM MAINTENANCE**

Preventative maintenance is occurring on the potable water system field valves throughout many areas of The Villages. Those customers serviced by Village Center Service Area (VCSA), Little Sumter Service Area (LSSA), North Sumter Utilities (NSU), Central Sumter Utilities (CSU) and South Sumter Utilities (SSU) that will be impacted will be notified 24 hours in advance of a temporary interruption in service and will receive the following notification:

**THE PUBLIC DRINKING WATER MAINS IN YOUR AREA WILL BE SHUT DOWN TEMPORARILY FOR NEEDED MAINTENANCE. AS A PRECAUTION, UPON RETURN OF WATER SERVICE, WE ADVISE THAT ALL WATER USED FOR DRINKING, MAKING ICE, AND COOKING BE BOILED, FOR ALL OTHER HOUSE HOLD USES THE WATER IS ACCEPTABLE. A ROLLING BOIL OF ONE MINUTE IS SUFFICIENT. AS AN ALTERNATIVE, BOTTLED WATER MAY BE USED.**

THIS "PRECAUTIONARY BOIL WATER NOTICE" WILL REMAIN IN EFFECT UNTIL THE MAINTENANCE TASK HAS BEEN COMPLETED AND A BACTERIOLOGICAL SURVEY SHOWS THAT THE WATER IS SAFE TO DRINK. THIS USUALLY CONSISTS OF A TWO-DAY SAMPLING PERIOD TO INSURE SAFE DRINKING WATER.

#### Share the path

We are currently in the season where we see the highest volume on our multimodal paths, walking or nature paths. The many trails and pathways within our community provide all Villagers the opportunity to explore the natural beauty of Florida while traveling by golf car, bicycle, or pedestrian. So please, use caution and care:



- **Please be aware that individuals using mobility devices have equal access to all of our beautiful paths and trails.**
- Please slow and ride single file when experiencing heavy traffic on a path.
- When passing someone traveling in the same direction, please slow and allow for oncoming traffic to pass before going around that cart, bicycle or pedestrian.
- Always use caution by controlling the speed of your golf car or bicycle so you have time to react to other users who may be stopping or slowing more suddenly.

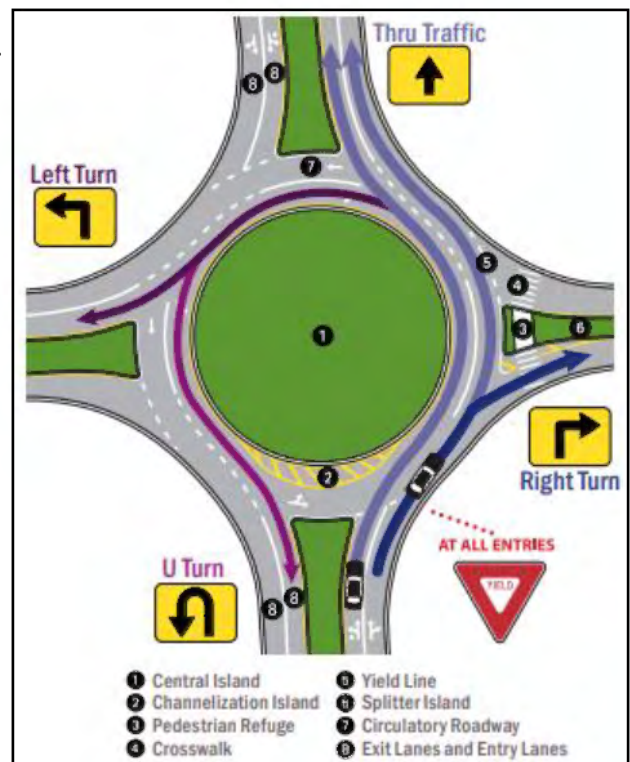

### Share the Road

Again, we are currently in the busy season and so we are seeing some of the highest volumes of vehicles on our roadways. We hope that all will exercise caution on our roadways and share the road with other vehicles.

- Obey the speed limit.
- Keep a safe distance from vehicle ahead of you to allow for stopping, turning, or changing lanes.
- The left lane on our roads is the passing lane until nearing a roundabout.
- Headlights help with visibility even when sunny.
- Please slow to 5 mph when entering gate areas and expect the gate to close after each vehicle.
- Share the road with bicycles. They are a vehicle in the state of Florida and you must allow 3 feet between you and the left handlebar of the bicycle when passing.

- Do not disturb their habitat - especially their nests or babies.
- Clean up your trash and dispose of it properly — including pet waste.

## Wildwood Seeks Citizen Input for Strategic Plan

Wildwood City Manager Jason McHugh today invited all city residents and businesses to provide input on the draft 2023-2027 Strategic Plan.

“This plan shapes the city’s priorities and defines specific action items and measurables over the next five years,” McHugh said. “We want to hear from citizens to ensure we are focusing on what is most important to them.”

Mayor Ed Wolf emphasized the significance of public input, adding, “I’ve been in this city more than 50 years now, and I’ve watched it grow by leaps and bounds. I’ve had the pleasure of serving as mayor for the past 30 of those years and can tell you that every resident who shares their thoughts helps me do my job better.”

The draft plan incorporates previous feedback from stakeholders provided during the 2020 update to the city’s 2018-2022 Strategic Plan, the Downtown Master Plan information gathering phase, and the 2050 Comprehensive Plan public input sessions. It also draws from employee survey responses and a questionnaire answered by city commissioners.

The draft centers on the following key areas:

- Community Engagement
- Transportation
- Affordable Housing
- Downtown Redevelopment
- Infrastructure
- Employee Recruitment and Retainment

Residents can review the draft plan on the city’s website, [www.wildwood-fl.gov](http://www.wildwood-fl.gov), and submit comments by email to [LPiotrowicz@wildwood-fl.gov](mailto:LPiotrowicz@wildwood-fl.gov).

As the plan is tied to the city budget, citizens also may comment during the public budget hearings at 7:00 p.m. on September 12 and 26, 2022, in the City Hall Commission Chamber located at 100 N. Main Street.

“It is definitely not too late to be heard,” McHugh stressed. “We are accepting written comments until September 9, 2022, so we can adjust the draft accordingly before the city commission votes on it later in the month.”

Mayor Wolf agreed. “There is still time to weigh in. We really do listen and care what residents think. Honestly, it’s why we serve as commissioners. It’s about serving the people.”
