### Hacienda Hills Temporary Postal Station

The Hacienda Hills Postal Station will be undergoing renovations and will be closed until further notice. All mail delivery will be relocated to the temporary Postal Facility located in the Hacienda Hills Postal Station parking lot starting on Tuesday, December 6, 2022. Barricades will be placed to restrict access to the Hacienda Hills Postal Station and some surrounding areas. A bulletin board and a District correspondence/amenities box have been placed at the temporary facility and are available for use.



**The golf car tunnel under Morse Blvd near Hacienda Hills Country Club will be temporarily closed and traffic will be routed west onto Morse Blvd. Portions of the surrounding multi-modal path will be temporarily closed and traffic will be routed to Morse Blvd as well.**

There will be NO disruption to mail delivery. Any mail remaining in the current location will be moved to the temporary Postal Facility. **The hours of operation for collecting your mail at the temporary Postal Facility are Monday – Saturday from 12 PM to 6 PM.**

As part of the District's continued commitment to provide our residents with efficient and dependable utility service, the Sanitary Sewer Lining project for Unit 01 located within the Lake County portion of The Villages will commence Thursday, December 15, 2022. Sewer lining is performed in-place and essentially results in a new pipe being installed inside of the existing pipe with no reduction of capacity. The rehabilitation of the system will improve the sewer system and reduce the potential for leaks.

**This project will temporarily impact approximately 87 homes along Aloha Way, Vermont Avenue, Paradise Drive and Owen Drive. All construction is anticipated to be completed within two (2) weeks, ending around January 3, 2023.**



While a specific section of sewer pipeline is being lined, the affected residents' sewer connections will be out of service. The contractor will perform work during normal business hours. We ask that affected residents minimize their water use during these hours and please DO NOT shower, bathe, use dishwashers or washing machines during this time. We also ask that affected residents keep all toilet flushing to an absolute minimum. Service will likely be restored within 4 – 8 hours or by end of each day. All affected residents will receive at least 24-hour notice of their scheduled outage via door hangers.

The safety of our residents and construction personnel is of the utmost importance. We are requesting everyone to abide by all barricades and warning signs and to avoid the active construction areas for anything other than access to your property. ### **District Property Management Tunnel Painting Project Update and Scheduled Closures — Updated 12/15/2022**

Over the past two years, District Property Management has been working to complete The Villages Tunnel Painting Project and so far, 26 out of the 34 tunnels have been completed. This project was conceived and developed by the Infrastructure Division of District Property Management with the intention to emit brighter lighting during the daytime hours. The specialty paint which is utilized provides significantly better visibility, improves safety, has outstanding durability and is highly resistant to staining and weathering.

Resident feedback on the tunnels that have been completed thus far has been extremely positive — the tunnels are brighter, safer and look much better overall.



District Property Management is now working to complete the tunnel painting of the 8 remaining tunnels. They have all been pressure washed, dried, and prepared for paint application. Labor shortages have greatly impacted our contractor's ability to perform these during nighttime hours and we have agreed to allow them to paint them during the day to complete this project over the next two weeks.

Each tunnel will be closed for approximately 12 hours to allow for paint application and adequate drying time. The contractor will provide signage and re-direct golf car traffic around the tunnel to alternate routes. We apologize for any inconvenience, but we have determined this to be the best approach in getting this much-needed project completed promptly.

### **Villa Road Underdrain Construction Information - 12/8/2022**

Underdrains are being installed underneath roadways at Soulliere, Atwood, Belle Glade, and Callahan Villas for the purpose of extending the lifetime of the road pavement. The underdrains will serve to move moisture from underneath the road base and route water into the existing stormwater drainage system. The installation process involves saw-cutting a 2-foot-wide trench down the center of the roadway. Existing material will be removed for installation of filter fabric and 3 inches of #57 limerock gravel, which will be placed in the trench. The underdrain pipe will be installed in the trench and encased with #57 limerock and filter fabric. The road base will be replaced up to the grade of the existing asphalt. The trench can then be safely driven on until the road is repaved.

### **Villa Road Underdrain Construction Information - 12/8/2022**

Milling and resurfacing will be performed in the same sequence as the underdrain installation. Dates may be adjusted due to unforeseen circumstances such as inclement weather or asphalt material shortage. Everything possible will be done to minimize your inconvenience.

Please do NOT run your irrigation or wash your vehicle while construction is performed on your roadway as it will increase the work time. Newly paved roadways will take approximately one hour to cure and should NOT be driven on while hot. Driving before this time could result in tracking asphalt onto your driveway and damaging the new roadway.

For the safety of our crews and all residents, we ask that you reschedule any work or deliveries to your residence until the underdrain installation (or the paving to follow after underdrain installation) is complete, as they may be denied access. Only residents and emergency vehicles will have immediate access during the construction. All vehicles and trailers must be parked off of the roads and the overflow parking areas must be empty, as to not impede the work. When traveling through the construction, please drive slowly and watch for and listen to directions provided by the construction workers.

Please be aware that in some cases, residents have installed decorative curbing, pavers, landscape, and other features within the District road right-of-way area or decorative curbing over the top of the asphalt. While our contractor is diligent in performing operations and will take all precautions to protect your property, these improvements which are in the road right-of-way areas or encroaching into the street are subject to damage or destruction without compensation to the resident. Residents may wish to remove items from the road right-of-way areas in advance of repaving to mitigate the potential for damage. The District will not make repairs, restoration or restitution for items within the road right-of-way that are inadvertently damaged during construction.

Our goal is to give you a new road that will last a maximum lifespan, with the least amount of inconvenience. Your cooperation is greatly appreciated. For additional information, please contact District Property Management at 352-753-4022.

### **Did you know there are flagpole guidelines when installing a pole on your property?**

The flagpole guidelines within the community are as follows:

- Displaying a portable flag mounted on a home does not require architectural approval.
- A flagpole requires prior written approval by the Architectural Review Committee to confirm it is not being installed within any easement area and does not exceed twenty-two (22) feet in height.



**Flagpole requires prior Architectural Review Committee approval.**

**Portable flag mounted on the home does not require prior Architectural Review Committee approval.**

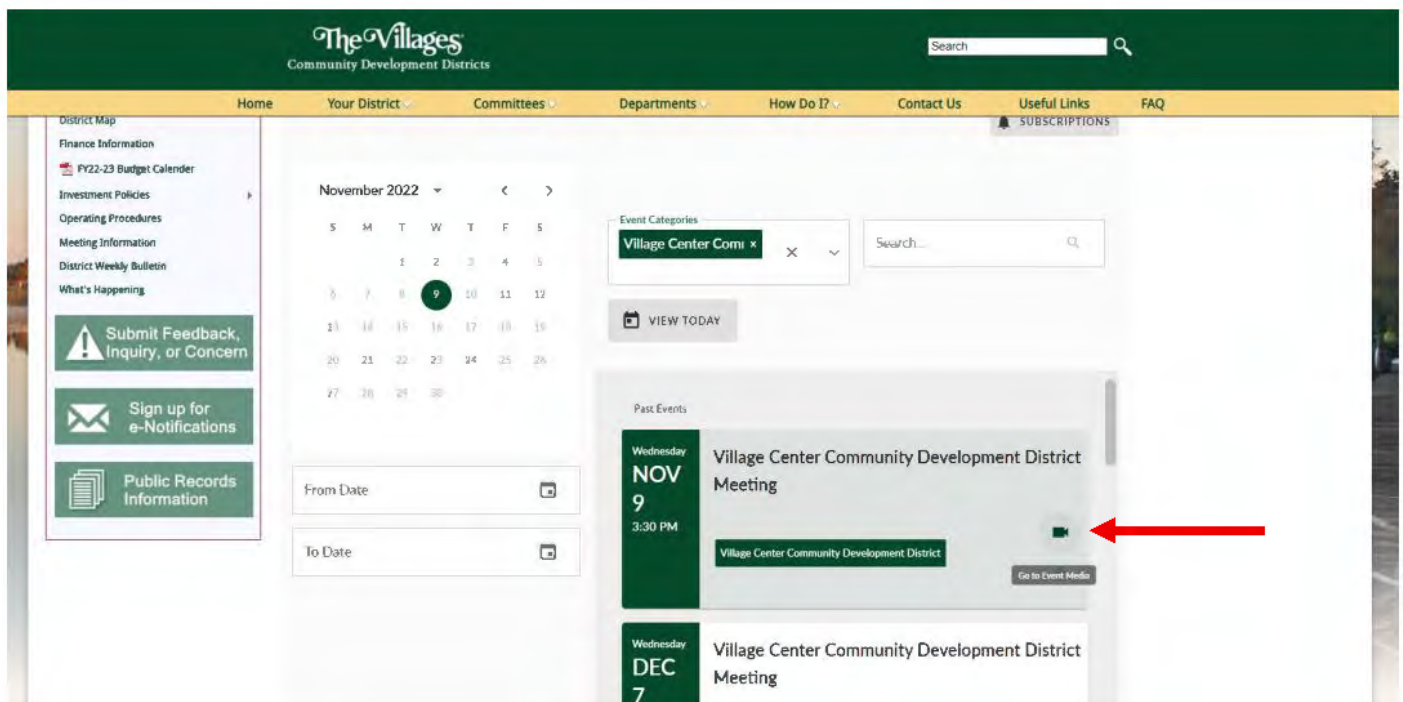
# Did You Know??

### **Please Clean Up After Your Pets**

Pet owners should always pick up after their pets and dispose of pet waste in your household trash or in a designated container. Pet waste should not be left on the ground and should never be put into storm drains, roads or waterbodies.

When it rains, pet waste can flow into storm drains and into roads. Eventually the waste ends up in our waterbodies causing water pollution. The waste also causes excess nutrients which creates algae bloom and decreases oxygen in the water. This condition has an adverse effect on fish and other aquatic life. If not disposed of properly, pet waste not only affects water quality, but public health. The bacteria found in pet waste are very harmful and can make people ill. Public beaches are closed when bacteria found in the water makes swimming unsafe.

### **What You Can Do:**

- Always clean up after your animals.
- Use bags or scoopers to pick up waste.
- Dispose of waste in pet waste containers or in your household trash.
- Do not put pet waste into storm drains or on the road.
- When traveling, carry extra bags in the car to have on hand to clean up after your pet.
- Remind other pet owners to pick up after their pet.

## Did You Know??

Another one of the services that Community Watch provides, each day and night, is locating broken sprinkler heads. Patrol Drivers, while in the course of their duties each shift, will notice a broken sprinkler head. Whether on District property or on private property, the driver will mark the broken sprinkler with a flag to indicate where that sprinkler is, even when the water is off. The driver will then call the location of the sprinkler into Dispatch and will note whether the sprinkler is on District or private property. Dispatch will then write up a work order if the sprinkler is on District property.

If the sprinkler is on private property, Dispatch will search for the homeowner's information and contact the homeowner to inform them of the broken sprinkler head. Dispatch will then explain to them exactly where on the property it is located and will inform them of the blue flag indicating the broken sprinkler. Most often the homeowner does not realize the sprinkler head is broken, because most sprinklers are set to go off in the very early morning hours.

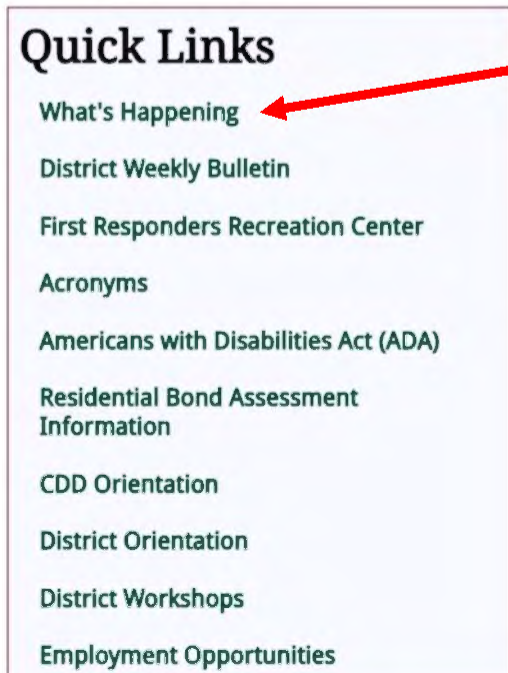

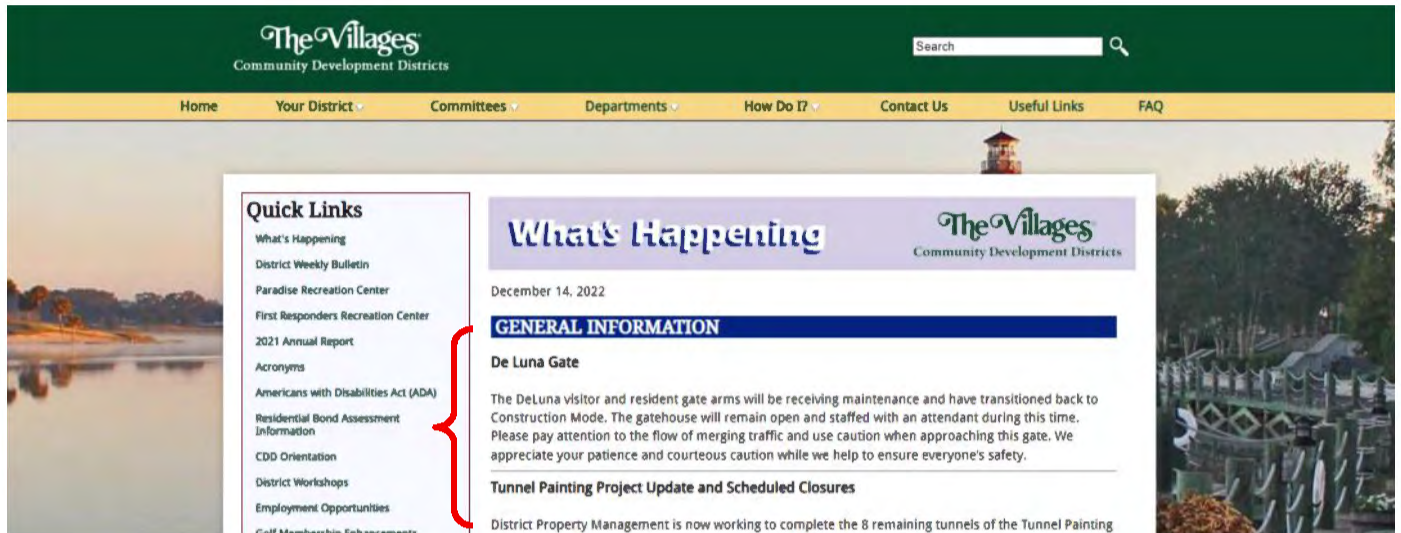

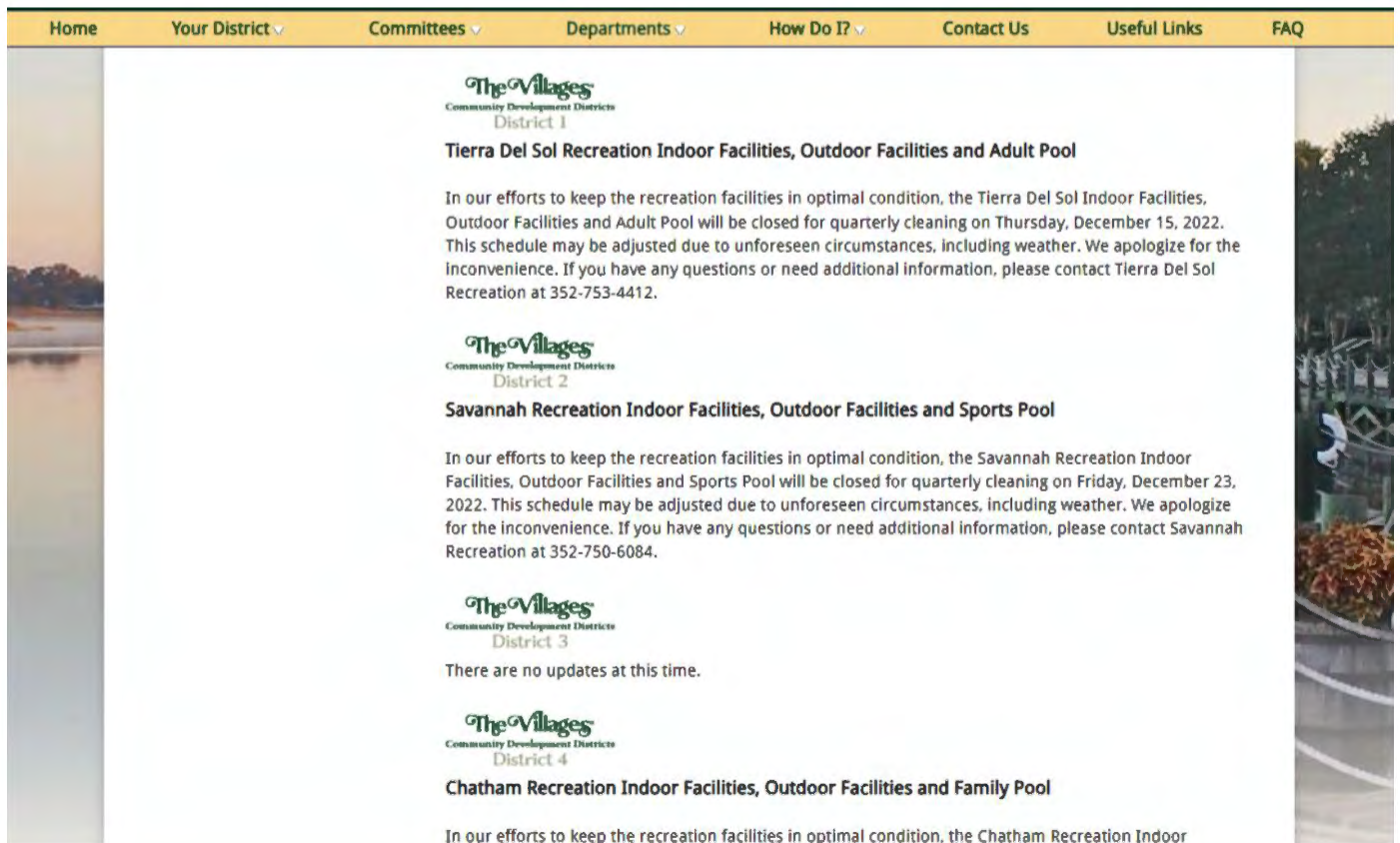

# Christmas Tree Safety



As you deck the halls this holiday season, be fire smart. A small fire that spreads to a Christmas tree can grow large very quickly.



## PICKING THE TREE

- Choose a tree with fresh, green needles that do not fall off when touched.



## PLACING THE TREE

- Before placing the tree in the stand, cut 2" from the base of the trunk.
- Make sure the tree is at least three feet away from any heat source, like fireplaces, radiators, candles, heat vents or lights.
- Make sure the tree is not blocking an exit.
- Add water to the tree stand. Be sure to add water daily.



## LIGHTING THE TREE

- Use lights that are listed by a qualified testing laboratory. Some lights are only for indoor or outdoor use.
- Replace any string of lights with worn or broken cords or loose bulb connections. Read manufacturer's instructions for number of light strands to connect.
- Never use lit candles to decorate the tree.
- Always turn off Christmas tree lights before leaving home or going to bed.



## After Christmas

Get rid of the tree after Christmas or when it is dry. Dried-out trees are a fire danger and should not be left in the home or garage, or placed outside against the home.

Check with your local community to find a recycling program.

Bring outdoor electrical lights inside after the holidays to prevent hazards and make them last longer.

## FACTS

- ! **Almost one third** of home Christmas tree fires are caused by electrical problems.
- ! Although Christmas tree fires are not common, when they do occur, they are more likely to be serious.
- ! A heat source too close to the tree causes more than **one in every five** of the fires.
