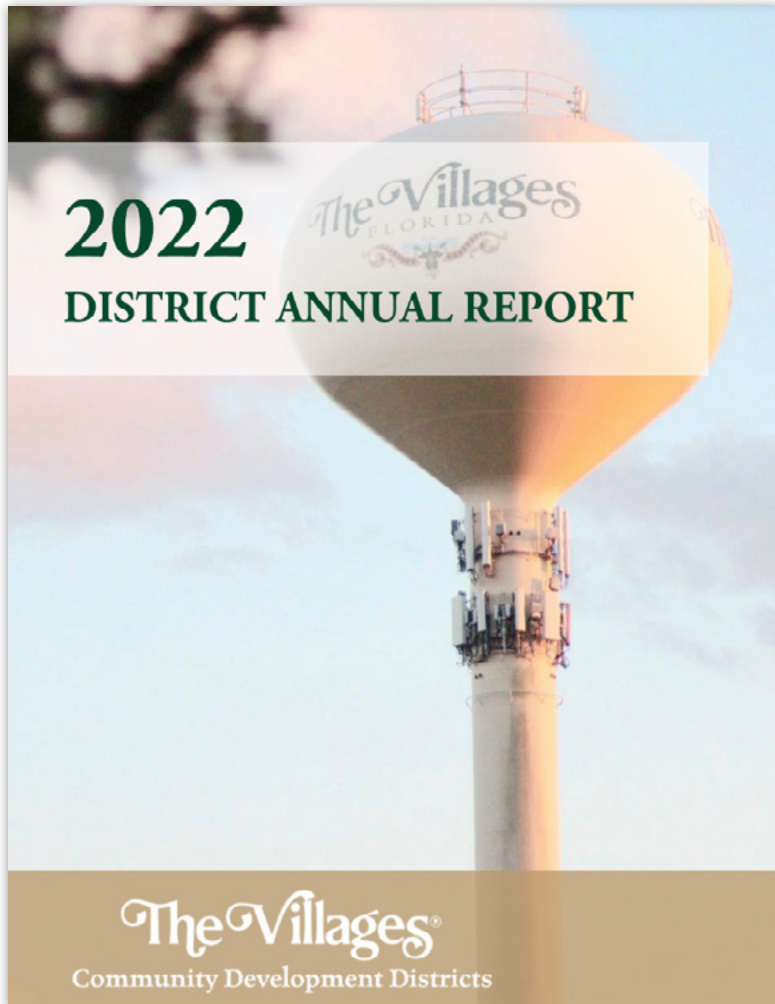

# GET THE FACTS: EXECUTIVE GOLF COURSE CONDITIONS

There is more than meets the eye when it comes to Executive Golf Course Conditions, especially around this time of year. When you see course conditions that may not align with our usual standards, rest assured that our team is working every day to maintain the Executive Golf Courses and combat the annual challenges they face such as weather conditions, lack of rain and increased traffic.

## Weather/Water Challenges

**Lack of Rain** – We have been experiencing drought conditions for the last two months with less than 3 tenths of an inch of recordable rainfall. This puts extra stress on turf conditions when only limited amounts of reclaimed irrigation water are available for golf courses.

The Executive Golf Courses are held to strict water allocations set by South West Florida Water Management District. The courses are not allowed to water more than they are allocated for during each month. Priority of areas when watering is – greens 1<sup>st</sup>,

tees and fairways 2<sup>nd</sup>, rough 3<sup>rd</sup> and property lines last.

Some of the Executive Golf courses experience high bicarbonate and pH water build-up in the irrigation lines and frequently have irrigation problems such as inoperable sprinkler heads. This makes it necessary for maintenance teams to flush out the system and inject products into the irrigation system to combat the problem. Important applications of fertilizers and pre-emergent herbicides that need watering-in can be difficult to do.



# GET THE FACTS: EXECUTIVE GOLF COURSE CONDITIONS

## Traffic/High Volumes of Players

- Annual rounds played on Executive courses: 2.5 million.
- Rounds played as of March 20, 2023: 703,089 (High season is January – May).
- High amounts of foot and cart traffic on the Executive Courses produce compacted soils which increase drainage, disease and weed pressures.

The Executive Golf Maintenance Department oversees the contractors and provides accountability and coaching on course maintenance through on-site visits, evaluations, scheduled meetings, course ride arounds, soil testing, weekly reporting and irrigation audits.

Improvement projects and corrective actions are supervised by District Staff.

## Golf Course Renovations

Revitalizing aging infrastructure: As courses reach their life expectancy or start to have negative performance, course renovations are planned and brought to amenity boards for consideration.

Renovations are using newer turf varieties that are shade, traffic and drought tolerant.



## Golf Course Maintenance

The District contracts out the maintenance of the Executive Golf Courses.



# CHURCHILL GREENS EXECUTIVE GOLF COURSE RENOVATION UPDATE

The renovation of the Churchill Greens Executive Golf Course is moving along nicely. The Bermuda grass eradication applications are complete and the bunker work has now been started. The next step in the process will be stripping off the old grass on the greens, tees and fairways.

# COURSE CLOSURES

## Palmetto Executive Golf Course Closure Notice

In our efforts to provide optimum conditions on the Executive Golf Courses, the Palmetto Executive Golf Course will be closed Friday, March 24, 2023 for several weeks to undergo necessary maintenance work. This closure will give the maintenance team time to execute cultural practices on the greens and tees such as aerification and sand topdressing to aid with drainage, relieve compaction and provide oxygen to the root zone. Additionally, the maintenance team will work on eradicating disturbing winter weeds like Poa annua grass. We thank you for your patience during this closure.

## Belmont Executive Golf Course Closure Notice

The Belmont Executive Golf Course will be closed Saturday, April 1, 2023 until further notice. This closure is part of the Project Wide Advisory Committee approved Capital Infrastructure Improvement Project. This project will consist of new greens, tees, fairways and new bunker sand. Additional landscaping and cart path improvements will take place as well during the closure. We thank you for your patience and look forward to opening the revitalized course in the fall.

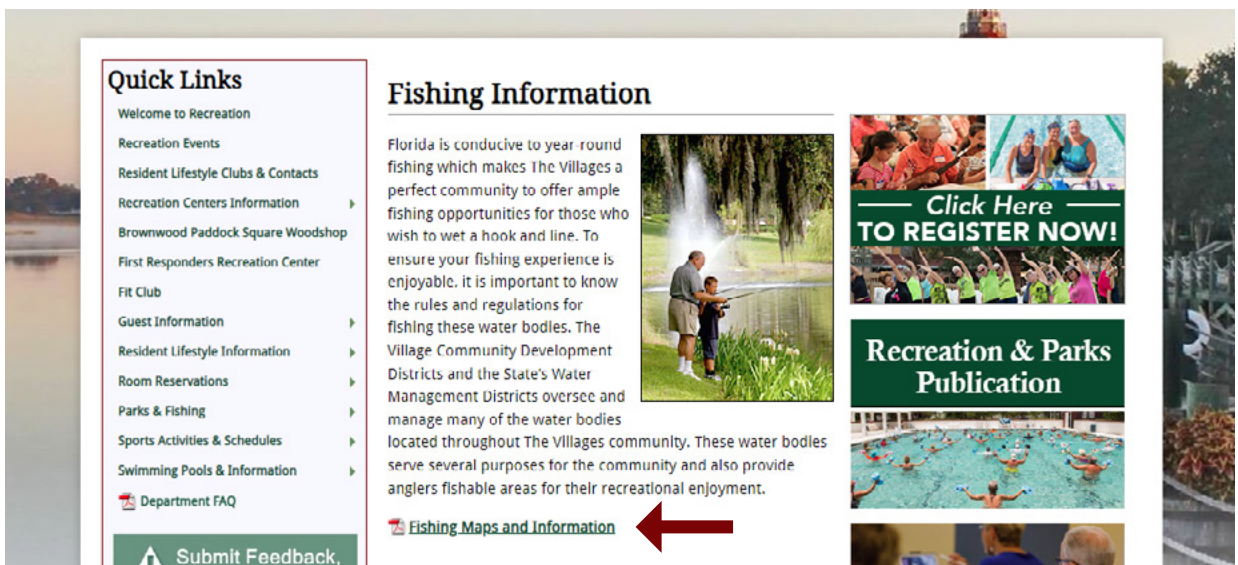

## Can I Park A Truck Or Recreational Vehicle (Rv) On The Street?



The District's Adopted Rule (Rule) for home units states: No trucks over  $\frac{3}{4}$  ton size, boats, or RV shall be parked, stored, or otherwise remain on any lot or street except for service vehicles located thereon on a temporary basis while performing a service for a resident.

### What does that mean?

If a vehicle is parked in the street and does not meet the aforementioned criteria, there would not be a violation of the Rule. However, if a resident is parking a vehicle in excess of  $\frac{3}{4}$  ton in size, a boat, or an RV in the street, it would be a violation of the Rule and the Community Standards Department would follow the process of bringing the property into compliance.

### What happens if a resident parks an RV on the street, moves the vehicle, brings it back, and then moves it again?

Each District Board has adopted their Rule to address this type of situation. The Rule states:

The term "Re-Occurring Violations" means a violation of a provision of the Rule by an owner who has been previously notified to have violated the same provision of the Rule within twelve (12) months prior to the current violation. If the Community Standards Department receives a complaint regarding a re-occurring violation, staff is not required to provide the owner a reasonable time to correct the violation. Instead, staff would send a notification of a public hearing to be held before the District Board of Supervisors within the district they reside in. The case may be presented to the Board even if the re-occurring violation has been corrected prior to the public hearing. If the re-occurring violation is brought into compliance prior to the public hearing, the Board may make a finding of guilt but shall not impose a fine.

# Irrigation Schedules

## In The Villages



Residents in the Sumter, Marion and Fruitland Park portions of The Villages must comply with the SWFWMD's year-round conservation measures.

The year-round conservation measures allow for twice-per-week watering, which gives residents additional flexibility in determining when to water. Residents are encouraged to water only if their

lawn and landscape needs it and turn off their irrigation system if it has rained or if rain is predicted in the next 24 hours. Some of the signs that a lawn needs water include blades folded in half lengthwise, footprints remaining on the lawn for several minutes after walking on it, and the top few inches of soil being dry.

# Parking Information



## Did you know Wildwood has a parking ordinance?

Wildwood's O2020-13 was approved and enacted in February 2020 to provide consistency with Sumter County and The Villages® parking regulations.

In addition to restricting parking in specific locations such as sidewalks, crosswalks, railroad tracks, etc., the ordinance **prohibits parking “in or on any city road, street, or right-of-way within the boundaries of the City of Wildwood, Florida.”**

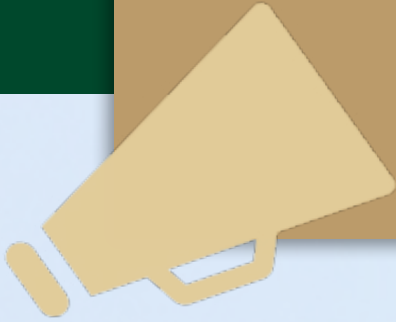
