Swimming Pool Information

The Recreation & Parks Department strives to make the pools safe for everyone's use and enjoyment. The neighborhood adult pools are intended for refreshing socialization and non-organized/scheduled activities. Regularly scheduled water exercise groups are encouraged to use the sports pool for this purpose (residents only) and the family pools are for residents and their guests 30 years of age and younger. Remember the following guidelines when visiting any of The Villages' swimming pools.

- Learn the rules and guidelines for each one of our recreation, sports and family pools.
- Pools and outdoor facilities close at dusk (30 minutes after sunset).
- In the event of an emergency, call 911.
- Please follow all posted pool hours, rules and regulations.
- Noodles, goggles, unbreakable masks and small plastic buckets are the only items allowed in the pool.
- If a staff member is on-site, please check in with them. Please have your Villages ID or guest ID and photo ID with you at all times.

Living With Florida Wildlife

Florida is home to an amazing array of wildlife many of which are protected by Federal or State laws and regulations. From birds and fish to reptiles, Florida has it all. Florida's wildlife and human populations are encountering each other more often than ever before. As people develop more open space and wildlife habitat is reduced and fragmented, conditions are often created that force wildlife and human interactions. Such contact between people and wildlife can result in conflicts if you aren't careful.

Help keep wildlife wild and healthy. Wildlife Services encourages you to avoid feeding wildlife such as ducks, geese, gulls, snakes and alligators. One way you can help reduce wildlife conflicts with people is by not feeding wildlife near human populations and in parks.

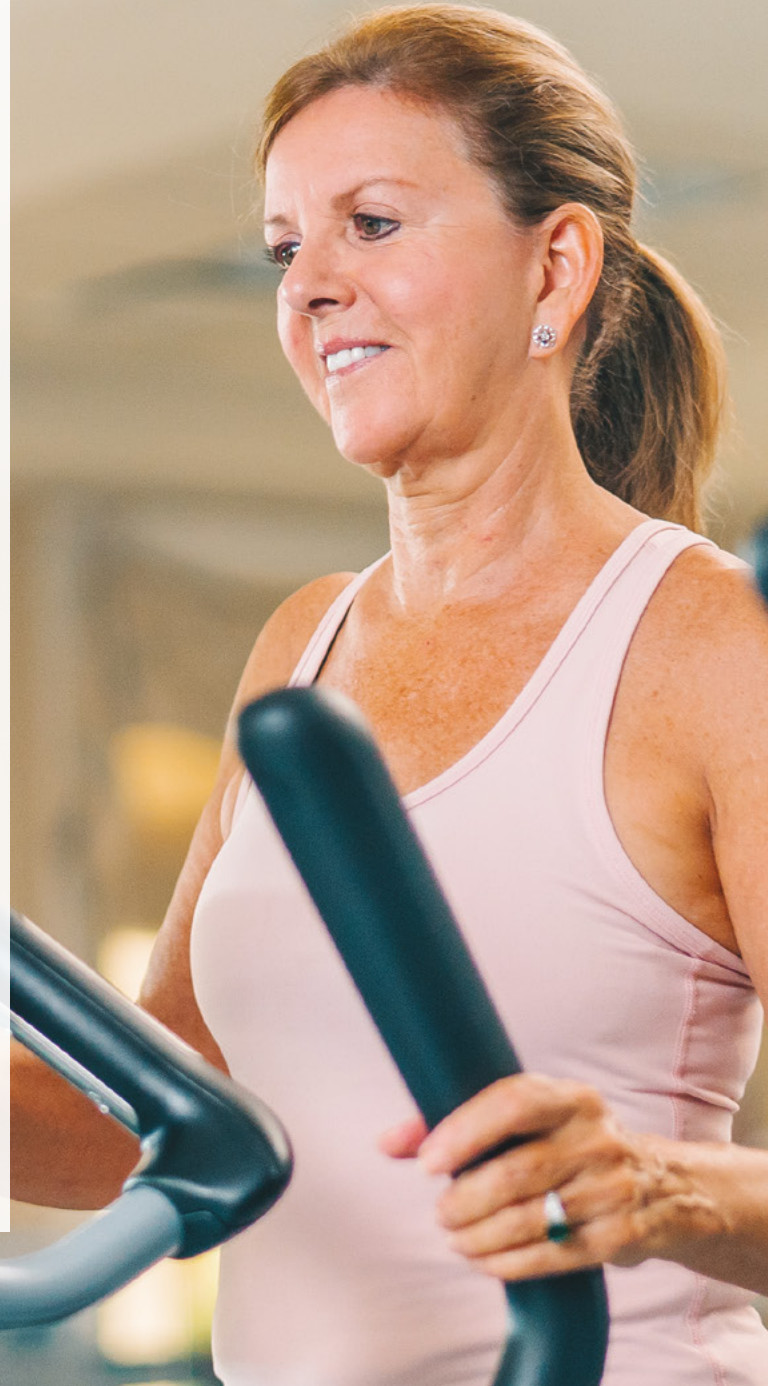

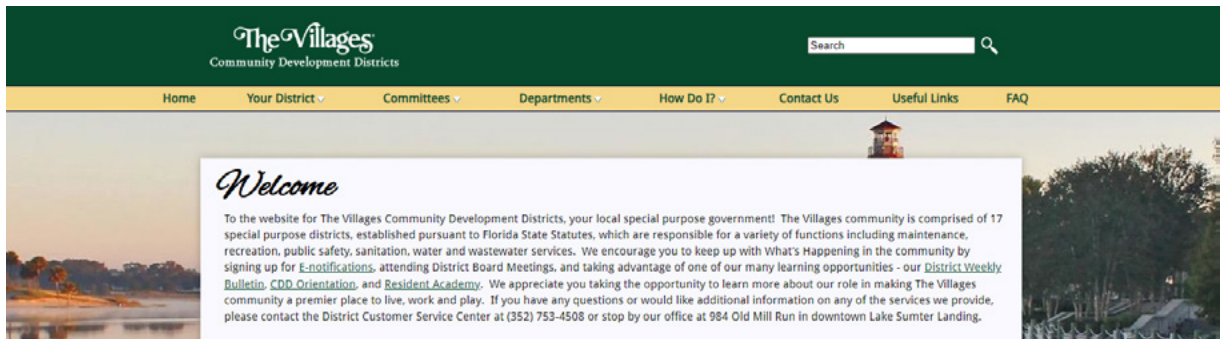

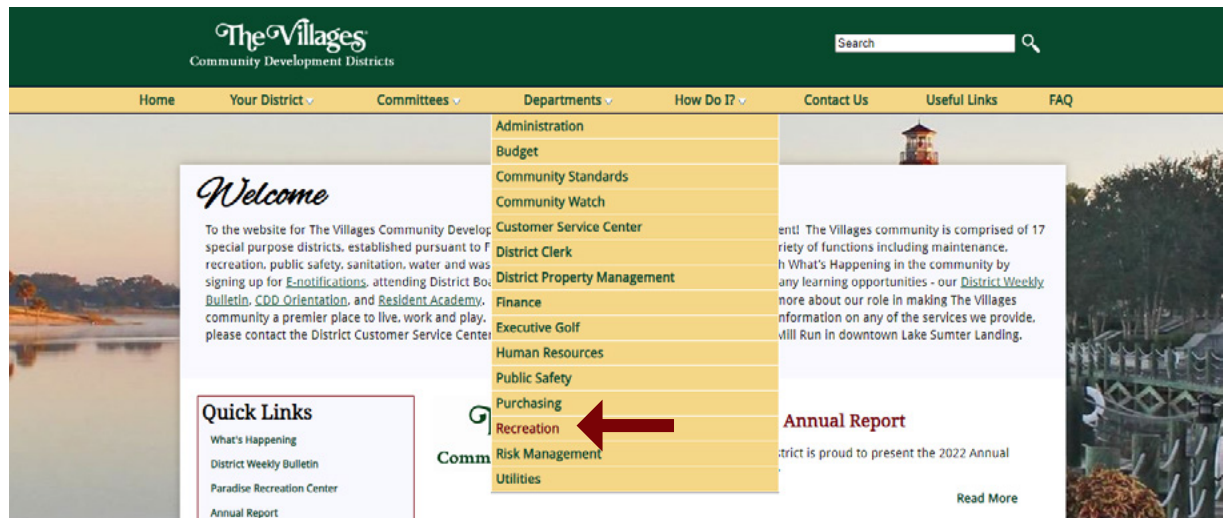
Where can I find information on fishing in The Villages?

Florida is conducive to year-round fishing which makes The Villages a perfect community to offer ample fishing opportunities for those who wish to wet a hook and line. To ensure your fishing experience is enjoyable, it is important to know the rules and regulations for fishing these water bodies. The Village Community Development Districts and the State's Water Management Districts oversee and manage many of the water bodies located throughout The Villages community. These water bodies serve several purposes for the community and also provide anglers with fishable areas for their recreational enjoyment. 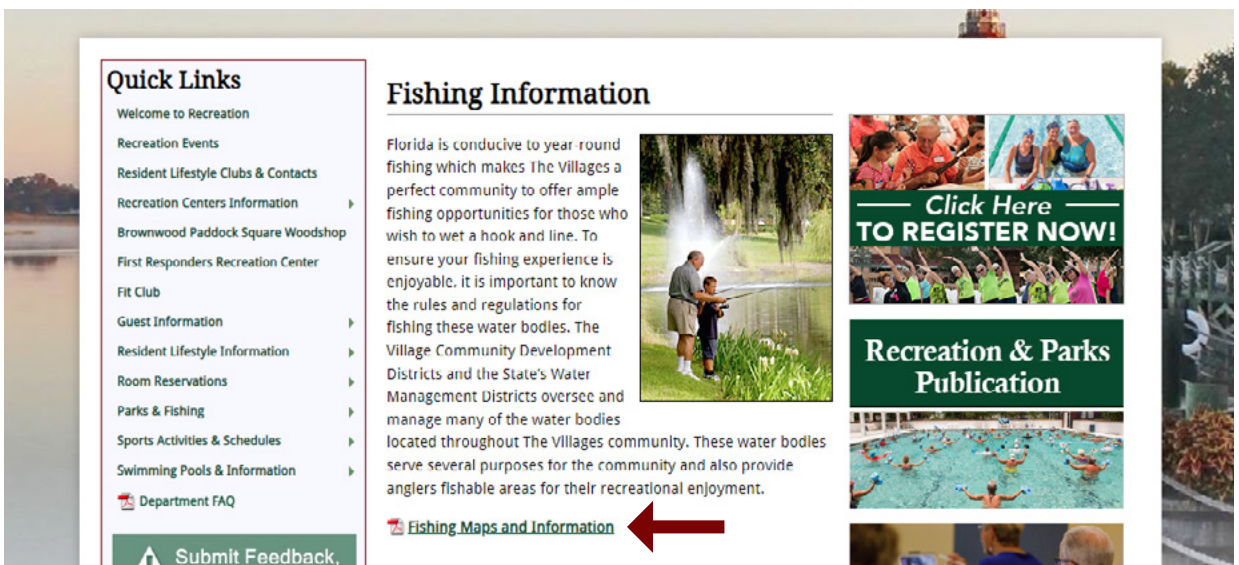

Tree Trimming on the Executive Golf Courses



June is finally here, which means that summer is upon us in The Villages Community. This also means that hurricane season has officially started. With hurricane season beginning and the potential for storms and severe weather any time now, residents are hard at work getting their trees trimmed ahead of potentially dangerous winds.

To ensure the landscape of the Executive Golf Courses remains in optimal condition, we would like to remind all who enjoy the courses or who reside on an Executive Golf Course to follow proper tree trimming guidelines.

While it is a good idea to be prepared, please make sure that any tree branches being trimmed belong to you and are not on private property. Residents who live on a golf course are likely to have trees

around and behind their home that may be on an Executive Golf Course. Trees on golf courses are private property and should not be trimmed by anyone other than the maintenance contractors. If you are having any tree work done, please keep all trimming within the boundaries of your property. If you or your contractor would like to use the golf course as access, please contact the Executive Golf Maintenance Department by email at ExecutiveGolfMaintenance@districtgov.org or by phone at 352-674-1885 to let us know so we can make those arrangements.

Did You Know?

Did you know that many of the water retention areas in our community are connected through various inlets and pipes?

In addition to stormwater, everything that enters the stormwater pipes can end up in the water retention areas throughout our community. This includes trash, leaves, fertilizer, soap from washing vehicles, animal droppings and more.

Please help us ensure the health and continued maintenance of the water retention basins throughout The Villages by not placing ANYTHING in any of the stormwater drains. Our National Pollutant Discharge Elimination System permit does not allow dumping into these storm drain systems. If you see anything being placed in stormwater drains, contact District Property Management at 352-753-4022.

Lithium-Ion Battery Safety



Lithium-ion batteries supply power to many kinds of devices including smart phones, laptops, e-scooters and e-bikes, e-cigarettes, smoke alarms, toys, and even cars. If not used correctly, or if damaged, these batteries can catch on fire or explode.

The problem

- These batteries store a large amount of energy in a small amount of space.
- Sometimes batteries are not used the right way; batteries not designed for a specific use can be dangerous.
- Like any product, a small number of these batteries are defective. They can overheat, catch fire, or explode.

Safety Tips

- Purchase and use devices that are listed by a qualified testing laboratory.
- Always follow the manufacturer's instructions.
- Only use the battery that is designed for the device.
- Put batteries in the device the right way.
- Only use the charging cord that came with the device.
- Do not charge a device under your pillow, on your bed, or on a couch.
- Do not keep charging the device or device battery after it is fully charged.
- Keep batteries at room temperature when possible. Do not charge them at temperatures below 32°F (0°C) or above 105°F (40°C).
- Store batteries away from anything that can catch fire.

Signs of a Problem

Stop using the battery if you notice these problems: odor, change in color, too much heat, change in shape, leaking, or odd noises. If it is safe to do so, move the device away from anything that can catch fire. Call **9-1-1**.

Battery Disposal

- Do not put lithium-ion batteries in the trash.
- Recycling is always the best option.
- Take them to a battery recycling location or contact your community for disposal instructions.
- Do not put discarded batteries in piles.

Charging an E-bike

Charge your battery in a flat, dry area away from children, direct sunlight, liquids, tripping hazards, and in a location where the e-bike is not at risk of falling.

Driveways and Rights Of Way

Information Provided By...



Easements and rights-of-way refer to areas of property that utilities have permission to use. These are usually located in and along streets and roadways and are necessary for ongoing utility maintenance.

Residents who choose to enhance their driveways with improvements such as brick pavers or painting that encroach on the right of way, should be aware that the Utility is not responsible for any

damage, loss or costs incurred should it be necessary to remove sections of the driveway for repairs or maintenance to the water or wastewater utility system. The Utility will restore the driveway to the original finish only.

IRRIGATION SYSTEM FLUSHING: DISTRICTS 5-8

In April 2023, our Utilities Operations and Maintenance contractor (Jacobs) began flushing the Villages Water Conservation Authority (VWCA) irrigation system located in Districts 5-8. Flushing prevents the accumulation of small particles and build-up, which can lead to plugging issues in our irrigation system. Due to the size of the VWCA system, the area has been divided into 90 distinct flushing zones. Once started, this project will take approximately 50 weeks to work through all 90 zones.



As the flushing takes place, you will see the Jacobs team opening fire hydrants and flushing irrigation lines only into the roadway. Work hours will be from 8 am to 5 pm. Information will be updated regularly on the District's website on when you can expect to see the Jacobs team in action in your area. Please continue to check the Weekly Bulletin or the [What's Happening](#) page on [DistrictGov.org](#) for updates.

This maintenance work will not have any effects on your drinking water quality nor pressure. This is a proactive effort to maintain your irrigation system.

The safety of residents and contractor personnel is of the utmost importance. We are requesting everyone to abide by all barricades and warning signs and to avoid the active work area for anything other than access to your property.

For the safety and quality assurance of residents, guests and workers, please adhere to the following requests:

- Reschedule any work or deliveries to your Villa until the paving is complete as they may be denied access. Only residents and emergency vehicles will have immediate access during the construction.
- PLEASE DO NOT run your irrigation, wash your vehicle or empty your pool during the week, as it will increase the work time.
- ALL vehicles and trailers must be parked OFF of the roads and the overflow parking areas must be empty, so as to not impede the work.
- Please be advised that newly paved roadways will take approximately one hour to cure and should not be driven on while hot! Driving before this time could result in tracking asphalt onto your driveway and damaging the new roadway.
- If you must travel through the construction, PLEASE drive slowly and watch for and listen to directions provided by the contract workers.

Our goal is to give you a new road that will endure its maximum life with the least amount of inconvenience. Your cooperation is greatly appreciated. 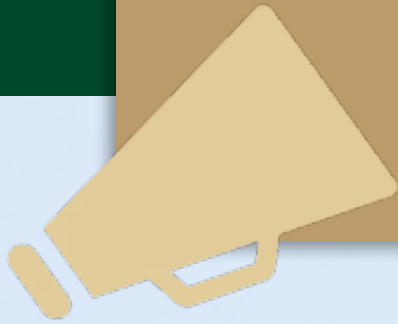
