Golf Car Safety Guidelines IN THE VILLAGES

In a community like The Villages, it's important to know the rules of the road when it comes to golf cars. A golf car is defined as a vehicle that is designed for operation on a golf course or for sport or recreation activities. Golf cars and low-speed vehicles must follow the same traffic laws as cars, including regulatory signs and the use of directional (or hand) signals while making turns. Operators of these vehicles can be issued traffic citations just like if they were driving an automobile, and these citations carry fines along with adding points to your driver's license.

A street-legal, low-speed vehicle is defined as a four-wheel electric vehicle whose top speed is greater than 20 mph, but less than 25 mph. A golf car must not be capable of exceeding 20 mph. Street-legal, low-speed vehicles may operate on streets where the posted limit is 35 mph or less. These vehicles may also cross roads that have a speed limit greater than 35 mph.

To operate at night or before sunrise, golf cars must be equipped with:

• Headlights & brake lights

- Turn signals
- Windshield
- Red reflective warning devices on the front and rear of the vehicle

Headlights should always be used 30 minutes before sunset and 30 minutes after sunrise. Headlights should also be used during inclement weather.

Be Safe

- Do not let anyone ride standing in the vehicle or on the back platform.
- Children should not be sitting on the driver's lap and should never be steering the vehicle.
- Passengers should keep their arms and legs inside the vehicle at all times (except for the driver when signaling a turn).
- Golf cars should yield to other vehicular traffic in all cases.
- Don't text/call while driving.
- Golf cars and other low-speed vehicles aren't permitted to travel on sidewalks.

IN THE VILLAGES

To be street legal, vehicles must have:

- Registered license plate & insurance
- Seat belts
- Windshield
- Rearview mirror
- Horn
- Headlights, taillights & brake lights
- Side reflectors
- Parking brake
- Turn signals
- VIN number

Know The Rules

- Golf car drivers must possess a valid form of government-issued photographic identification.
- Drivers under 18 years of age must possess a valid driver's license or learner's driver's license.
- Golf cars may not cross or drive on CR 466/466A, Hwy 27/441 or any other road with a posted speed limit of 35 mph and above.
- FDOT/State roads only allow crossings of golf carts. Golf cars are NOT allowed on state roads.
- Golf cars are not allowed on

County roads unless approved for neighborhoods by the County.

- Golf cars must use the transportation multi-modal paths adjacent to El Camino Real, Buena Vista Blvd, Morse Blvd, CR 466 and CR 466A.
- Golf cars can drive on streets in The Villages with a posted speed limit of 30 mph or less. Golf cars should be driven in the marked diamond lanes or along the righthand edge of the street if there is not a marked lane.

This information aims to promote and encourage golf car safety in The Villages. Following these rules of the road and safety tips will help ensure a safe and enjoyable experience for everyone traveling on the multi-modal paths and roadways in a golf car.

Sanitation Collection Guidelines

For residents living in Village Community Development Districts 1-11:

- All Household Solid Waste and Yard Waste is picked up twice a week—same time, same truck, all together!
- All household waste should be placed in sealed tall kitchen trash bags or 20-30 gallon trash bags (any color with the exception of red, which is used for medical waste).
- All materials can be placed in the same bag, no need to sort!
- The trash bags should be left at the end of your driveway, no garbage cans are allowed (they will be disposed of with the household waste).
- Each bag should weigh no more than forty (40) pounds.
- Bags must be placed for collection before 6:00 a.m. on your collection day or the night before (no sooner than 5:00 p.m.).
- Wrap broken glass or other sharp objects in newspaper and place them where they cannot cause injury.



• Limbs & branches should be bundled and tied and may not exceed 5" in diameter, 5' in length or exceed 40 pounds.

- Stay in the kitchen when you are cooking on the stovetop so you can keep an eye on the food.

- Keep children away from the stove. The stove will be hot and kids should stay 3 feet away.

- Keep knives out of the reach of children.
- Be sure electric cords from an electric knife, coffee maker, plate warmer or mixer are not dangling off the counter within easy reach of a child.
- Keep matches and utility lighters out of the reach of children up high in a locked cabinet.
- Never leave children alone in room with a lit candle.
- Make sure your smoke alarms are working. Test them by pushing the test button.


Project Description

The historic Moving Florida Forward Infrastructure Initiative (fdot.gov/movingfloridaforward) is allowing the Florida Department of Transportation (FDOT) to advance much-needed improvements to Interstate 75 (I-75) in Central Florida, with construction anticipated to begin in spring 2025.

The I-75 Improvements projects are located between State Road (S.R.) 44 in Sumter County and S.R. 326 in Marion County, covering approximately 30 miles. The improvements include the addition of an auxiliary lane in each direction and interchange improvements at S.R. 326 and S.R. 40.

An auxiliary lane is an extra lane connecting the on and off ramps between two consecutive interchanges that reduces congestion by giving drivers more space and time to merge safely.

The I-75 improvements are currently being evaluated under two separate Project Development and Environment (PD&E) studies. I-75 South begins south of S.R. 44 and ends at S.R. 200. I-75 North begins at S.R. 200 and ends at S.R. 326.

Wildwood Completes Additional Stabilization of Scardino Street

Roadway Rehabilitation to Begin after Thanksgiving

Additional stabilization of the public right-of-way on Scardino Street in The Villages[®] section of Wildwood has been completed following a series of supplemental concrete grout injections.

A series of initial injections were made in September after a ground depression was reported in August. A second depression was then reported north of the stabilized area.

Geotechnical engineers performed tests, analyzed results, and recommended another series of grout injections at 21 new sites, which were completed Nov. 10. City officials are awaiting the geotechnical report providing clearance of those repairs.

Work to begin rehabilitation of the roadway, including repair of utility infrastructure damaged during the collapse, is scheduled to begin Nov. 27, 2023, after Thanksgiving weekend. During that work, up to 12 homes on Scardino Street will need to be disconnected from sanitary sewer lines to allow for reconstruction. Affected residents will be temporarily relocated until service is restored.

City staff notified residents and met with them in person last week to discuss the arrangements with a local hospitality provider. Residents provided feedback and the city developed details of the temporary relocation based on that input.

"We have maintained two-way communication with residents throughout this process, and taken their concerns to heart," said Public Works Director Jeremy Hockenbury. "We opted to start the next phase of repairs after Thanksgiving to allow residents to enjoy the holidays at home with their families. We now look forward to expediting the road and utility work to the greatest extent possible while making sure it also meets the highest safety, quality, and engineering standards."

Access to the affected area of roadway remains restricted to residents and authorized personnel.

Road Closure

District Property Management will be performing restoration for a stormwater pipe that will require a closure of the westbound golf cart lane on Bichara Boulevard northwest of the intersection of US 441 and Bichara Blvd near the Wendy's restaurant. Golf carts will be merged temporarily into automobile traffic before returning to the golf cart lane. The closure will begin Friday, October 6, 2023 and will continue indefinitely until stormwater restoration is completed as soon as possible. Please pay attention to the flow of traffic and use caution when approaching the lane merge. We appreciate your patience as we strive to provide the best service possible and ensure the District's assets are preserved for our community. Saddlebrook Multi-Modal Path Closure

District Property Management will be performing asphalt repairs along the multimodal path between the south side of Saddlebrook Recreation Center to the north side of Tunnel B10 (under 466A). The multi-modal path will be blocked off and a detour will be visibly marked - <u>click here to view a map of the detour route</u>. The detour will run along the concrete pathway of the Saddlebrook Executive Golf Course. The work is tentatively scheduled below:

IRRIGATION SYSTEM FLUSHING: DISTRICTS 5-8

The Villages Community Development Districts Utilities

In April 2023, our Utilities Operations and Maintenance contractor (Jacobs) began flushing the Villages Water Conservation Authority (VWCA) irrigation system located in Districts 5-8. Flushing prevents the accumulation of small particles and build-up, which can lead to plugging issues in our irrigation system. Due to the size of the VWCA system, the area has been divided into 90 distinct flushing zones. Once started, this project will take approximately 50 weeks to work through all 90 zones.



As the flushing takes place, you will see the Jacobs team opening fire hydrants and flushing irrigation lines only into the roadway. Work hours will be from 8 am to 5 pm. Information will be updated regularly on the District's website on when you can expect to see the Jacobs team in action in your area. Please continue to check the Weekly Bulletin or the <u>What's Happening</u> page on <u>DistrictGov.org</u> for updates.

This maintenance work will not have any effects on your drinking water quality nor pressure. This is a proactive effort to maintain your irrigation system.

The safety of residents and contractor personnel is of the utmost importance. We are requesting everyone to abide by all barricades and warning signs and to avoid the active work area for anything other than access to your property.
