New Year's Holiday Sanitation Information

Districts 1-11

If you live in Village Community Development Districts 1-11 in the Sumter County, Marion County or Fruitland Park portions of The Villages, there will be no sanitation collection on Monday, January 1, 2024. Collection will be on Thursday, January 4, 2024.

District 12 and the Villages of DeLuna and Hammock at Fenney

If you live in District 12 or the Villages of DeLuna and Hammock at Fenney there will be no changes to the sanitation collection schedule.

District 13 (excluding Villages of DeLuna & Hammock at Fenney) or District 14

If you live in District 13 (excluding the Villages of DeLuna and Hammock at Fenney) and District 14, there will be no sanitation collection on Monday, January 1, 2024. Collection will be on Thursday, January 4, 2024.

If you live in the **unincorporated Lake County portion of The Villages (not including District 11 or 14)**, Monday collection will occur on Tuesday. All collection days for the week will be moved to the following day.

If you live in the **Town of Lady Lake portion of The Villages**, there will be no sanitation collection on Monday, January 1, 2024. Collection will be on Thursday, January 4, 2024.

If you live in **Middleton Community Development District-A**, there will be no changes to the sanitation collection schedule.

Holiday Decoration Policy

If your Village plans on decorating the Gate House or Village/Villa Entry sign for any of the upcoming holidays, the District Boards have adopted a Holiday Decoration Policy. This excludes postal stations. Prior to installation, residents must submit a design application to District Property Management (DPM) and sign the Activity Release of Liability. Christmas Tree Collection



Residents of Districts 1-11

If you live in Districts 1–11 in the Sumter County, Marion County or Fruitland Park portions of The Villages, discarded live Christmas trees can be placed at the curb and will be collected with your regular household trash on your designated day. The trees must follow the procedures for yard waste. Tree limbs and branches may not exceed five (5) feet in length, five (5) inches in diameter, or exceed 40 pounds.

Artificial trees should be taken apart and placed curbside in sections and will be collected with your regular household trash on your designated day. If you have any questions please contact sanitation at 352-748-0109.

Residents of Districts 12-14 and Middleton-A:

If you live in Districts 12–14 or Middleton-A, live and artificial trees can be placed at the curb and will be collected with your regular household trash on your designated day. If you have any questions, please contact the Utilities Department at 352-750-0000.

Residents of the unincorporated Lake County portion of The Villages:

If you live in the unincorporated Lake County portion of The Villages, live trees can be placed at the curb on your assigned yard waste day and must be in 4' lengths and no more than 6" in diameter. To discard artificial trees, please call Lake County Solid Waste to schedule a bulk pick-up at 352-343-3776.

Residents of the Town of Lady Lake:

If you live in the Town of Lady Lake, live and artificial trees can be placed at the curb and will be collected with your regular household trash on your designated day. If you have any questions, please contact Waste Management at 352-787-4416.



Christmas Tree Safety



As you deck the halls this holiday season, be fire smart. A small fire that spreads to a Christmas tree can grow large very quickly.



PICKING THE TREE

- Choose a tree with fresh, green needles that do not fall off when touched.



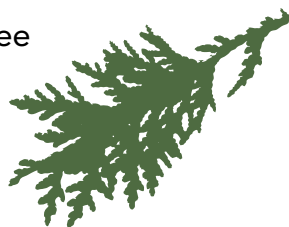
PLACING THE TREE

- Before placing the tree in the stand, cut 2" from the base of the trunk.
- Make sure the tree is at least three feet away from any heat source, like fireplaces, radiators, candles, heat vents or lights.
- Make sure the tree is not blocking an exit.
- Add water to the tree stand. Be sure to add water daily.



LIGHTING THE TREE

- Use lights that are listed by a qualified testing laboratory. Some lights are only for indoor or outdoor use.
- Replace any string of lights with worn or broken cords or loose bulb connections. Read manufacturer's instructions for number of light strands to connect.
- Never use lit candles to decorate the tree.
- Always turn off Christmas tree lights before leaving home or going to bed.



After Christmas

Get rid of the tree after Christmas or when it is dry. Dried-out trees are a fire danger and should not be left in the home or garage, or placed outside against the home.

Check with your local community to find a recycling program.

Bring outdoor electrical lights inside after the holidays to prevent hazards and make them last longer.

FACTS

- ! **Almost one third** of home Christmas tree fires are caused by electrical problems.
- ! Although Christmas tree fires are not common, when they do occur, they are more likely to be serious.
- ! A heat source too close to the tree causes more than **one in every five** of the fires.

2024 CPR Schedule



The Villages Public Safety Department has announced their Cardiopulmonary Resuscitation (CPR) schedule for 2023. Three types of classes are offered:

- Basic Life Support (BLS) Healthcare Provider offers a two-year certification card and teaches CPR and Automated External Defibrillator (AED) use for adults, children and infants.
- Family and Friends CPR/AED – In this class residents learn basic compression CPR and AED use for adults, children and infants. This class doesn't offer a certification card and it's recommended you take a refresher every two years. Due to increased popularity, an afternoon session has been added for the Friends and Family CPR.
- The Emergency Care & Safety Institute (ECSI) offers a two-year certification card and is recommended for healthcare providers. The class teaches CPR/ AED and basic First Aid for adults, children and infants.

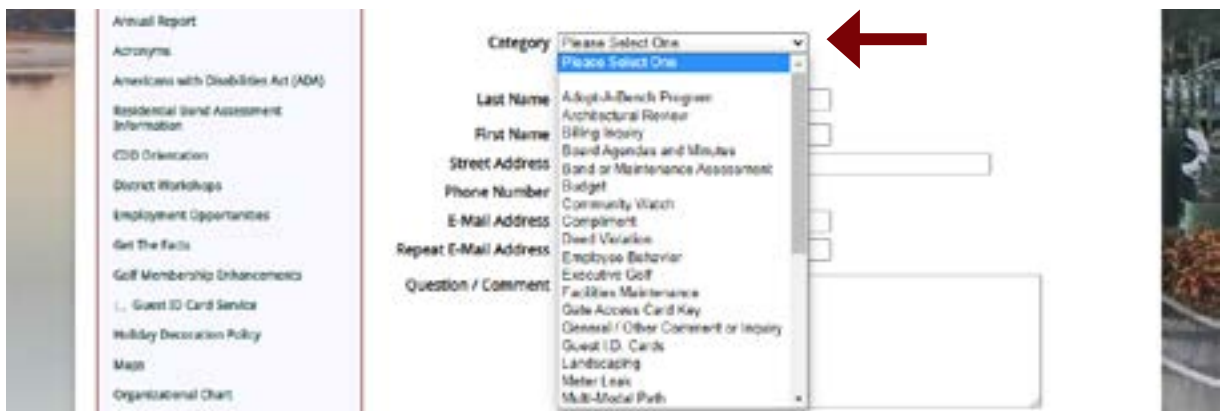

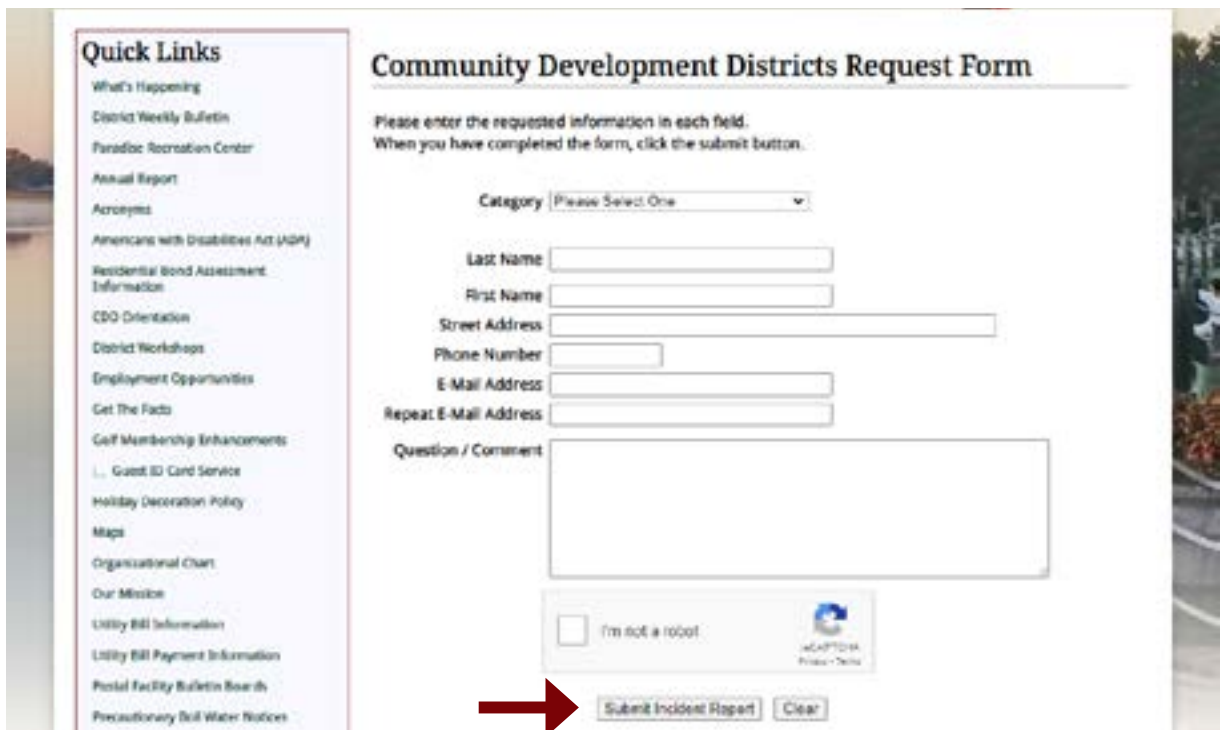

Community Watch Programs – House Check



If you will be away from your home in The Villages for seven days or more, you can arrange for Community Watch to periodically check the perimeter of your home to make sure everything is as it should be. The **Community Watch House Check Program** is a service available to all residents leaving the area for more than seven days.

Our patrol drivers will inspect the exterior only of the home on foot, three times a week. They will check for broken windows, any doors/windows that are open or unlocked and any packages/flyers/papers that were left at the front door. The cost for this program is \$6.42 a week.

Road Closure

Updated 10/9/2023

District Property Management will be performing restoration for a stormwater pipe that will require a closure of the westbound golf cart lane on Bichara Boulevard northwest of the intersection of US 441 and Bichara Blvd near the Wendy's restaurant. Golf carts will be merged temporarily into automobile traffic before returning to the golf cart lane. The closure will begin Friday, October 6, 2023 and will continue indefinitely until stormwater restoration is completed as soon as possible. Please pay attention to the flow of traffic and use caution when approaching the lane merge. We appreciate your patience as we strive to provide the best service possible and ensure the District's assets are preserved for our community. Current Executive Golf Course Closures

IRRIGATION SYSTEM FLUSHING:

DISTRICTS 5-8

In April 2023, our Utilities Operations and Maintenance contractor (Jacobs) began flushing the Villages Water Conservation Authority (VWCA) irrigation system located in Districts 5-8. Flushing prevents the accumulation of small particles and build-up, which can lead to plugging issues in our irrigation system. Due to the size of the VWCA system, the area has been divided into 90 distinct flushing zones. Once started, this project will take approximately 50 weeks to work through all 90 zones.



As the flushing takes place, you will see the Jacobs team opening fire hydrants and flushing irrigation lines only into the roadway. Work hours will be from 8 am to 5 pm. Information will be updated regularly on the District's website on when you can expect to see the Jacobs team in action in your area. This maintenance work will not have any effects on your drinking water quality nor pressure. This is a proactive effort to maintain your irrigation system.

The safety of residents and contractor personnel is of the utmost importance. We are requesting everyone to abide by all barricades and warning signs and to avoid the active work area for anything other than access to your property.
