

The 2023 Annual Water Quality Reports detailing testing performed on the water systems during 2023, are now available! Public water systems are required to provide annual drinking water quality reports to their customers by July 1st of each year for the prior year by the U.S. Environmental Protection Agency and the Florida Department of Environmental Protection.

## Keep wipes and other products from clogging your community's sewer system

To keep wastewater systems working properly, please flush only the appropriate waste down the toilet.

### WIPES CLOG PIPES, SO REMEMBER THESE TIPS:

#### **FLUSH IT:**

Biological waste (urine, feces) and toilet paper are the only materials that should be flushed down the toilet. Toilet paper breaks down in water. Others products d not.

#### TRASH IT:

Paper towels, feminine hygiene products, wipes, and similar products must be disposed of as domestic waste and NOT flushed down the toilet.

These steps will help us keep collection and treatment systems operating properly. If there's no toilet paper and you must use something else, keep a trash bin in the bathroom to dispose of non-toilet-paper products. Clean the bin and surrounding areas regularly. Businesses should provide similar trash bins and consider posting signs reminding patrons not to flush non-toilet-paper products.

Please help us avoid unnecessary sewer clogs and backups.

If you live in Districts 1 – 11 located in Sumter County, Marion County or Fruitland Park portions of The Villages, there will be normal residential sanitation collection on Monday, May 27, 2024.

## Village Community Development District 12, the Villages of DeLuna and Hammock at Fenney, and District 15

If you live in Village Community Development District 12, the Village of DeLuna and Hammock at Fenney, and District 15, there will be no sanitation schedule change due to the holiday.

## Village Community Development District 13 (excluding Villages of DeLuna and Hammock at Fenney) and District 14

If you live in Village Community District 13 (excluding Village of DeLuna and Hammock at Fenney) and District 14, there will be no residential sanitation collection on Monday, May 27, 2024. Sanitation collection will be on Thursday, May 30, 2024.

If you live in the **Town of Lady portion of The Villages**, there will be no residential sanitation collection on Monday, May 27, 2024. Sanitation collection will be on Thursday, May 30, 2024.

If you live in the **Lake County portion of The Villages** (not including VCDD No. 11 and 14), there will be no sanitation collection on Monday, May 27, 2024. Sanitation collection will be on Tuesday, May 28, 2024. All collection days for the week will be moved to the next day.

If you live in the **Middleton Community Development District**, there will be no sanitation schedule change due to the holiday.
