### THE MORSE BLVD. REVETMENT PROJECT

### Managed by District Property Management along with the Engineering firm of Kimley Horn & Associates

The primary purpose of this project was to combat shoreline erosion around Morse Island and before the John Parker Bridge near Lake Sumter Landing. This was a crucial initiative prompted by years of erosion along the banks of Morse Island from various storms. The project scope of



work was to protect the island shoreline by strategically installing riprap, a key defense against water's erosive forces, as well as rock underlayment to provide maximum protection against storm surge and erosion.



Approved and Funded by the Project Wide Advisory Committee, the project benefited from the generous donation of riprap material by the Village's Developer, highlighting a collaborative partnership and joint effort to conserve the natural environment, maintain the infrastructure in The Villages community and reduce the overall

project cost. Riprap installation, a proven method for shoreline protection, not only stabilizes the shoreline but also reinforces it against future erosion, ensuring the long-term sustainability of the area. The project approach included clearing overgrown vegetation on the island and installing geofabric, enhancing the effectiveness and durability of the riprap solution.

The successful completion of the Morse Island revetment project, delivered within budget and ahead of schedule, reflects the efficiency and effectiveness of the entire District Staff. Despite the project's scale, minimal disruption was caused to residents, demonstrating the thorough planning and flawless execution of the project.

Looking forward, District Property Management anticipates that the installed riprap will serve as a long-term defense against erosion, safeguarding the Morse Island shoreline and preserving the area's natural beauty.

**LITHIUM-ION** 

BATTERY Safety





Lithium-ion batteries supply power to many kinds of devices including smart phones, laptops, e-scooter, ebikes, e-cigarettes, smoke alarms, toys, and even cars.

If not used properly, of if damaged, these batteries can catch on fire or explode.

### The Problem

- These batteries store a large amount of energy in a small amount of space.
- Sometimes batteries are not used the right way; batteries not designed for specific use can be dangerous.
- Like any product, a small number of these batteries are defective. They can overheat, catch fire, or explode.

### Safety tips

- Purchase and use devices that are listed by a qualified testing laboratory.
- Always follow the manufacturer's instructions.
- Only use the battery that is designed for the device.
- Put batteries in the device the right way.
- Only use the charging cord that came with the device.
- Do not charge a device under your pillow, on your bed, or on a couch.
- Do not keep charging the device or device battery after it is fully charged.
- Keep batteries at room temperature when possible. Do not charge them at temperatures below 32°F (0°C) or above 105°F (40°C).
- Store batteries away from anything that can catch fire.

### Signs of a Problem

Stop using the battery if you notice these problems: odor, change in color, too much heat, change in shape, leaking, or odd noises. If it is safe to do so, move the device away from anything that can catch fire. Call 9-1-1.

### **Battery Disposal**

- Do not put lithium-ion batteries in the trash.
- Recycling is always the best option.
- Take them to a battery recycling location or contact your community for disposal instructions.
- Do not put discarded batteries in piles.

### **ID Checking at Swimming Pools**

The Recreation & Parks Department has set standards for checking ID cards at The Villages swimming pools that fall under the its purview.

Individuals are not asked to get out of the swimming pools or stop play in order to check IDs, unless they do not meet the age requirements, or are reported by a Resident that they do not meet Resident/Guest Eligibility Standards.

- **Sports Pool classes / programs (residents only):** Each activity or program will be checked a minimum of once a week. Examples: water volleyball, exercise class, combo swim and lap swim.
- Neighborhood Recreation Centers (adult pools, ages 30+): Recreation Staff check these pools upon opening each morning and closing each evening, then at various times each day, or more often if staff is available. This is a minimum of three times daily, one time each, between the hours of 7 AM 12 PM, 12 5 PM, and 5 PM to close. Community Watch checks at least two neighborhood pools each afternoon. They will rotate the pools checked so that all of them are checked at least once every four days.
- Family Pools: Checked a minimum of Three (3) times daily once each between the hours of 7 AM 12 PM, 12 5 PM, and 5 PM to close. \*Ongoing ID checks.



## Fiber Optic Utility Easement Work

Please be advised that fiber optic utility easement work will be taking place in Village Community Development District No. 7 over the coming weeks and months.

The location of utility easements varies throughout the community, and work may be conducted in closer proximity to some residences compared to others.

Residents in affected areas will receive door hangers with additional information approximately 60 days before work begins in their specific location.
